Call to Order. (16-1903)

**President Carlos Benavides called the meeting to order at 1:04 p.m.**

**I. ADMINISTRATIVE MATTERS**

2. Discussion and Approval to allocate an amount not to exceed \$11,000 from the Commission on Disabilities Trust Fund for the cost to hold the 2016 Access Awards Luncheon at the Omni Hotel, located at 251 South Olive Street, Los Angeles, California 90012. (16-1907)

**1st Vice President Janet Neal reported the Omni Hotel is tentatively scheduled for Monday, October 17, 2016 to hold the Commission on Disabilities Annual Access Awards Luncheon. She stated the anticipated cost for the event should not exceed \$11,000 and requested the cost be taken from the Commission on Disabilities Trust Fund.**

**Following discussion, on motion of Commissioner John Troost, seconded by 1st Vice President Janet A. Neal, and unanimously carried, this item was approved.**

## **II. PRESENTATION**

3. Receive and file summary report by the Department of Health Services and review and address answer to questions posted by the Commission. (16-1991)

**Dr. Alexander Li, Deputy Director of Care Transition of the Department of Health Services, provided a global PowerPoint presentation on the merger of three Departments (Health Services, Mental Health and Public Health). His presentation included the mission for the Departments, a brief history since the merge, their 2015 timeline & processes, the role of the Affordable Care Act (ACA) and the assurance that the changes will link information to deliver wraparound services.**

It has been less than six months since the merge initiative was implemented, and is fulfilling the overall strategy to provide more care, improve patient and population experience, and have same or better quality of service using the same or lower budget. County of Los Angeles and its Board of Supervisors will administer and allocate billions of dollars of Measure B property tax revenue to LA County trauma centers, particularly Antelope Valley Hospital, of which a portion of the funds will also be used to educate the community in reducing violence. Presently, the County has 1 trauma center, 4 hospitals, and 19 outpatient clinics.

Following the presentation, Dr. Li was asked to report back at a future meeting to address the following questions posed by Commissioners:

- What and where are services for the deaf and hard of hearing?
- Is alternative medicines offered as a substitute to conventional medicines?
- Is the survey/information collected by the Mental Health Department shared/utilized by the recently consolidated departments?
- Is there an ombudsman to locate who is the neediest and are they protected?
- Is there any means of tracking improvements and demonstrate if it is beneficial or negatively impactful?
- What has the economic impact been since ACA or has there been an increase of funding that supports the three department? Is it because patients are using the ACA to access private health providers reducing the financial impact to the County?

President Carlos Benavides, 1st Vice President Janet Neal, Treasurer Lourdes Caracoza, Commissioners Rosa Maria Chaturvedi, Edward A. Colley, Steve Miller and Peggy Reyna provided their comments.

Genevieve Clavreul, member of the public, addressed the Commission.

After further discussion, and by Common Consent, there being no objection, this item was continued to the meeting of May 18, 2016 to report back to address questions posed by the Commission.

**III. REPORTS**

4. Receive and File the Accessibility Report by Joanna Lemus, Accessibility Programs Administrator and provide input to the Public Participation Plan by Bronwen Keiner, Senior Community Relations Officer for the Los Angeles County Metropolitan Transportation Authority (METRO). (16-0754)

**Joanna Lemus, Accessibility Programs Administrator for the Los Angeles County Metropolitan Transportation Authority (METRO), reported on the following activities provided by METRO:**

- **Sat. April 9, 2016 – Our staff joined Access in providing a resource table at a conference organized by the Los Angeles Autism Advocacy Organization held at the Junior Blind of America.**
- **Wed. May 4, 2016 – We will be going to the Braille Institute, Los Angeles center for their Low Vision Seminar and Resource Fair.**
- **Thurs. May 19, 2016 - Rancho Los Amigos Bus Practice Event**

**In response to 1st Vice President Janet Neal question, Ms. Lemus advised the Commission of a smart phone application by METRO that will assist in reporting safety concerns.**

**Commissioner Rosa Maria Chaturvedi asked that METRO look in to utilizing brail or alternative methods to assist the visually disabled identify bus lines and schedules at bus stops.**

**Commissioner John James thanked METRO for providing the Commission with METRO Flash Cards that can assist a visually impaired customer in identifying the bus line to be used. Commissioner John James distributed flash cards to students at Peirce College.**

**Genevieve Clavreul, member of the public, addressed the Commission.**

**Bronwen Keiner, Senior Community Relations Officer for METRO, distributed a flyer inviting feedback on METRO's Draft Public Participation Plan (Plan) and conducted the PowerPoint presentation on the same matter. It is required by the Federal Government Transit Administration that METRO gather important public input on possible changes to bus and rail services, new project plans for construction, fare and other programs. This occurs every three years as stated in Title VI Program Update. Commissioner Steve Miller suggest METRO contact the Regional Centers for additional input to the Plan.**

**Ms. Keiner invited Commissioners to participate by providing their input online at [www.metro.net/communityrelations](http://www.metro.net/communityrelations) and take the opportunity to review the presentation and draft Plan.**

**Commissioner John Troost reported that there is no gate at the Exposition and Crenshaw Expo Rail stop. 1st Vice President Janet Neal also stated that the Expo Rail at Crenshaw and Exposition traffic light need an adjustment; traffic is backed up to Adams and Crenshaw. Ms. Lemus will take the information back to her office for further investigation.**

- 5. Discuss and take appropriate action on the Access Services Incorporated report by Louis Burns, Access Services Customer Support Administrator and Geoffrey Okamoto, Manager of Eligibility Services, C.A.R.E. = Comprehensive Assessment Restorative Evaluation Program. (16-1415)**

**Geoffrey Okamoto, Manager of Eligibility Services, C.A.R.E. (Comprehensive Assessment Restorative Evaluation) Program of Access Services responded to the written questions posed by the Commission at the March 16, 2016 meeting.**

**In response to 1st Vice President Janet Neal questions, Mr. Okamoto reported that the evaluating period for eligibility for Access Services is dependent on the number of people waiting. Also, Access Services conducts a Transit evaluation, not a medical evaluation of their customer to determine eligibility in ridership on Access Services vehicles vs. a METRO bus.**

**Commissioner Peggy Reyna asked not to use wording hearing impaired. She would like everyone to use the wording deaf and/or hard of hearing for a person with a hearing disability.**

**At the suggestion of Commissioner Steve Miller, further questions posed by the Commission will be addressed at the next Transportation Committee meeting scheduled for May 11, 2016.**

**Prior to Commissioner Steve Miller's report, President Carlos Benavides thanked the Ad hoc-Committee for their hard work.**

**As provided by Commissioner Miller, a copy of the "2016 Red Book", a Summary Guide to Employment Supports for Persons with Disabilities and the Social Security Disability Insurance (SSDI) and Supplemental Security Income (SSI) Programs from the Social Security Administration was provided to all Commissioners. Commissioner Steve Miller referenced the Red Book and noted not many people know that they can make up to \$37,000 a year and keep their Medicare benefits.**

**In addition, he stated the Committee met prior to the meeting to discuss the developmental disabled community recruitment practice of the Los Angeles County Human Resource Department. Ms. Pam Missett, Human Resources Department, attended the meeting and spoke about recruitment for the disabled. At the next meeting, Ms. Missett and the Ad-hoc Committee will discuss the non-necessary requirements within the on the job description, ie., Driver's License and examine existing employment sites to see demonstration of employee work.**

**1st Vice President Janet Neal inquired about the special needs trust and the pension. The Committee will speak with Ms. Missett about her concern and report back.**
