SYBIL BRAND COMMISSION FOR INSTITUTIONAL INSPECTIONS

Authority

The Sybil Brand Commission for Institutional Inspections is authorized by Chapter 2.82 of the Los Angeles County Code and consists of ten members; two from each Supervisorial District, with the Sheriff and the Chief Probation Officer serving as ex-officio members. The Sybil Brand Commission meets each Wednesday at 10:00 a.m. in Room 372 of the Kenneth Hahn Hall of Administration, 500 West Temple Street in Los Angeles.

Duties

The members of the Sybil Brand Commission, or a committee of the Commission, is required to visit and inspect each jail, lockup, probation and correctional facility in the County at least once each year. They may conduct additional inspections more often as the Commission may deem necessary or as directed by a judge of the Superior Court. The Commission shall examine every department of each institution visited to ascertain its condition as to effective and economical administration, cleanliness, discipline and comfort of its inmates and juveniles at Probation camps. In addition, the Commission may call for and inspect the permit and register of such jail and lockup and may see and visit all persons kept in such jail and lockup, whether the institution is located within or without the corporate limits of any incorporated city. The Commission also inspects group home facilities to ascertain its condition.

2010 ACCOMPLISHMENTS

In calendar year 2010, the Sybil Brand Commission (SBC) accomplished the following objectives:

Reports

- The Commission conducted 328 site inspections.
- Traveled an estimated annual mileage of 23,946 miles to conduct site inspections.
- Presided over 49 meetings where reports on Institutional Inspections were discussed.
- Presided over 12 Business Meetings with representatives from the Los Angeles County Auditor-Controller, Children and Family Services, Internal Services, Mental Health, Probation, and Sheriff's Departments and the State of California Community Care Licensing Division, to identify, discuss and find solutions to problems that arise at various facilities. These meetings have established an unique means of communication and an invaluable collaboration among jurisdictions.
- Issued three letters of concerns, two letters were sent to the Courthouses regarding the safety of judicial officers' parking location and one to Camp Kenyon Schudder relating to Commission activities.
- Issued three letters of commendation to Sheriff Baca for implementation of innovative program and ideas and responsiveness at the following facilities:
 - ◆ Pico Rivera Sheriff Station's innovative effectiveness of placing florescent tape on cell/exterior door locks;
 - ◆ The Men's Central Jail Father Program, wherein inmates record a children's book and mail a CD recording and the book to their child and the Dog Program wherein inmates can be paired with a dog to handle and nurture; and
 - ◆ North County Correctional Facility Deputies for their attentiveness, responsiveness, and courteous escort of Commissioners that inspected their facility.

Donations

The Sybil Brand Commission maintains a savings account funded strictly through the voluntary monthly dues paid by each commissioner. These funds are used exclusively

to support programs and events associated with Sybil Brand Commission activities. Each transaction is voted on and any disbursement of Commission funds are placed on the agenda and approved by the majority vote of the Commission.

In 2010, the Sybil Brand Commission financially supported the following:

- On August 24, 2010, the Commission awarded four \$300 scholarships to four exceptionally deserving graduating high school foster youth. The \$1200 in scholarship funds will be used to support the awardees in their pursuit of higher education.
- On November 17, 2010, the Commission donated \$100 to the Tierra Del Sol Foundation to be used to assist individuals with disabilities to establish meaningful and productive lives.

The Sybil Brand Commission will continue to encourage the Los Angeles County Auditor-Controller, Children and Family Services, Internal Services, Mental Health, Probation and Sheriff Departments and the State of California Community Care Licensing Division, to work together and seek the assistance of the Commission to collaborate and help each Department achieve their independent goals.

Collaborative Efforts

As mandated by the Board of Supervisors, the Commission works closely with the Los Angeles County Sheriff's Department, Departments of Children and Family Services, Probation, Mental Health and the Auditor-Controller to monitor and ensure the safety and well-being of juveniles placed in County Group Homes and Juvenile Probation Camps. (Current information on the ever-changing problems faced by today's out-of-home care youth, both psychologically and socially, is essential to the understanding and support of these children.)

During the 2010 calendar year, the Sybil Brand Commission participated in the following:

- **On June 9, 2010, the Probation Department invited the Commission to be a stakeholder in their Focus Group on "Transitional Youth Aging Out of the System Without Permanent Connections"**

Update on Goals for 2010

In our continuing effort to monitor and ensure the effective and economical administration, cleanliness, discipline and comfort of inmates, and of the care of group home clients, the Commission identified the following goals for 2010:

- Create a new inspection reporting form that is more comprehensive and well-organized.

Status: Completed

- Evaluate changes to the Sybil Brand Commission Education Scholarship Application to be disseminated during group home and probation camp inspections.

Status: Completed

- Increase the Scholarship monetary award.

Status: Completed

- Partner with various schools, including the Department of Children and Family Services and Probation Department to increase awareness of efforts to identify Scholarship awardees.

Status: In progress. (The Commission will receive presentations in early 2011 from school district contacts and Department of Children and Family Services regarding this issue.)

- Provide recognition and commendations for all County agencies that maintain positive environments for youths in their Group Home and Probation facilities.

Status: In progress. (The Commission will continue to pursue this goal in 2011.)

- Continue to increase site visits and inspections of youth facilities and jails in the Northwest area of Los Angeles County, at least monthly.

Status: In Progress. Inspection of Group Homes in the Northwest area of Los Angeles County is 40% complete. (The Commission will continue to pursue this goal in 2011.)

- The Commission as a whole will schedule each month an inspection of the larger probation camps/jails facilities.

Status: In Progress. (The Commission will continue to pursue this goal in 2011.)

- Continue dialogue between the respective County Departments to enhance collaboration and efficiencies.

Status: In Progress (The Commission will continue to pursue this goal in 2011.)

Goals for 2011

- To inspect all of the youth facilities and jails in the Northwest area of Los Angeles County by the end of the year.
- Once a month, the Commission as a whole, is to inspect the larger probation camps/jails.
- Encourage County departments to enlist the Commission's participation in conducting specific inspections, employment interviews, review panels, focus groups, etc.
- Establish a partnership with the Auditor-Controller's Office Ombudsman Program that would include distributing their written materials and collaborating in special projects.
- Select scholarship recipients by May 31, 2011 in order to mention SBC Scholarship Award in the recipient's June 2011 Graduation Program.
- Remain in contact with former scholarship recipients.
- Continue to network with Group Homes to recruit potential scholarship recipients.
