The deputy working the module said the mail deputy delivers it daily. This did not comport with what many inmates told us. In addition, several inmates said their loved ones use <u>https://www.pelipost.com</u> to send pictures (it is a service they pay for and it is supposed to minimize contraband entering the institution). It was unclear why these pictures are still taking weeks for delivery or never arriving at all when they are sent from a 3 rd party. In addition, one gentleman said he mailed out a letter to his wife over 2 ½ weeks ago and she did not receive it yet. When he was at NCCF, it never took more than a week.

Solitary Confinement	U	There are 4 cells here used for the purposes of solitary
		confinement. There are 2 inmates here, we believe the are on court-ordered phone restriction (k-19). In the empty cells, the walls and floors had not been cleaned and are still covered in graffiti, artwork, or the remnants of inmates who had previously been housed here. A note on one inside wall displayed a message suggestiv of a person who was experiencing the agonizing effects of isolation and sensory deprivation: "Don't Speak, Don Feel, Don't Think."
		One of the inmates here, IM 6207219 showed us his paperwork - he was given 3 years state prison in Oct 2021 - he does not understand why he is still in county jail. Our conversation began with the lights off. When this individual turned on the lights (the backlight was covered by paper), we could see the walls of the cell were covered in artwork depicting satanic imagery including a character resembling Beelzebub. We asked him several times if he created the artwork and he said he did not. Consistent with other empty cells that had not been cleaned since their last use, it is at least plausible that he is telling the truth.
		This individual told us his personal possessions were taken by a trustee who swept them away. There are no trash bags for waste. He says he's been taken to a dayroom only three times during his entire time in this cell. He says mail does not come. He does not receive any hot meals. He said the milk he is served is frequently rotten. The shower, which is directly opposite from his cell, leaks into the hallway. He says other inmates have thrown urine at his cell when they take showers.

	IM 6314595 said he filed a complaint in February 2022 about a use of force and requested video. He stated the assault occurred while he was housed at T131.
	IM 5432246 stated his personal belongings had been taken from him when he was housed in 3700. This was relayed to the watch commander.
