<u>MCJ Kitchen</u>

MCJ has an industrial kitchen in the basement. We inspected the kitchen and found employees and a group of trustees eating hot meals they had prepared in the kitchen, heaping mounds of pork and rice in what smelled like a curry sauce. The trustees said they were excited to eat the meal. According to the kitchen staff, the kitchen is fully functioning, but has not been used to prepare hot meals for the people incarcerated in MCJ since the start of COVID. We asked about the frequent complaint we hear from inmates that they do not get a hot meal. They said the food is prepared across the street at Twin Towers and is hot when prepared, but then it takes a long time for the meals to be delivered to inmates, and by then the meals are no longer hot. According to Title 15, inmates are to receive at least one meal per day with hot food.

<u>4300-C – Discipline Row for people incarcerated with mental illness</u>

4300-C is a row of double-bunk cells designated as disciplinary housing for people with mental illness. Many of the people we talked to on this row were placed here because they had been labeled "walk-outs" meaning they refused their housing placements due to concerns for their personal safety.

Inmates complained they were not receiving religious diets or hygiene products like a fish kit. Their mattresses were worn out foam pads covered with a bedsheet. They said they had missed their medical appointments due to their placement here. They say they see nurses, but never a doctor. Two people specifically just asked for a book or two to pass the time. There are no TVs here.

The deputy in the module didn't know who was there/why/and for how long, so he had no way of knowing who still got access to the store/roof/recreation/books/etc. We later spoke with Sgt Soffa on 5000 who said the deputy on the discipline row should have folders for each person and so should know who should have access to store.

We were told that when people are placed on the discipline row as a walkout, there is no formal write up created to document the reasons, and yet these people are deprived of access to personal property and appear to be withheld from medical appointments.

Further attention to this matter is needed.

5200 – MOH Housing

5200 is a dorm for people incarcerated with mental illness. It is a compressed living space with triple-bunk beds spaced shoulder-width apart. Our inspection led to interviews with all people who are incarcerated with requests for medical or mental health care. A list of medical and mental health care requests was forwarded to Dr. Belavich, Dr. Henderson, and Joan Hubbell. See below for a de-identified list of the medical and mental health concerns presented to us.

Approximately 66% of medical-related requests made to us were for psychiatric medication, while numerous other complaints related to requests for treatment of chronic health conditions.

Facilities issues here included:

- Triple bunking / inmate safety issues (see below)
- Requests for hygiene kits (nail clippers, haircut, shaves)
 - \circ One gentleman showed me his nails that were at least 1/4 in long.
- 3-day waiting period to receive mattresses
- Extremely dirty clothing
- Complaints about meal shortages
- No hot meals being served
- Broken phones (static, family members could not hear)
- No access to complaint forms or medical request forms

Recreation time. Roof is offered at 6am on Thursdays (and it has not been offered at all since 12/8). Given the severe MH issues and the stressful conditions, as well as the cold early morning temperatures of the winter season, custody staff should consider shuffling recreation times for these modules so people have a true meaningful opportunity for outdoor time. For the mental health well-being of the inmates in these dorms, this seems very important.

Reading material. People here requested books or reading material. They said they had access to books when in MOH at TTCF. Why are reading materials restricted when the populations are the same?

Covid. People expressed concern re covid. 5200 was recently locked down for several days for covid exposure, but they were not provided any mitigation measures such as regular access to quality masks or any kind of ventilation to avoid getting sick.

Safety. Generally, the conditions in 5300 and 5200 were absolutely abysmal and appeared unsafe for many of the mentally ill people forced to live there. For example, I stood in the deputy booth and saw there was no way they could see into many parts of the dorms to provide any meaningful security or supervision. With the triple bunking, people appear to be packed in like sardines. There was no ventilation, it was hot, and the air was stagnant. These are ill people - I spoke to at least two people in 5300 who had just been at the state hospital because they had been found incompetent to stand trial in their criminal case. They had been restored and were now back in jail to face charges. These conditions are detrimental to their mental health and stability. These safety concerns are clearly related to the people who are on the "discipline" row not because they violated a jail policy but because they simply fear for their own safety.

5300 – MOH Housing ("High – discipline kickout")

5300 is a dorm for MOH housing. A document posted in the watch commander's office indicates 5300 is for higher acuity MOH inmates who are "discipline kickouts." During our inspection, deputies stood extremely close to commissioners and while they did not interject or interrupt conversations, their proximity potentially had an effect on candor. The bathroom in 5300 was in a state of significant disrepair. Drinking fountains were broken, toilets were broken, and the urinal was broken. Phones were said to be broken.
