171 F 7 Floor of cell is covered with rotten food stuck to the floor and insects are crawling up the wall. He has no clothes but said he had been approved for clothes.

171 D 13 Inmate told me there is a cockroach infestation under his bedframe. I watched him reach under his bedframe and grab a fist full of cockroaches to prove they were there. No soap. Says he has not showered in two months. Said his lunch had been not given to him, left on railing. Said he was improperly labeled as "hostile" because he said he got angry after a deputy intentionally dropped his dinner on the floor.

171 F 9 Trash is piling under the bed. Foam mattress is torn to several pieces, he said he ripped his mattress when he was feeling angry to try to block window. "They don't listen to me," he said. He said his room smelled like feces and wanted it cleaned.

Many cells have "graffiti" or writing on walls.
