Incorporate, as needed, up to \$14,812,050 in County Affordable Housing Funds, \$4,000,000 in HOME funds and \$900,000 in HPI funds, as described herein, into the Commission's approved Fiscal Year 2016-17 budget, for the purposes described;

Increase the loan amounts by a maximum of 10% each for unforeseen project costs, and incorporate an aggregate amount up to \$1,881,205 into the Commission's fiscal year budgets, as needed; and

Reallocate funds set aside for affordable housing developments at the time of project funding, as needed, and within each project's approved funding limit, in line with project needs, and within the requirements for each funding source. (17-0787)

Upon determination and as necessary and appropriate under the terms of the JOCs, amend the JOCs to terminate any of the two JOCs for convenience or to terminate the contractor's right to proceed with the performance of the JOCs; and

Determine, on a case-by-case basis, that a JOC work order shall be exempt from the application of the County's Local Targeted Worker Hire Policy, provided that the Executive Director first determines that the JOC work order will be funded in whole or in part by Federal funds, which prohibit geographic preferences. Revised recommendation as submitted by Supervisors Solis and Hahn: Approve and instruct the Director of Personnel to implement a 24-month Temporary Services Registry pilot project for the Departments of Public Social Services, Children and Family Services, Mental Health and Child Support Services, no later than April 1, 2017, to include the development of a Countywide Temporary Services Registry for clerical services, identification of County Departments to participate in the pilot, and development of policies, processes and/or procedures for use of the Registry; in coordination with Workforce Development, Aging and Community Services (WDACS), all applicants to the program should first be registered in the regional workforce development system, in order to maximize access to job readiness and training programs, as well as provide for longitudinal evaluation of sustained employment; and the following participation goals, which are not mutually exclusive: (Continued from the meeting of 2-7-17)

At least 30% of the participants in the program must be local residents that are students or recent graduates of local community colleges or adult schools programs and live in the Tier 2 Zip Codes defined in the County's Local and Target Worker Hire policy;

At least 51% of the participants in the program must be Target Workers facing barriers to employment served and tracked by Workforce Innovation and Opportunity Act (WIOA) and regional Workforce Development Board programs;

At least 20% of the participants in the program must be Greater Avenues for Independence (GAIN) and General Relief Opportunities for Work (GROW) participants; and

At least 25% of the participants in the program must be current or former foster youth;

Instruct the Director of Personnel, working with the Chief Executive Officer and the Director of WDACS, to report back to the Board on a quarterly basis to evaluate the project on the status of the pilot and achievement of the goals and provide a comprehensive report upon the completion of the initial 24-month pilot, including quarterly reports commencing on June 30, 2017, and delivered to the Board and the Economic Development Policy Committee throughout the duration of the pilot; a statement of any additional metrics that will be collected and used to evaluate the performance of the program in the first quarterly report, as well as a statement regarding any additional labor organization, Social Enterprise, private sector, philanthropic, or workforce development partners that will be helpful in achieving success for the program;

at the conclusion of the two-year pilot, an evaluation by the Director of Personnel, the Chief Executive Officer and the Director of WDACS of the rate of retention of the program participants, as well as their level of career advancement either as an employee of the County or other employer as tracked through the resources of the Regional Workforce Development System, with the projected and actual cost of the program and effectiveness of the pilot as to the impact that the program may have to maximize the use of the full set of County-offered job readiness and other wrap-around social service or housing assistance and reduce participants' usage of County safety net services over time; and

Direct the Chief Executive Officer to work with the Director of Personnel and the pilot Departments to establish a 24-month pilot Temporary Services Registry in the Department of Human Resources. (17-0713)

Report Video 3. Recommendation as submitted by Supervisors Solis and Kuehl: Direct the Chief Executive Officer, County Counsel and the Directors of Public Works, Consumer and Business Affairs (DCBA), and Workforce Development, Aging and Community Services to report back to the Board by March 9, 2017, with a proposal for the Board to establish a Countywide Construction Careers and Economic Development Initiative, to include:

Explore amending and augmenting the Local and Targeted Worker Hire policy, such that:

County construction projects of greater than \$2,500,000 will require a minimum of 20% Apprentice hours, or any higher percentage authorized by State law, for each construction trade utilized, where at least half of these Apprentice hours are from Local Resident or Targeted Worker categories;

Hours worked by an Apprentice who is also a Targeted Worker or a Local Resident may be applied to the 30% Local Resident or the 10% Targeted Worker hire goal in the Local and Targeted Worker Hire policy;

The full list of Targeted Workers would be expanded to include all categories of individuals, as permitted under applicable law, involving Targeted Workers facing barriers to employment served and tracked by the Workforce Innovation and Opportunity Act of 2014 (WIOA);

Local and Targeted Workers would be registered in the regional workforce development system;

When possible, registered Local and Targeted Workers' records would be linked to the County's Enterprise Linkage Project to enable improved coordination between County human service delivery and workforce development efforts; and

The policy would require that any employer under any contract associated with projects under the Local and Targeted Worker Policy pay any workers on any affected project at the level of the County's Living Wage, unless pre-empted by higher Prevailing Wage or Davis Bacon Wage standards or an existing Community Workforce Agreement, including but not limited to security and clerical or administrative workers:

Include policies and procedures for program implementation and potentially, a list of pre-qualified Jobs Developers (compliance consultants) to assist contractors, private developers, or County agencies identifying and hiring qualified Local and Targeted Workers, where any such prequalified Jobs Developers are required to work with America's Jobs Centers of California (AJCCs) and to register Local and Targeted Workers in the regional workforce development system;

Explore enhancing DCBA Small Business, Disabled Veteran-Owned Business and Social Enterprise Utilization Programs, and affected Departments should:

Develop and implement procedures for certifying construction contractors and subcontractors as Social Enterprises consistent with the DCBA certification program, including those Employment and Training Social Enterprises certified to employ and train a labor force that is at least 51% Targeted Worker;

Propose how and when it is appropriate to require all Departments, Commissions and Agencies delivering County capital and construction projects and economic and housing development projects on County property to include a Small Business, Disabled Veteran-Owned Business and Social Enterprise Utilization Plan (Utilization Plan) for each such project describing the plan to achieve 25% utilization of certified Local Small Business Enterprises (LSBEs) and 3% utilization of Disabled Veteran Business Enterprises (DVBEs) on each project, with corresponding Utilization Plans and performance reports to be submitted to the Director of Consumer and Business Affairs for inclusion in quarterly Business Utilization reports to the Board;

On a quarterly basis, report back to the Board with recommendations on achieving Local and Targeted Worker Policy goals, including Apprentice utilization goals, information on Targeted Workers by category, and any additional Construction Careers and Economic Development Initiative goals to the Economic Development Policy Committee, with the first report including data reported through June 30, 2017; and

Make recommendations on the creation of an annual report back to the Board, with the first report filed by October 15, 2018, evaluating the performance of the Construction Careers and Economic Development Initiative in achieving the goals of increased and sustained economic opportunity over time, including:

Feedback from key industry stakeholders, including employers, developers, Los Angeles/Orange Counties Building and Construction Trades Council, unions, community-based organizations, Social Enterprises, America's Jobs Centers of California, Community Colleges and Adult Schools, philanthropy, and mission-oriented investors;

The cumulative performance to date of County Local and Targeted Worker Hire projects;

The rate of sustained employment of registered Local and Targeted Workers on County projects, in the construction industry, or through transition to employment in another sector based on data tracked through the information resources of the regional workforce development system;

The impact that this Initiative has in increasing the use of County job readiness and other services and in reducing Targeted Worker's usage of County safety net services over time; and

The impact that this Initiative has in increasing the number of construction industry LSBEs, DVBES, and SEs that are certified by the County and that receive contracts, as well as the distribution of contracts among the pool of certified businesses. (17-0848)
