- Acting as the Board of Supervisors for the Los Angeles County Flood Control District, upon consideration of the candidate, appointed Mark Pestrella as Chief Engineer, Flood Control District effective March 1, 2017;
- 4. Instructed the Director of Personnel to execute an at-will employment contract, which is approved as to form by the County Counsel; and
- 5. Instructed the Executive Officer of the Board to furnish evidence to the State Controller that the County has complied with Streets and Highways Code Section 2006 upon appointment of the Road Commissioner.
