Pursuant to Government Code Section 54954(b)(5), the Board of Supervisors met outside its immediate jurisdiction on May 7, 2002 with the Director of

the Office of Management and Budget and on May 8 and 9, 2002 with Federal elected and appointed officials to discuss legislative and regulatory issues affecting Los Angeles County. The meetings were held in Washington, D.C. because a local meeting was not practical.

The Board meeting convened on May 7, 2002 at 2:10 p.m. at 252 Eisenhower Executive Office Building, Washington, D.C. Present were Supervisors Don Knabe, Michael D. Antonovich, and Zev Yarolsavsky, Chairman of the Board. Supervisors Gloria Molina and Yvonne Brathwaite Burke were absent. The

meeting adjourned at 3:00 p.m.

The meeting reconvened at 8:15 a.m. on May 8, 2002 at 1000 H. Street. N. W.

Present were Supervisors Molina, Burke and Knabe. Supervisor Yaroslavsky joined the meeting at 8:18 a.m. Supervisor Antonovich joined the meeting at 8:33 a.m. The meeting adjourned at 9:02 a.m. to the next location.

The meeting reconvened at 10:00 a.m. in Room 437 of the Cannon House Office Building. Present were Supervisors Burke, Knabe and Yaroslavsky, Chairman of the Board. Supervisors Molina and Antonovich were absent. The meeting adjourned at 10.20 a.m. to its next location.

At each location the Board discussed with elected and appointed officials and their staff the following issues over which the Federal officials have

jurisdiction and that affect the County of Los Angeles: Health Care Financing; Temporary Assistance for Needy Families (TANF) Authorization; Homeland Security funding; Criminal Aliens funding; and Food Stamp Quality Control.

No motions were made. No resolutions were introduced. No ordinances were proposed, introduced or adopted. No actions were taken.
