## 1-P. Allocation of Funds for Various Projects Pursuant to the Safe Neighborhood Parks Proposition of 1996

Recommendation: Certify that the Board, as a responsible agency under the California Environmental Quality Act (CEQA), has independently considered and reached its own conclusions regarding the environmental effects of the proposed La Laguna de San Gabriel Playground Rehabilitation Project, the Mitigated Negative Declaration (MND) and Mitigation Monitoring and Reporting Program (MMRP) adopted by the City of San Gabriel, as lead agency, and determine that the documents adequately address the environmental impacts of the proposed project; find that the Board has complied with the CEQA requirements for a responsible agency and adopt by reference the City's MND and MMRP; allocate an amount not to exceed \$593,000 in Excess Funds available to the Fifth Supervisorial District pursuant to the Safe Neighborhood Parks Proposition of 1996 as detailed below; and authorize the Director of the Regional Park and Open Space District to award grants when applicable conditions have been met, and administer the grants as of the date of award and pursuant to guidelines in the Procedural Guide for Specified, Per Parcel and Excess Funds Projects, otherwise, funds shall remain in the Excess Funds account: (Continued from the meeting of 5-15-18)

\$400,000 to the City of Covina for the Covina Woman's Club Rehabilitation Project (5);

\$40,000 to Friends of La Laguna for the La Laguna de San Gabriel Playground Rehabilitation Project (5); and

#### 3. Implementing Recommendations to Enhance Veteran Peer Access Network

Recommendation as submitted by Supervisors Ridley-Thomas and Barger: Approve the recommendations in the May 4, 2018 report and instruct the Director of Mental Health, as the Health Agency lead, to implement the recommendations in the report; and authorize the Director of Mental Health to take the following related actions: (Relates to Agenda No. 1-D)

Increase the number of ad hoc steering committee members as deemed necessary;

Participate in event opportunities with the Department of Mental Health's (DMH) regional partners, such as the Veterans Affairs Healthcare Systems, to promote mental health awareness, access to holistic services and suicide prevention for veterans in Los Angeles County;

Identify the potential sources of funding within DMH that would allow the allocation of \$20,000,000 towards housing resources, \$15,000,000 that would be allocated to create new affordable and permanent supportive housing units for veterans experiencing homelessness and mental health issues and \$5,000,000 for housing resources to expedite access to existing landlords and housing stock through the veteran peer network;

Work with the ad hoc steering committee to determine how the \$5,000,000 in identified housing funds could leverage and supplement housing resources being deployed through other local, State and Federal funds and be administered to allow veteran peers streamlined access to tangible resources to effectively assist homeless veterans with mental health issues to locate and secure stable and appropriate housing within the existing housing stock;

Identify the potential sources of funding within DMH that would allow the allocation of up to \$15,000,000 during Fiscal Year (FY) 2018-19 to the Community Development Commission to be administered Countywide through the Commission's bi-annual Notice of Funding Availability (NOFA) pursuant to the terms of the existing Memorandum of Understanding (MOU) executed between the parties on November 30, 2017 or any other agreement;

Amend the existing MOU and execute such amendment or execute any other agreement for Countywide activities related to the funding and operation of permanent supportive and affordable housing, including, without limitation, administration and allocation of up to \$15,000,000 of

available funding identified by DMH, to be targeted for homeless veterans with mental illness, pursuant to the above directive to be administered through the Commission's NOFA process; and

#### 6. Establish a Prison Rape Elimination Act Compliance Implementation Team

Recommendation as submitted by Supervisors Kuehl and Hahn: Instruct County Counsel to coordinate and lead a Prison Rape Elimination Act (PREA) Compliance Implementation Team comprised of staff from the Chief Executive Office, Sheriff and Probation Departments, to identify the steps required to achieve compliance with PREA in all County facilities and provide guidance to the Sheriff and Chief Probation Officer on implementing necessary reforms, with the team to work collaboratively with County Departments and stakeholders, including the Office of Inspector General, Correctional Health Services, Juvenile Correctional Health Services, Juvenile Mental Health Services, the Sheriff's Civilian Oversight Commission and the Probation Oversight Commission (when formed) to leverage County expertise and resources; and instruct the Team to take the following related actions:

Create a detailed plan, with a timeline, to achieve compliance with PREA within the Sheriff and Probation Departments, including the formation of internal Sheriff and Probation PREA Compliance Units;

Assess the viability of a centralized County PREA Compliance Unit, housed outside of both the Sheriff and Probation Departments, to serve as a resource to both Departments and County Counsel and to conduct administrative PREA investigations for Sheriff and Probation;

Report back to the Board on whether it is feasible and advantageous for the Office of the Inspector General to conduct the audits of Sheriff and Probation custody facilities required by PREA;

Re-evaluate the proposed composition of the teams necessary for each Department to achieve and maintain compliance with PREA; and

Report back to the Board within 120 days with an update on progress made to accomplish these tasks; and

Also, instruct County Counsel and the Chief Executive Officer to evaluate the Mental Health Services Act as a possible funding source to support PREA compliance activities; and

Direct the Chief Executive Officer to give PREA the highest funding priority during the next budget phase for the PREA consultant and other positions specifically identified in this motion. (18-2658)
