1-D. Norwalk Library Project

2. Grand Avenue/Golden Springs Widening Project and Diamond Bar Golf Course

Recommendation as submitted by Supervisors Hahn and Solis: Acting as a responsible agency for the Grand Avenue/Golden Springs Widening Project (Project), consider the Addendum to the Final Environmental Impact Report and Finding of No Significant Impact (FEIR/FONSI) prepared and approved by the Industry Urban-Development Agency (Successor Agency) as lead agency, the National Environmental Policy Act/California Environmental Quality Act (NEPA/CEQA) Re-Validation Memorandum, and the FEIR/FONSI prepared and approved by Caltrans as lead agency; certify that the Board has independently reviewed and considered the information contained in the Addendum to the FEIR/FONSI, NEPA/CEQA Re-Validation Memorandum and the FEIR/FONSI, and reached its conclusions regarding the environmental effects of the County's approvals related to the Project as shown in the Addendum to the FEIR/FONSI, NEPA/CEQA Re-Validation Memorandum, and the FEIR/FONSI; adopt the Environmental Commitments Record, as applicable; and determine that the significant adverse effects of the Project have been reduced to an acceptable level as outlined in the Discussion of Significance of Impacts, which findings are adopted and incorporated herein by reference as applicable; and take the following actions: (Carried over from the cancelled meeting of 3-17-20)

Find that the portion of the Diamond Bar Golf Course located at 22751 Golden Springs Drive in Diamond Bar, proposed to be for temporary use by the Successor Agency for construction and staging purposes at the County's appraised value, is not currently needed for County purposes, will not substantially conflict or interfere with the County's use of these properties and is in the public interest;

Find that the portion of the Diamond Bar Golf Course, proposed to be sold to and acquired by the City of Industry, including the roadway supporting slope, for the widening of Grand Avenue and Golden Springs Drive at the County's appraised value, is not currently needed for County purposes, will not substantially conflict or interfere with the County's use of the Golf Course, and is in the public interest;

Find that the County-owned real property is exempt surplus land as defined in Government Code Section 54221(f)(1)(D), in that it is surplus land that a local agency is transferring to another local, State or Federal agency for the agency's use;

Authorize the Director of Parks and Recreation to take all further actions necessary and appropriate to complete the transaction, including opening and management of escrow and execution of any escrow documentation to consummate the purchase, including to negotiate and execute the Purchase and Sale Agreement, Quitclaim Deeds, Temporary Construction License, right of entry license (ROE), Access Easement, Footing Easement and any other ancillary documentation, and take all further actions necessary and appropriate to implement the terms and conditions of the agreements and various easements and license; and

7. Delegated Authority to the Chief Executive Officer During Declared States of Emergency

Revised recommendation as submitted by Supervisor Barger: Authorize the Chief Executive Officer to approve fiscal, budgetary, contractual, procurement and operational actions so long as each departmental request has been reviewed pursuant to established protocol; approve fiscal, budgetary, contractual, procurement and operational actions placed on the agenda of certain Special Districts, when the Board acts in the capacity of their Governing Board, including, but not limited to the Los Angeles County Development Authority, the Regional Park and Open Space District of the County of Los Angeles, the Los Angeles County Flood Control District and the Los Angeles County Consolidated Fire Protection District; approve requests submitted to the County Office of Emergency Management to procure emergency services and supplies needed to support the County's Novel Coronavirus (COVID-19) transmission mitigation efforts; and take the following additional actions:

With respect to the authorizations and delegations of authority, as they apply to the procurement of construction, alteration and repair work for new or existing facilities, as well as the procurement of necessary equipment, services and supplies for such purposes, find that public interest and necessity demand immediate emergency action to address the threat of COVID-19 including, but not limited to, projects to provide shelter and housing for homeless and other persons, and related projects, and find that these emergency actions cannot be delayed by compliance with otherwise applicable competitive bidding rules;

Adopt a resolution authorizing the Chief Executive Officer to authorize, and the Director of Public Works to carry out, the performance of force account work, negotiate and amend existing emergency and as-needed contracts on behalf of the County, procure new contracts for the construction, repair or construction of necessary facilities, and procure necessary equipment, services and supplies for such purposes, without giving notice for bids to let contracts:

Find that the construction, alteration and repair projects needed to respond to this emergency are exempt from the California Environmental Quality Act;

Direct the Chief Executive Officer to brief all items in cluster meetings, as well as provide the Board with a list of items approved using this delegated authority at the next meeting of the Board following the action taken;

Instruct all other County Directors to work with the Chief Executive Officer to expedite necessary actions related to the Chief Executive Officer's delegated authority; and

The authorizations and delegated authorities provided for the above shall remain in effect until such actions are terminated by the Board. (20-2037)

8. Temporary Emergency Shelter Facilities in the Antelope Valley

Recommendation as submitted by Supervisor Barger: Find that pursuant to Government Code Sections 8698 et seq., a significant number of persons within the Antelope Valley are without the ability to obtain shelter, resulting in a threat to their health and safety; instruct the Director of the Homeless Initiative, Chief Executive Office, to work with the Interim Executive Director of the Los Angeles Homeless Services Authority (LAHSA), Fire Chief, Director of Public Works, County Counsel, and other pertinent County Departments to ensure readiness for continued operation of a 24-hour emergency shelter at the High Desert Multi-Ambulatory Care Center (MACC), during the shelter crisis period of April 1, 2020 through October 31, 2020; find the proposed actions are either not subject to or are exempt from the California Environmental Quality Act; and take the following actions:

Authorize the Chief Executive Officer in consultation with County Counsel and the Directors of Public Works and Public Health, The Fire Chief, and other pertinent County Departments, to identify, with respect to the High Desert MACC, which provisions of any applicable State or local regulatory statute, regulation or ordinance prescribing standards of housing, health or safety would in any way prevent, hinder or delay the mitigation of the effects of the shelter crisis to the extent there was strict compliance with same, with delegation of authority to in no way, limit the broad suspension of the provisions of any state or local regulatory statute, regulation or ordinance prescribing standards of housing, health or safety that occurs by operation of law; enact and implement any applicable health and safety standards or regulations as applied to the use of High Desert MACC as a temporary emergency shelter and to be operative during the shelter crisis consistent with ensuring public health and safety;

Authorize the Director of Public Works to complete maintenance and repairs to the High Desert MACC using a Board-approved Job Order Contract to allow for continued operation of the temporary emergency shelter:

Direct the Chief Executive Officer and the Interim Executive Director of the Los Angeles Homeless Services Authority to use Measure H funding to fund the operation of 100 beds at the High Desert MACC shelter from April 1, 2020 through October 31, 2020; and

Authorize the Chief Executive Officer to take any other actions consistent with and/or necessary for the implementation of the foregoing actions.

Also, find that the services to be provided by Volunteers of America, a nonprofit corporation, are necessary to meet the social needs of the County and serve public purposes which benefit the County; find that the former High Desert MACC is not currently needed for County purposes; find that the proposed Non-Exclusive License Agreement (License) is exempt from CEQA; and authorize the Chief Executive Officer to take the following actions:

Negotiate the License with Volunteers of America, with a term extending through October 31, 2020;

Execute the License, which except as stated herein, shall reflect substantially the same terms as the existing license;

Amend the License to extend the term, if and as necessary, for the duration of the Shelter Crisis; and

Negotiate and execute other ancillary documentation necessary to effectuate the License, and to take any other actions necessary and appropriate to implement and effectuate the License. (20-2007)

13. Ensuring Adequate Efforts to Prevent Novel Coronavirus (COVID-19) Among Justice-Involved Populations

Revised recommendation as submitted by Supervisors Solis and Ridley-Thomas: Request that the Sheriff, the Director of Health Services and the Interim Chief Probation Officer, with the assistance of the Inspector General, the Directors of Public Health, Mental Health and Office of Diversion and Re-Entry, the Public Defender, the Alternate Public Defender, the District Attorney, County Counsel, Directors of the Homeless Initiative, Public Social Services and Internal Services, the courts and any other relevant stakeholders, to report back to the Board consistently and frequently on the following:

Collaborating with the existing and new housing resources within the County and the community, including the Office of Diversion and Re-Entry, Departments of Health Services and Mental Health, Chief Executive Office and the Office of Emergency Management to link inmates who are being released from County jail to medical housing or other available housing, when deemed appropriate;

Plans to ensure adequate space for quarantining or isolating individuals currently in custody who may become infected or who are vulnerable and cannot be released and, thus, require extra protections to ensure their well-being;

Updates on efforts to provide increased and sufficient handwashing, hygiene, and cleaning supplies and policies to support best practices in personal and institutional hygiene (such as handwashing and cleaning), including providing sufficient information and education on proper hygiene measures and effective strategies to reduce infection to all individuals within our care within detention facilities and staff and personnel who work in those facilities, including efforts to control rumors and reduce unnecessary fear among prisoners and staff as much as possible;

Updates on efforts to ensure effective screening of all new admissions, along with plans to ensure staff entering the facilities are healthy (e.g. taking temperatures), plans to ensure appropriate staffing levels and treatment should individuals become infected, and adequate data collection and tracking based on public health approaches; and

A plan to support increased virtual contact and visitation with people in custody at no cost, as well as communication with families regarding when visitation will resume, once determined, in order to minimize anxiety and increase communication and familial connections. (20-1993)

Provisions for Grocery Retail and Drug Retail employers to provide adequate security to implement any necessary crowd control and social distancing measures;

Provisions for Grocery Retail and Drug Retail employers to develop protocols to establish operating hours to better serve vulnerable populations and ensure adequate time to re-stock stores;

Provisions for Grocery Retail, Drug Retail and Food Delivery Platform employers to develop protocols to implement the terms of this interim ordinance and/or order or regulation as appropriate;

Provisions for Grocery Retail, Drug Retail and Food Delivery Platform employers to provide, at their expense, access to coronavirus testing, as available if an employee or worker does not have a medical provider to perform the testing and based on guidance issued by the Health Officer;

Potential mechanisms for Grocery Retail, Drug Retail and Food Delivery Platform employers to support employees so that they may address

childcare and family needs arising from the Local Health Emergency, without retaliation and to maintain employee hours in good faith;

Potential mechanisms for Grocery Retail, Drug Retail and Food Delivery Platform employers to support employees who must self-isolate and/or self-quarantine in accordance with any Health Officer Order;

Provisions for Grocery Retail, Drug Retail and Food Delivery Platform employers and employees to follow all Orders and guidance issued by the Health Officer related to the work environment, employees and COVID-19; and

Instruct County Counsel to prepare and present an urgency, interim ordinance and/or order or regulation, as appropriate, to regulate Food Delivery Platform Companies that considers the following:

Requiring all Food Delivery Platform Companies to register with the County if they intend to do business within the unincorporated areas of Los Angeles County, as part of the registration, such a company will indicate the number of drivers it believes it has that work in the unincorporated areas of Los Angeles County, the Companies will agree to a code of conduct developed by the unincorporated areas of Los Angeles County, including a commitment to comply with the terms of the urgency, interim ordinance and/or order or regulation;

Prohibiting Food Delivery Platform Companies from penalizing drivers or shoppers (e.g., "deactivating") during this Local Health Emergency;

Direct the Chief Executive Officer, in collaboration with the Directors of Personnel and Consumer and Business Affairs, and Acting Director of Workforce Development Aging and Community Services, and other relevant Departments to reach out and convene discussions with impacted Labor Unions and other impacted entities to partner on training and worker resources needs at County of Los Angeles related to COVID-19 response efforts, and report back at the next scheduled Board meeting; and

Continue local emergencies as a result of the following: (a) Discovery of an infestation of fruit flies, as proclaimed on May 10, 1990; (b) Conditions of disaster arose as a result of the discovery of a leak at the natural gas storage wells at the Aliso Canyon storage field affecting the City and County of Los Angeles, as proclaimed on December 10, 2015 and ratified by the Board on December 15, 2015; (c) Conditions of disaster and extreme peril to the safety of persons and property arose as a result of the Creek Fire that started December 5, 2017 and affected the Kagel Canyon and the City of Los Angeles, as proclaimed and ratified by the Board on December 5, 2017; (d) Conditions of disaster and extreme peril to the safety of persons and property arose as a result of the Woolsey Fire that began in Ventura County that started on or about November 8, 2018 and guickly spread into the County of Los Angeles, as proclaimed and ratified by the Board on November 13, 2018; (e) An imminent threat to public health in Los Angeles County in the form of contaminated fire debris from household hazardous waste created as a result from the Woolsey Fire that started on November 8, 2018, as proclaimed by the Public Health Officer on November 12, 2018 and ratified by the Board on November 13, 2018; (f) Conditions of extreme peril to the safety of persons and property arose as a result of a winter storm beginning January 10 through 18, 2019 affecting the unincorporated communities around Little Tujunga and surrounding areas of Los Angeles County, as proclaimed on January 29, 2019 and ratified by the Board on February 5, 2019; (g) Conditions of disaster or extreme peril to the safety of persons and property arose as a result of a winter storm beginning January 31, 2019 through February 5, 2019 affecting the unincorporated communities throughout the County as well as the Cities of Malibu, Burbank and Los Angeles, as proclaimed on February 14, 2019 and ratified by the Board on February 19, 2019; (h) Conditions of disaster or of extreme peril to the safety of persons and property arose as a result of the introduction of the novel coronavirus (COVID-19), a novel communicable disease, which was first detected in Wuhan City, Hubei Province, China in December 2019, as proclaimed and ratified by the Board on March 4, 2020; and

(i) An imminent threat and proximate threat to public health from the introduction of COVID-19 in Los Angeles County, as proclaimed by the Public Health Officer on March 4, 2020 and ratified by the Board on March 4, 2020. (A-1)
