4-D. Orchard Arms Senior Public Housing Development Flooring Replacement Program Construction Contract

2. Maintaining a Reduced Jail Population Post-COVID-19

Revised recommendation as submitted by Supervisors Hahn and Ridley-Thomas: Request the Sheriff and the Director of the Office of Diversion and Re-Entry, in collaboration with the Public Defender, the Alternate Public Defender, the Interim Chief Probation Officer, the District Attorney, the Chief Executive Officer, County Counsel, the Alternatives to Incarceration (ATI) Initiative, the Reentry Health Advisory Collaborative, and all other relevant Departments, community stakeholders, other justice partners, and in consultation with the Executive Officer/Clerk of the Superior Court to, in building on the recently submitted ATI Workgroup report and recommendations, report back to the Board in 60 days on their plan post-COVID-19 to maintain a reduced jail population beneath the Board of State and Community Corrections rated capacity while continuing to protect public safety and ensuring appropriate services for individuals released early or diverted from incarceration including, but not limited to, a protocol for warm hand-offs to post-release placements; additions and expansions needed to the County's system of care that can provide alternative placements to incarceration-community-based whenever possible, including for individuals experiencing homelessness, individuals with serious mental illness, and individuals suffering from substance abuse; legislative changes that the County could pursue and advocate for to help maintain a reduced jail population; and plans to reduce the number of inmates admitted on a daily basis; and direct the Chief Executive

Officer, in consultation with the Sheriff and Auditor-Controller, to report back to the Board in 60 days with an analysis of any cost savings that have or will be generated in the future through a reduced jail population. (20-3034)

3. Expanding the Existing Safe Youth Zone Program

Recommendation as submitted by Supervisors Hahn and Ridley-Thomas: Instruct the Los Angeles County Commercially Sexually Exploited Children-Integrated Leadership Team (ILT) to engage the Departments of Public Social Services, Mental Health, Public Health, Health Services, Children and Family Services, Probation, Fire and the Sheriff, and provide the following information to the Board at the next scheduled ILT report back date of October 6, 2020:

4. Responsible Policing and Use of Force Reform

Recommendation as submitted by Supervisors Hahn and Ridley-Thomas: Urge the Sheriff's Department, and the forty-six police departments within Los Angeles County, to review their use of force policies and adapt them to be consistent with the eight reforms outlined by Campaign Zero, and detailed below, and follow up by sending a five-signature letter to each entity; direct the Civilian Oversight

Commission of the Los Angeles County Sheriff's Department (LASD) to report back to the Board in less than 30 days with their recommendations on strengthening LASD's use of force policies and practices:

- 1. Require officers to intervene to stop another officer from using excessive force;
- 2. Restrict or prohibit the use of chokeholds, strangleholds, and carotid restraints;
- 3. Require officers to de-escalate situations, when possible, before using force;
- 4. Use a Force Continuum or Matrix that defines and limits the types of force that can be used to respond to specific types of resistance;
- 5. Require officers to give a verbal warning before using deadly force;
- 6. Prohibit officers from shooting at people in moving vehicles unless the person poses a deadly threat by means other than the vehicle;
- 7. Require officers to exhaust all other reasonable alternatives before resorting to using deadly force; and
- 8. Require comprehensive reporting that includes both uses of force and threats of force. (20-3009)

5. Court Technology During COVID-19

7. Capping Fees for Third-Party Delivery Service Platforms in Unincorporated Communities

Recommendation as submitted by Supervisors Solis and Kuehl: Direct the Chief Executive Officer, in consultation and collaboration with County Counsel, the Director of Consumer and Business Affairs, the Acting Director of Workforce Development, Aging and Community Services and other relevant Departments, and after considering feedback from labor and business representatives, and members of the County's Economic Resiliency Task Force representing Restaurants, Small Business and Labor, to report back to the Board prior to the July 7, 2020 Board meeting with draft ordinance language to cap fees for third-party delivery platforms charged to food establishments located within the unincorporated areas of the County, the draft ordinance, at a minimum, should investigate the following:

A cap on the commission fees that third-party food delivery services charge on the purchase price of the order;

A cap on any additional fees charged by a third-party food delivery platform beyond those fees charged for delivery of each order;

A fee that can be imposed on third-party food delivery platforms for all deliveries to create a Countywide fund that could be used for assisting certain food establishments and their workers as well as for economic development activities; and

Prohibiting third-party food delivery platforms from reducing compensation paid to delivery service drivers or garnishing any of the gratuities paid to delivery service drivers as a result of any caps or fees implemented.

Also, consideration of Supervisor Barger's recommendation to amend Supervisors Solis and Kuehl's motion to also instruct the relevant County Departments to report back to the Board prior to the July 7, 2020 Board meeting with draft ordinance language to cap fees for third-party delivery platforms charged to food establishments located within the unincorporated areas of the County, where the draft ordinance, at a minimum, should investigate the following:

Disclose to the customer a clearly identified and itemized cost breakdown of each transaction, including charges and fees assessed to the customer, as well as the Retail Food Establishment;

Should a fee be considered in County Ordinance in conjunction or in lieu of a cap, it shall be setup under the County Fund for Los Angeles, as established in the April 28, 2020 Board Motion on "Roadmap to Economic

Recovery;" and

Include a sunset date of 90 days after the conclusion of the "Safer at Home" Health Officer Orders. (20-3043)

9. A Just and Equitable Response to Disparities Illuminated by the COVID-19 Pandemic

Develop and implement culturally and linguistically, as well as literacy appropriate public education campaigns by contracting with outside entities with deep connections within highly impacted communities, including Black, Latinx, Asian, Native Hawaiian/Pacific Islander, Indigenous, American Indian and Alaskan Native, low-income, and justice involved populations, such as local ethnic media partners and local community-based organizations, and in partnership with local community leaders by underscoring the availability of free COVID-19 testing regardless of immigration or insurance status, the symptoms of COVID-19 and signs that may signify the need to seek medical care, health options for those without a regular provider, and resources related to the pandemic; leveraging the ability of community-based organizations, including organizers, community health promoters, gang intervention workers, nonprofit organizations, congregations, labor unions, and others, to directly reach out to their constituents and form "neighborhood education teams;" identifying, strengthening and amplifying the capacity of supportive resources (e.g. 2-1-1, One Degree, Hunger Action LA's People's Guide to Welfare Health and Other Services); and connecting to information hubs that exist in a variety of mediums including, but not limited to, hotlines and websites;

Partner with local community clinics and community-based organizations that serve the most COVID-19-impacted neighborhoods and non-geographic identity-based vulnerable groups (such as the American Indian Alaskan Native population) to provide technical assistance, as needed, to help community organizations collaborate with existing and proposed testing sites and support testing sites in high impact communities by providing access to testing resources, including advising on options to obtain reimbursement for COVID-19 testing through available State and Federal mechanisms; as supplies are available, leverage State stockpile and Personal Protective Equipment (PPE) resources in a manner that supports distribution to community-accessible testing sites; conduct outreach to the community about COVID-19 testing and linkages to healthcare and other supportive services (e.g. housing, food, etc) with a focus on engaging and funding community partners in outreach and engagement activities in the most vulnerable and at-risk communities; identify the capacity and resource needs of the community-based clinics and organizations that serve our most impacted neighborhoods, to offer testing and have an adequate supply of PPE for clinical staff; leverage the cultural and linguistic competency of community partners to support and enhance the County's contact tracing efforts in our vulnerable and at-risk communities; and ensure testing and contact tracing efforts are integrated with care delivery and linkages to supportive services through the engagement of community partners, Federally-gualified health centers, and County clinics;
