3. Establishing an Antiracist Los Angeles County Policy Agenda

Recommendation as submitted by Supervisor Ridley-Thomas: Recognize, affirm and declare that racism is a matter of public health in the County and that racism against Black people has reached crisis proportions that result in large disparities in family stability, health and mental wellness, education, employment, economic development, public safety, criminal justice and housing; direct the Chief Executive Officer to establish an eighth Board-directed priority to address the elimination of racism and bias in the County and develop a strategic plan and underlying policy platform articulating the goals, actions and deliverables, establish an organizational unit within the Chief Executive Office that is dedicated to implementing the plan and report back to the Board in writing in 60 days on the strategic plan and policy

platform; and take the following actions:

Direct the Chief Executive Officer, and other Departments, to evaluate existing County policies, practices, operations and programs through a lens of racial equity in order to more effectively promote and support policies that prioritize physical and mental health, housing, employment, public safety and justice in an equitable way for African Americans;

Direct the Chief Executive Officer, in collaboration with the Director of Personnel and Department Directors, to assess existing policies, processes and practices that may prevent African Americans from advancing within County Departmental career ladders and develop procedures that best advance and sustain Countywide and Departmental equity commitments;

Support the Los Angeles Homeless Services Authority in its work to execute a workplan, in collaboration with the County and the City of Los Angeles, to prioritize and advance the overarching strategies and 67 recommendations put forward by the Ad Hoc Committee for Black People Experiencing Homelessness, where the workplan would establish baseline data to track and evaluate implementation of the recommendations;

Direct the Executive Director of the Human Relations Commission and the Chief Executive Officer to:

Commission an annual report (Report) by an academic institution and/or research institute that outlines and provides a regular update on the State of Black Los Angeles County with a focus on outcomes for African Americans in the areas of physical and mental health, education, employment, law enforcement, justice, housing and homelessness, including updates from the implementation of recommendations made by the Ad Hoc Committee on Black People Experiencing Homelessness;

Direct the Chief Executive Officer to work with the Executive Director of the Human Relations Commission to execute data usage agreements for relevant County Departments, as necessary, and develop a funding plan, in consultation with philanthropy and academia to identify the requisite funding to produce the Report each year;

Direct the Chief Executive Officer to ensure that all County Department Directors identify at least one Management Appraisal and Performance Plan goal each year that strengthens organizational capacity for cultural competency and vigilance to reduce racial stigma, inequality and implicit bias within their respective Departments; and

Direct the Chief Executive Officer to recommend and advocate for relevant legislative policies that improve outcomes and reduce racial disparities and support local, regional, State and Federal initiatives that advance efforts to dismantle systemic racism. (20-3641)

8. Extending Eviction Moratorium through September 30, 2020 and Establishing County's Eviction Protections as Baseline in Incorporated Cities

Recommendation as submitted by Supervisors Kuehl and Solis: Adopt a resolution further amending and restating the Executive Order to extend the County's Eviction Moratorium through September 30, 2020, unless further extended or repealed by the Board, and establishing the County's eviction protections as the baseline for all incorporated cities within the County to the extent that the cities' eviction moratoria do not include the same or greater tenant protections as the provisions of the County's Eviction Moratorium. (Relates to Agenda No. 25)

Supervisor Kuehl revised the resolution in her joint motion with Supervisor Solis, page 4, Section III. a, to remove the sentence "Cities that have local eviction moratoria in place are exempt from this Moratorium, except that this Moratorium shall apply to residential tenants, mobilehome space renters, and commercial tenants, respectively, in incorporated cities within the County whose local eviction moratoria does not address residential tenants, mobilehome space renters, or commercial evictions, and effective July 21, 2020, does not include the same or greater tenant protections as the provisions of this Moratorium." and replace with Except as otherwise indicated, effective July 21, 2020, this Moratorium applies to all unincorporated areas and incorporated cities within the County of Los Angeles pursuant to Government Code Section 8630, et seg. and Chapter 2.68 of the County Code. It is the intent of the County, in enacting this Moratorium, to provide uniform, minimum standards protecting residential, mobilehome space renters, and commercial tenants during this local emergency. Nothing in this Moratorium shall be construed to preclude any city from imposing, or continuing to impose, greater local protections than are imposed by this Moratorium if the protections are not inconsistent with

this Moratorium. Examples of greater local protections include, but are not limited to, additional time to notify a landlord of inability to pay, no requirement that a tenant notify a landlord of an inability to pay, no requirement to provide certification or evidence of inability to pay, additional prohibited reasons for eviction, additional time to repay rent due, or the application of protections beyond the expiration of this Moratorium.

Supervisor Barger made a motion to amend Supervisors Kuehl and Solis' joint motion to adopt a revised resolution further amending and restating the Executive Order to extend the County's Eviction Moratorium through September 30, 2020, unless further extended or repealed by the Board, but defer establishing the County's eviction protections as the baseline for all incorporated cities within Los Angeles County; and instruct the Director of Consumer and Business Affairs, in consultation with County Counsel, to report back to the Board within 14 days, with a comparison of the tenant protections contained in each local moratorium within the County to the County's Moratorium to determine which of the County's tenant protections would apply to those cities if the County's tenant protections were extended as proposed, including the resources required to successfully create a communications and education campaign for the new provisions, for tenants and landlords across 88 cities Countywide.

10. Expanding the Monitoring of Compliance with County Health Officer Orders in the Workplace to Slow COVID-19 Transmission

Recommendation as submitted by Supervisors Kuehl and Ridley-Thomas: Instruct the Director of Public Health, in consultation with County Counsel, the Chief Executive Officer and the Director of Consumer and Business Affairs, to consult with labor representatives, worker advocates and business community representatives, and report back to the Board in 14 days on opportunities for monitoring compliance with County Health Officer Orders (HOO), including the feasibility of establishing a mechanism by which employees at workplaces across sectors throughout the County can quickly notify the Department of Public Health (DPH) about possible violations of County HOOs and guidelines, including budget implications of implementing a plan that would include the following:

Ensuring that employers Countywide allow the establishment of public health councils comprised of employees at their worksites, and the public health councils will expand DPH's HOO enforcement capacity by working with third-party worker and community-based organizations certified by DPH to monitor, document and report any violations of the County's HOOs and guidelines, and employees must be allowed to form public health councils without retaliation by their employer;

Providing for the certification of third-party worker and community-based organizations that can serve as the intermediary between the public health councils and DPH, where the certified third-party worker and community-based organizations will: assist public health councils in understanding public health orders and guidance; provide technical assistance to public health councils in identifying non-compliance; and help public health councils prepare reports and documentation to submit to DPH for further investigation; and DPH will develop the certification criteria, as well as the process, by which certified third-party worker and community-based organizations will collaborate with DPH, at a minimum, that criteria and process should include the following:

Certification of third-party worker and community-based organizations with knowledge of and experience communicating with workers in various industries throughout the County with the goal of certifying multiple organizations each with a focus on specific sectors (garment industry, hospitality, janitorial, food service and production, etc.);

Training to ensure third-party worker and community-based organizations understand and are well versed on the County's HOOs

and guidelines for the specific industry which they are monitoring; and

- v. Capital funding for transitional housing, affordable housing, and supportive housing; and

B. Alternatives to Incarceration:

- i. Community-based restorative justice programs;

Ensure that the ordinance containing the proposed charter amendment is clear that the use of any of these earmarked funds for carceral systems and any law enforcement agencies, including the Sheriff's Department, the District Attorney's Office, Los Angeles County Superior Courts, or the Probation Department, including redistribution of funds through these agencies, is strictly forbidden. This restriction does not extend to State laws requiring the County to fund court facilities and certain court-related expenditures including, but not limited to, the Trial Court Facilities Act of 2002 (2002 Senate Bill No. 1732), Lockyer-Isenberg Trial Court Funding Act of 1997 (1997 Assembly Bill No. 233), and other mandatory fines and fees; and
