4. Additional Funding for Mobile Stroke Unit Program

10. Alignment of the Los Angeles County Board of Supervisors' "Care First, Jail Last" and Law Enforcement Transparency and Accountability Priorities with Legislative Policies

Recommendation as submitted by Supervisors Solis and Kuehl: Direct the Acting Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Division, to advocate with Governor Gavin Newsom in support of the following measures, if and when they make it to his desk:

Assembly Bill (AB) 66 (Gonzalez), legislation which would prohibit the use of kinetic energy projectiles or chemical weapons by any law enforcement agency to disperse an assembly protected by the First Amendment of the United States Constitution;

AB 329 (Kamlager) and AB 767 (Grayson), legislation which would expand eligibility for compensation under the Victims Compensation Program for injuries or death caused by use of force by a police officer and define "crime" to include the use of excessive force by a peace officer;

AB 1022 (Wicks), legislation which would require each law enforcement agency to require officers to immediately report potential excessive force, and intercede when present and observing an officer using excessive force;

AB 1314 (McCarty), legislation which would require municipalities to annually post on their website information relating to the use of force settlements and judgments;

AB 1506 (McCarty), legislation which would allow law enforcement agencies and district attorneys to request a new division of the Attorney General's office to investigate and potentially prosecute a criminal case when there is an officer involved shooting that results in a death of a member of the public;

AB 1550 (Bonta), legislation which would authorize a person to bring a civil action against any responsible party who, motivated by the person's protected status, knowingly causes a peace officer to arrive at a location to contact the person with the intent to, among other things, infringe upon the person's right;

AB 1599 (Cunningham), legislation which would require a law enforcement agency or oversight agency to complete investigations into allegations of the use of force, sexual assault, discharge of a firearm or dishonesty relating to the investigation of a crime or misconduct by another peace officer or custodial officer, despite the peace officer's or custodial officer's voluntary separation from the employing agency;

AB 1775 (Jones-Sawyer), legislation which would make a number of changes in criminal and civil law to discourage individuals from using 911 or other communications with law enforcement to harass a person because that person belongs to a protected class;

Senate Bill (SB) 731 (Bradford), legislation which would create a statewide process to automatically revoke the certification of a peace officer following the conviction of certain serious crimes or termination of employment due to specified misconduct; and

SB 776 (Skinner), legislation which would expand the categories of personnel records of peace officers and custodial officers that are subject to disclosure under the California Public Records Act; and

Direct the Acting Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Division to work with the Board, the Executive Director of the Civilian Oversight Commission and the Inspector General, to develop legislative policies and priorities that will support measures in the future that reflect the Board's commitment to strengthen law enforcement transparency, accountability and policing reform in the County's Federal and State legislative

agendas; and work with the Alternatives to Incarceration Initiative (ATI), in collaboration with relevant Departments, to develop legislative policies and priorities relevant to the Board's adoption of "care first, jail last," which supports alternatives to incarceration and the ATI Workgroup recommendations and which can be included in the County's State and Federal Legislative Agendas prior to the Board's adoption, in addition, request that an update on legislative advocacy efforts be included in the ATI Director's report back to the Board. 11. Support Assembly Bill 1436 (Chiu) to Create the COVID-19 Tenant, Small Landlord, and Homeowner Relief Acts of 2020

Recommendation as submitted by Supervisors Solis and Kuehl: Direct the Acting Chief Executive Officer to send a five-signature letter to Governor Gavin Newsom requesting that he sign Assembly Bill 1436 (Chiu), legislation which would temporarily suspend eviction or foreclosure due to COVID-19 related financial impacts and increase time for those with COVID-19 impacts to make payments on rent or mortgages, while creating a pathway for landlords and mortgage holders to recover what is owed to them. 12. Ending ICE Transfers Without a Judicial Warrant in Los Angeles County

Revised recommendation as submitted by Supervisors Solis and Kuehl: Prohibit the use of any County resources, property, personnel, time, labor or funds to be used to honor requests by immigration authorities or persons or entities contracted for immigration enforcement purposes to hold, detain, house, transfer or otherwise facilitate the arrest of any person in the Sheriff's Department custody, unless pursuant to a judicial warrant or judicial probable cause determination, or as otherwise required by Federal or State law; or directly communicate with immigration authorities or persons or entities contracted for immigration enforcement purposes regarding an individual's release time, date or place, or immigration status, or to otherwise participate in any immigration enforcement activities, unless pursuant to a judicial warrant or judicial probable cause determination, or as otherwise required by Federal or State law;

Prohibit access to and use of County property, including Sheriff's Department jails, stations, courthouse lockups and databases, to immigration authorities or persons or entities contracted for immigration enforcement purposes, unless pursuant to a judicial warrant or judicial probable cause determination, or as otherwise required by Federal or State law.

Direct the Acting Chief Executive Officer, in consultation with County Counsel, to prepare and issue a letter to impacted County Departments advising them of this

directive; and

The County defines a “judicial probable cause determination” and “judicial warrant” as defined in Government Code Section 7284.4, Subdivisions (h) and (i); “immigration authorities” as defined in Government Code Section 7284.4, Subdivision (c); and “immigration enforcement” as defined in Government Code Section 7284.4, Subdivision (f). 14. Preparation for Influenza Season During the COVID-19 Pandemic
