Discussion and consideration of necessary actions on the Public Health Order related to COVID-19, as requested by the Chair of the Board; and a status on the COVID-19 vaccine, as requested at the Board meetings of December 8, 2020 and January 5, 2021. (20-4861)

Dr. Genevieve Clavreul addressed the Board. Interested person(s) also submitted written testimony.

Dr. Barbara Ferrer, Director of Public Health, made a presentation and responded to questions posed by the Board. Dr. Christina Ghaly, Director of Health Services, also addressed the Board.

Supervisor Solis instructed the Director of Public Health to ensure that teachers and those serving in the hardest hit communities have access to the vaccines with enforcement tools to ensure an equitable process.

Supervisor Barger instructed the Director of Public Health to look into the equity issues and ensure the vaccine distribution is equitable for the most vulnerable communities.

Supervisor Kuehl instructed the Director of Public Health to target the severely impacted communities and advertise through examples and trusted

community entities, that the vaccine is becoming widely available and accepted.

Supervisor Hahn instructed the Director of Public Health to include in the next report to the Board a plan to target impacted communities.

Supervisor Mitchell instructed the Director of Public Health to look at the two-dose compliance rates to determine those communities where people are less likely to return for a second dose.

After discussion, by Common Consent, there being no objection, this item was received and filed; and the Director of Public Health was instructed to ensure that teachers and those serving in the hardest hit communities have access to the vaccines with enforcement tools to ensure an equitable process; look into the equity issues and ensure the vaccine distribution is equitable for the most vulnerable communities; target the severely impacted communities and advertise through examples and trusted community entities, that the vaccine is becoming widely available and accepted; include in the next report to the Board a plan to target impacted communities; and to look at the two-dose compliance rates to determine those communities where people are less likely to return for a second dose.

2. Hearing on Ordinance to Amend a Proprietary Petroleum Pipeline Franchise Granted to Phillips 66 Company

Hearing on ordinance for adoption amending the proprietary petroleum pipeline franchise (3 and 4) granted to Phillips 66 Company to extend the term of the franchise through February 22, 2036; change the formula for calculating the base annual franchise fee; impose testing and reporting requirements pertaining to hazardous materials pipelines and their compliance with applicable laws; make other minor revisions to clarify certain terms and conditions of the franchise; find that good cause exists to change the formula for calculating the base annual franchise fee in the proprietary pipeline franchise granted to Phillips 66 Company; and find that the proposed project is exempt from the California Environmental Quality Act. **(Department of Public Works)** (21-0881)

11. Developing Digital Divide Regional Strategic Plan

Recommendation as submitted by Supervisors Solis and Kuehl: Instruct the Chief Information Officer, in coordination with the Directors of Internal Services, Regional Planning, Public Works and Consumer and Business Affairs, the Acting Director of Workforce Development, Aging and Community Services, County Counsel, and other relevant Departments, to develop and implement a County Internal Action Plan in 90 days that, at a minimum aggregates all existing and planned Digital Divide efforts by County Departments; identifies common strategic objectives among the various efforts and ensures coordinated implementation of the various efforts; standardizes the reporting on activities and outcomes, including an evaluation of utilizing visual dashboards to track progress; and identifies gaps and limitations, including resource and funding constraints, that will assist in the strategic development and prioritization of future initiatives; and take the following actions:

Instruct the Chief Information Officer, in coordination with the above-listed Departments, as well as external stakeholders, including cities, private sector partners, community based organizations, school districts, nonprofits, venture capitalists and others, to develop and begin implementing a Comprehensive Regional Digital Divide Strategy for the County and report back to the Board with quarterly progress updates that, at a minimum:

Establishes regional priorities, goals and objectives to tackle the Digital Divide, including short-, medium- and long-term strategies;

Identifies and develops sustainable solutions for persistent inequity in access to digital resources;

Identifies and involves stakeholders and community partners in the inclusive development of such sustainable, equity-based solutions;

Establishes transparent criteria to measure success and track progress against the target metrics;

Explores and secures short- and long-term investment and funding opportunities from State and Federal sources, venture capitalists and regional investors, in addition to philanthropic partnerships and grant funding;

Identifies local, State, and Federal policies that are essential to bridging the Digital Divide; and

Leverages best practices and synergies from other local, State and Federal government efforts; and

Authorize the Chief Executive Officer to retain a consultant to assist the Chief Information Officer to convene Departments and regional stakeholders in a results-oriented discussion to solve common Digital Divide; and

Direct the Chief Executive Officer, through the Legislative Affairs and Intergovernmental Relations Division, to support State and Federal Legislation, and advocate for legislative and regulatory changes, that support the objectives of this motion, the County Internal Action Plan and the Comprehensive Regional Digital Divide Strategy. (21-0904)
