STATEMENT OF PROCEEDINGS FOR THE MEETING OF THE HOUSING AUTHORITY OF THE COUNTY OF LOS ANGELES TUESDAY, MARCH 31, 2009 9:30 A.M.

1-H. Recommendation as submitted by Supervisor Ridley-Thomas: Approve and authorize the Acting Executive Director to accept the American Recovery and Reinvestment Act Capital Fund Program (ARRA CFP) funds from the U.S. Department of Housing and Urban Development (HUD), in an estimated amount of \$7,401,512 and incorporate the funds into the Housing Authority's Fiscal Year 2008-09 budget; also adopt and instruct the Chairman to sign resolution, as required by HUD, to accept the ARRA CFP funds for various construction activities at 14 housing developments. - 2. For all funded projects or activities, an accounting of the deadlines for spending the money, what projects or activities are eligible to receive funds, how much money has been expended in each category, and how much money remains to be spent in each category; and
- 3. As applicable, and as legally permissible, a reporting of all public and private entities that receive funds administered or disbursed by the CDC/HACoLA and the purpose for which that money was spent.

Instruct all Department/District Heads to determine if they have covered accounts as defined in the ITPP and a) immediately begin developing a policy to comply with the ITPP if a department's review identifies covered accounts; b) notify the Chief Information Officer (CIO) in writing of the results of their review including details on the methodology used to determine the results, if no covered accounts are discovered:

Instruct the Chief Executive Officer and the CIO to establish a taskforce that will develop an implementation plan and ensure that all program deliverables and objectives are met by September 2009;

Instruct all Department/District Heads to complete their review and establish a final, department specific policy by December 31, 2009;

Instruct the CIO to report back on the progress of implementation of the ITPP at the first Board of Supervisors meeting in September, 2009, and again in December, 2009; and

Instruct the CIO to report back annually on the status of the ITPP at the first Board of Supervisor's meeting in September commencing in 2010 to include evaluation of the effectiveness of the ITPP with respect to opening of covered accounts, existing covered accounts and service provider arrangements, identification of any significant incidents involving identity theft, responses to such incidents, notification to other departments of "lessons learned;" and any recommendations for changes to the ITPP.
