Programs and services (including Department of Public Social Services and Community and Senior Services programs) provided to relative caregivers, as well as an analysis of the gaps where additional support is needed from both Countywide and regional perspectives;

The volume and types of calls (e.g., referrals from the State Ombudsman, foster parents, birth parents or other types of caregivers) received by the Department of Children and Family Services (DCFS) Ombudsman in calendar year 2014; and

The feasibility of establishing a 24/7 Caregiver Call Center within its existing budget to support the needs of relative and foster caregivers or birth parents, that should work closely with other County Departments and the Kinship Support programs, once established; also

Using the solicitation process for the Prevention Initiative Demonstration Project as a model, instruct the Director of Children and Family Services to issue a Request for Information to partner with community-based organizations (CBO) (one in each Supervisorial District) to develop Kinship Support programs, and allocate up to \$1,250,000 annually from its existing budget to contract with qualified CBOs for these purposes, with each program being different to meet the unique needs of each community to allow providers to establish and operate the program, including staffing, space for out-stationing DCFS staff onsite partial time, program activities, as well as direct support for families in need, and requiring community-based providers to be able to demonstrate robust experience in the past five years in prevention and after care services, Family Visitation Center models, and offer services including, but not limited to:

- Emergency needs assessments and support, such as food, transportation and other emergency need vouchers;
- Respite care and child care linkages;
- Systems navigation and collaboration with other local agencies, such as courts, schools and County Departments;
- Space for visitation;
- Support groups, training and orientations;
- Educational advocacy, guidance and referrals for tutoring;
- Legal assistance;
- Adoption and Safe Families Act home assessment support;
- Live Scan, health and mental health services and other social services referrals;
- Assistance with eligibility for government benefits (Approved Relative Caregiver, AB 12, Cal Fresh, CalWORKS, Family Caregiver Support Program, housing and others); and
- Family support services, including activities to support economic stability and increase social connections among caregiving families. (15-2676)

Recommendation as submitted by Supervisor Kuehl: Authorize the Interim Director of Public Health, in partnership with the Director of Health Services, to develop and implement a plan for a robust, comprehensive program to deliver Pre-Exposure Prophylaxis (PrEP) throughout the County, considering a broad range of medical providers, including the Departments of Public Health and Health Services' operated clinics as well as community-based organizations and clinics, that can effectively provide PrEP to those at high risk for contracting HIV; instruct the Interim Director of Public Health to report back to the Board in writing within 30 days on the PrEP program implementation plan, including details on program target population, program elements such as robust public education and awareness campaign, the provision of technical assistance to local providers and service delivery elements, specific timeline and milestones for program implementation, program monitoring and evaluation of the plan, and the Departments of Public Health and Health Services' financed investment strategy; and instruct the Interim Director of Public Health to develop and release a solicitation within 45 days to fully support private-sector delivery of PrEP services to benefit uninsured and underinsured residents of the County at high risk for HIV infection. Supervisor Kuehl accepted Supervisor Solis' friendly amendment.


