Report by the District Attorney on the Victim Witness Assistance Program (VWAP) and Restitution Enhancement Program (REP). (14-3165)

Joseph Maizlish, Sheila Pinkel, Nicole Parson, Father George Horan, Stephon Beckam, Arnold Sachs, Kim McGill, Michael Jenkins and Diana Beard-Williams addressed the Board.

Jackie Lacey, District Attorney, presented a report and responded to questions posed by the Board. Lydia Bodin, Deputy in Charge, Bureau of Prosecution Support Operations, District Attorney's Office, Donna Wills, Director of Victim Witness Assistance Program, and Jim McDonnell, Sheriff, also responded to questions posed by the Board.

Supervisor Antonovich made a motion that the Board support the Interim Chief Executive Officer's recommendations and instruct the Interim Chief Executive Officer to:

- 1. Allocate a total of \$1,158,000 to the District Attorney's Office to fully fund 10 victim services representatives at a cost of \$719,000 and five paralegals for the Victim Restitution Unit at a cost of \$439,000;
- 2. Work with the District Attorney, as well as other relevant County Departments, to review and analyze the other existing gaps impacting victims and provide recommendations to the Board in 60 days, including the three additional positions requested by the District Attorney for direct victim services and the feasibility of utilizing unclaimed victim restitution as provided under Government Code Section 500.50; and

Further, that the Board adopt the District Attorney's six recommendations relating to the victim restitution as follows:

- Designate the Sheriff's Department as the agency authorized to collect victim restitution from inmates housed in County jail pursuant to a Penal Code 1170 (h) sentence;
- Request the Sheriff's Department to collect the maximum 50 percent allowed from deposits made into an inmate trust account when the inmate has an outstanding restitution order pursuant to a Penal Code 1170 (h) sentence and impose an additional 10 percent of any amounts collected to support collection processes;

- 3. Designate the Probation Department as the agency authorized to collect restitution, including the 10 percent as described in Recommendation No. 2 above, from both the Post-Release Community Supervision (PRCS) population and offenders on mandatory supervision following their release from County jail on a Penal Code 1170 (h) split sentence;
- 4. Designate the District Attorney's Office as the agency authorized to obtain court-ordered fines and restitution on behalf of crime victims and to utilize and expand Prosecutorial Information Management System (PIMS) to initiate a digital record that is subsequently transmitted to the Sheriff's Department and the Probation Department through Collections and Accounts Receivables System (CARS) in a centralized County restitution system in order to effect collection from criminal defendants;
- Expand the Treasurer Tax Collector's role to support collection of restitution from all Assembly Bill 109 realigned populations utilizing the CARS, or its successor system, as the centralized County restitution system; and
- Direct the Countywide Criminal Justice Coordination Committee
 and the Restitution Taskforce to report back to the Board
 in 90 days with the status of the restitution collection plan discussed
 in the District Attorney's report, including systems issues and
 resource needs.

Supervisor Solis made a friendly amendment to Supervisor Antonovich's foregoing motion to request an additional staff for the victim witness assistance program in East Los Angeles and San Gabriel Valley.

Supervisor Antonovich accepted Supervisor Solis' friendly amendment.

Supervisor Kuehl made a request to bifurcate approval of Recommendation Nos. 1 and 2 of Supervisor Antonovich's foregoing motion from the portion of Supervisor Antonovich's motion related to the adoption of the recommendations by the District Attorney and continue to the Board meeting of September 15, 2015.

The Mayor ordered a division of the question.

After discussion, on motion of Supervisor Antonovich, seconded by Supervisor Knabe, the report by the District Attorney was received and

filed; and Recommendation Nos. 1 and 2 of Supervisor Antonovich's motion were approved as amended to instruct the Interim Chief Executive Officer to:

- 1. Allocate a total of \$1,158,000 to the District Attorney's Office to fully fund 10 victim services representatives at a cost of \$719,000 and five paralegals for the Victim Restitution Unit at a cost of \$439,000;
- 2. Work with the District Attorney, as well as other relevant County Departments, to review and analyze the other existing gaps impacting victims and provide recommendations to the Board in 60 days, including the three additional positions requested by the District Attorney for direct victim services and the feasibility of utilizing unclaimed victim restitution as provided under Government Code Section 500.50;
