Indication in the above statements how priority is given to the three key Plan elements described above that support greater demand for high-skill, growing local industries, including targeted workforce development, local small business and social enterprise support and positioning County capital assets and infrastructure to maximize local and regional economic well-being;

Direct the Chief Executive Officer to establish an Economic Development Policy Committee, chaired by a representative of the Chair of the Board, with representatives from each Board office, as well as Department of Consumer and Business Affairs, Department of Community and Senior Services, Chief Executive Office's Capital Projects and Real Estate Offices, and Community Development Commission, and senior subject matter representatives or Economic Development Liaisons from the other Departments that are deemed relevant upon review of the Plan, including but not limited to the

Departments of Human Resources, Internal Services, Public Works, Health Services, Regional Planning, Public Social Services, Children and Family Services, Chief Executive Office's Service Integration Branch, Chief Information Office and Office of Education; and

Propose the Policy Committee to convene a group of independent economic development research institutes and academic institutions to join LAEDC in reviewing and providing advice for the Chief Executive Officer's strategy of implementation and quarterly reporting going forward. (16-0108)
