> Direct the Chief Executive Officer and the Homeless Initiative to work with the Los Angeles Homeless Services Authority and the providers in Bell, Pomona, Lancaster and High Desert MACC to keep the winter shelters in those locations open until March 31, 2016, and activate Augmented Winter Shelters through March 31, 2016, as dictated by the weather, and take any other actions consistent with and necessary for the implementation of the foregoing actions.
