Finding Words

You can use the Find command to find a complete word or part of a word in the current PDF document. Acrobat Reader looks for the word by reading every word on every page in the file, including text in form fields.

To find a word using the Find command:

- 1. Click the Find button (**Binoculars**), or choose Edit > Find.
- 2. Enter the text to find in the text box.
- 3. Select search options if necessary:
 - Match Whole Word Only finds only occurrences of the complete word you enter in the box. For example, if you search for the word *stick*, the words *tick* and *sticky* will not be highlighted.
 - Match Case finds only words that contain exactly the same capitalization you enter in the box
 - Find Backwards starts the search from the current page and goes backwards through the document.
- 4. Click Find. Acrobat Reader finds the next occurrence of the word.

To find the next occurrence of the word:

Do one of the following:

Choose Edit > Find Again

Reopen the find dialog box, and click Find Again. (The word must already be in the Find text box.)

Copying and pasting text and graphics to another application

You can select text or a graphic in a PDF document, copy it to the Clipboard, and paste it into another application such as a word processor. You can also paste text into a PDF document note or into a bookmark. Once the selected text or graphic is on the Clipboard, you can switch to another application and paste it into another document.

Note: If a font copied from a PDF document is not available on the system displaying the copied text, the font cannot be preserved. A default font is substituted.

To select and copy it to the clipboard:

1. Select the text tool T, and do one of the following:

To select a line of text, select the first letter of the sentence or phrase and drag to the last letter.

To select multiple columns of text (horizontally), hold down Ctrl+Alt (Windows) or Option (Mac OS) as you drag across the width of the document.



To select a column of text (vertically), Hold down Ctrl+Alt (Windows) or Option+Command (Mac OS) as you drag the length of the document.

To select all the text on the page, choose Edit > Select All. In single page mode, all the text on the current page is selected. In Continuous or Continuous – facing mode, most of the text in the document is selected. When you release the mouse button, the selected text is highlighted. To deselect the text and start over, click anywhere outside the selected text. The Select All command will not select all the text in the document. A workaround for this (Windows) is to use the Edit > Copy command.

- 2. Choose Edit > Copy to copy the selected text to the clipboard.
- 3. To view the text, choose Window > Show Clipboard
 In Windows 95, the Clipboard Viewer is not installed by default and you cannot use the
 Show Clipboard command until it is installed. To install the Clipboard Viewer, Choose
 Start > Settings > Control Panel > Add/Remove Programs, and then click the Windows
 Setup tab. Double-click Accessories, check Clipboard Viewer, and click OK.

- 10 CONSTRAINTS THAT WE ALL HAD TO HOLD ON TO AS MEMBERS OF THIS
- 11 BOARD, NOW WE'RE BEING PUNISHED FOR IT AND OUR MONEY IS BEING
- 12 TAKEN. I THINK WE SHOULD DELAY THIS VOTE UNTIL WE GET A BETTER
- 13 SENSE OF HOW THE GOVERNOR IS GOING TO MOVE FORWARD ON IT. I
- 14 THINK HE OWES US A DUTY. WE'RE THE LARGEST COUNTY IN THIS
- 15 STATE. HE SHOULD TAKE THE TIME, BESIDES STOPPING AT EVERY MINI
- 16 MALL THAT THERE IS OUT THERE AND CAMPAIGNING ON IT, HOW ABOUT

- 21 SUP. KNABE, CHAIR: I JUST WOULD ADD, I MEAN, OBVIOUSLY YOUR
- 22 DELAY IS AN ATTEMPT TO DELAY TO STICK IT OUT AFTER THE
- 23 ELECTION AND THE ELECTION IS TWO WEEKS FROM TODAY. I MEAN, YOU
- 24 KNOW, I THINK WE DO KNOW WHERE WE'RE GOING, SHOULD WE NOT--
- 25 THE VOTERS NOT PASS 57 AND 58. I THINK THAT'S THE CONCERN. I



- 1 DON'T THINK THERE'S ANY DIFFERENCE OF OPINION AS TO WHAT YOU
- 2 ARTICULATE AS IT RELATES TO THE ISSUES THAT WE DON'T KNOW ARE
- 3 ON THE HORIZON. WE CERTAINLY KNOW WHAT'S ON THE HORIZON IF
- 4 WE'RE NOT ABLE TO PUT TOGETHER 57 AND 58 AND I THINK THAT'S
- 5 THE CONCERN OF ALL OF US. I'M NOT SURE THAT IT'S SUPERVISOR
- 6 ANTONOVICH'S MOTION, WHETHER HE WANTS TO MOVE FORWARD, UP OR
- 7 DOWN TODAY. I THINK THAT, AS A BOARD, THAT IT'S VERY IMPORTANT
- 8 THAT WE MOVE FORWARD TO AT LEAST, AS THE LARGEST COUNTY, LEND

- 11 AS A BOARD, THIS BOARD, ASIDE FROM THE MEETINGS YOU HAVE...

13 SUP. KNABE, CHAIR: RIGHT. NO, HE'S COMMITTED TO BOTH OF US

- 15 SUP. YAROSLAVSKY: THEY'RE VERY IMPORTANT AND SOONER RATHER
- 16 THAN LATER. AND, LIKE MS. MOLINA, I THINK THAT'S CRITICAL. I
- 17 THINK THAT HE NEEDS TO TALK AT THAT LEVEL TO US, NOT THROUGH
- 18 HIS STAFFS. THAT, OBVIOUSLY, GOES WITHOUT SAYING THAT THERE
- 19 WILL BE, AT THE STAFF LEVEL, THERE'LL BE A LOT OF

- 23 SUP. MOLINA: MR. CHAIRMAN, TO YOUR POSITION ABOUT BEING PART
- 24 OF THE SOLUTION, I WOULD VERY MUCH LIKE TO BE A PART OF THE
- 25 SOLUTION BUT THIS DOESN'T PRESENT ITSELF AS A SOLUTION. THIS



- I IS A STOPGAP REMEDY. THAT'S ALL IT IS. LET'S BORROW AND--
- 2 RIGHT NOW HE WANTS TO BORROW MORE THAN WHAT HE ACTUALLY NEEDS
- 3 IN ORDER TO FILL THE HOLE AND STILL MAKING NO COMMITMENT TO
- 4 THE-- SOME OF US IN WHERE HE'S RIPPED US OFF OF THESE DOLLARS.
- 5 THE REALITY IS, WE NEED THAT MEETING. I NEED TO KNOW WHERE
- 6 WE'RE GOING BECAUSE, WHEN I SIT DOWN WITH MY CONSTITUENTS AND
- 7 I HAVE TO CLOSE DOWN PARKS, WHEN I HAVE TO CLOSE DOWN

- 1 SUP. BURKE: I CAN UNDERSTAND SUPERVISOR MOLINA'S POSITION
- 2 BECAUSE THERE'S NO QUESTION WE'RE IN A VERY UNTENABLE POSITION
- 3 AND I AM VERY CONCERNED ABOUT LIBRARIES, I'M VERY CONCERNED
- 4 ABOUT THE LIFEGUARDS, I'M CONCERNED ABOUT OUR PARKS. BUT IF I
- 5 LOOK AT WHERE WE ARE AT THIS MOMENT, I DON'T KNOW WHAT HAPPENS
- 6 UNLESS WE DO GO ALONG WITH THIS. WE STAND TO BE OUT OF AT
- 7 LEAST THREE AND A HALF BILLION. WE DON'T KNOW FOR SURE EXACTLY
- 8 -- OR NOT THREE AND A HALF BILLION, BUT 360 MILLION-- WE KNOW
- 9 FOR SURE IF THERE IS NOT SOME METHOD OF CLOSING THAT GAP. NOW,
- 10 FROM A-- IF I WAS NOT PART OF THIS BOARD OF SUPERVISORS, I
- 11 WOULD PROBABLY TAKE A POSITION IN OPPOSITION OF IT AND I WOULD
- 12 PROBABLY NOT VOTE FOR IT. BUT I FEEL VERY UNCERTAIN AND I FEEL
- 13 TERRIBLE TO PUT MY COUNTY IN A POSITION OF WHERE THEY MAY LOSE
- 14 THESE FUNDS AND BE FORCED INTO START CLOSING THINGS WHEN THERE
- 15 IS A POSSIBILITY, ALBEIT A TERRIBLE SOLUTION, BUT TO BORROW
- 16 THOSE FUNDS AND HAVE A CHANCE TO REPLACE SOME OF THOSE MONIES
- 17 IN TERMS OF THE TAXES, OUR PROPERTY TAXES, THAT WERE TAKEN.
- 18 NOW, THIS IS NOT A GOOD SOLUTION, TO PUT OVER TO GENERATIONS
- 19 WHAT IS REALLY OUR RESPONSIBILITY BUT THE FACT IS THAT WE
- 20 DON'T HAVE A LOT OF ALTERNATIVES. WALL STREET HAS ALSO SAID
- 21 THAT, IF WE DON'T BORROW, THEY MAY REDUCE THE BOND RATING OF
- 22 THE STATE OF CALIFORNIA TO JUNK BOND STATUS. SO IT'S A VERY
- 23 DIFFICULT SITUATION. IT'S ONE OF WHERE THIS IS NOT SOMETHING
- 24 WE WOULD WANT TO DO. I DEFINITELY DON'T THINK IT'S A GOOD
- 25 APPROACH. LONG-TERM BORROWING, 15 YEARS BORROWING,



- 1 PARTICULARLY WHEN WE STILL HAVE NEXT YEAR TO LOOK FORWARD TO
- 2 AND WE'RE GOING TO HAVE TO FACE THOSE-- THAT DEFICIT AT-- WHEN
- 3 THAT TIME COMES. SO THIS DOES NOT TAKE CARE OF ANY LONG-TERM
- 4 ISSUES. WE ARE ONLY FINDING OURSELVES AND PUTTING OURSELVES IN
- 5 A POSITION TO PERHAPS SAVE THE BASIC SERVICES THAT MAY BE CUT
- 6 IF WE DON'T DO SOMETHING. SO I'M PREPARED TO TAKE THIS
- 7 POSITION, TO VOTE FOR IT. I HOPE THAT WE DO MEET WITH THE
- 8 GOVERNOR. I HOPE THAT WE CAN EXPLAIN TO HIM EXACTLY WHAT THE

- 22 SUP. ANTONOVICH: LET ME JUST SAY THAT THIS PROPOSAL ALLOWS US
- 23 SOME BREATHING TIME. WITHOUT IT, WE HAVE CATASTROPHIC
- 24 DISRUPTION OF PUBLIC SERVICES WITH THE CLOSURE OF LIBRARIES
- 25 AND OTHER VITAL SERVICES. WITH THIS, IT ALLOWS US BREATHING



- 1 TIME TO NEGOTIATE, TO WORK WITH THE STATE LEGISLATURE AND ALSO
