Adobe Acrobat Reader

Finding Words

You can use the Find command to find a complete word or part of a word in the current PDF document. Acrobat Reader looks for the word by reading every word on every page in the file, including text in form fields.

To find a word using the Find command:

1. Click the Find button (**Binoculars**), or choose Edit > Find.
2. Enter the text to find in the text box.
3. Select search options if necessary:
Match Whole Word Only finds only occurrences of the complete word you enter in the box. For example, if you search for the word *stick*, the words *tick* and *sticky* will not be highlighted.

Match Case finds only words that contain exactly the same capitalization you enter in the box.

Find Backwards starts the search from the current page and goes backwards through the document.

4. Click Find. Acrobat Reader finds the next occurrence of the word.

To find the next occurrence of the word, Do one of the following:

Choose Edit > Find Again
Reopen the find dialog box, and click Find Again.
(The word must already be in the Find text box.)

Copying and pasting text and graphics to another application

You can select text or a graphic in a PDF document, copy it to the Clipboard, and paste it into another application such as a word processor. You can also paste text into a PDF document note or into a bookmark. Once the selected text or graphic is on the Clipboard, you can switch to another application and paste it into another document.

Note: *If a font copied from a PDF document is not available on the system displaying the copied text, the font cannot be preserved. A default font is substituted.*



To select and copy it to the clipboard:

1. Select the text tool **T**, and do one of the following:
To select a line of text, select the first letter of the sentence or phrase and drag to the last letter.

To select multiple columns of text (horizontally), hold down Ctrl+Alt (Windows) or Option (Mac OS) as you drag across the width of the document.

To select a column of text (vertically), Hold down Ctrl+Alt (Windows) or Option+Command (Mac OS) as you drag the length of the document.

To select all the text on the page, choose Edit > Select All. In single page mode, all the text on the current page is selected. In Continuous or Continuous – facing mode, most of the text in the document is selected. When you release the mouse button, the selected text is highlighted. To deselect the text and start over, click anywhere outside the selected text. The Select All command will not select all the text in the document. A workaround for this (Windows) is to use the Edit > Copy command. Choose Edit > Copy to copy the selected text to the clipboard.

2. To view the text, choose Window > Show Clipboard

In Windows 95, the Clipboard Viewer is not installed by default and you cannot use the Show Clipboard command until it is installed. To install the Clipboard Viewer, Choose Start > Settings > Control Panel > Add/Remove Programs, and then click the Windows Setup tab. Double-click Accessories, check Clipboard Viewer, and click OK.

4 CHILD SUPPORT. I WANTED TO PERSONALLY RECOGNIZE THE SUCCESSFUL
5 EFFORT OF THE AGENCY THROUGH THE LEADERSHIP PROVIDED HERE BY
6 THE BOARD AND BY DIRECTOR GOLIGHTLY TO IMPROVE THE CHILD
7 SUPPORT PROGRAM. THROUGH THE BOARD SUPPORT, THE L.A. DIRECTOR
8 HAS ACHIEVED SIGNIFICANT IMPROVEMENTS IN COLLECTIONS IN CHILD
9 SUPPORT. WHEN L.A. COUNTY WAS PLACED IN CORRECTIVE ACTION IN
10 2003, OUR CURRENT SUPPORT STATISTIC WAS ONLY 37 PERCENT. THE
11 RECENT FISCAL YEAR CLOSED OUT WITH A 48 PERCENT MARK. AND IN
12 THE BEGINNING MONTH OF THE NEXT FISCAL YEAR, THE IMPROVEMENT
13 WAS EVEN HIGHER. L.A. CHILD SUPPORT IS FULLY COMMITTED TO

22 FIRST OF ALL, THE DIVERSION RATE HAS BEEN AS HIGH AS 80
23 PERCENT. BUT IN THE LAST WEEK OF NOVEMBER, THE DIVERSION RATE
24 FOR AMBULANCES TO E.R. SATURATION WENT DOWN TO 33 PERCENT. SO
25 WE'RE ACTUALLY GOING IN THE RIGHT DIRECTION THERE. THE AVERAGE

1 DAILY CENSUS FOR THE MONTH OF NOVEMBER WAS 436, WHICH IS ABOUT
2 72 PERCENT OCCUPANCY, OR 70 PERCENT OF THE PATIENT FLOW. ON
3 PAGE 3, AN IMPORTANT FACTOR IS THE BOARDING TIME OF PATIENTS
4 IN THE EMERGENCY ROOM WAITING FOR A BED INTO THE HOSPITAL.
5 THAT NUMBER HAS GONE TO ABOUT 4.42, FOUR HOURS AND 42 MINUTES,
6 WHICH IS HIGHER THAN BEFORE. BUT KEEP IN MIND THAT WE ARE
7 AVERAGING THE FIRST DAYS IN THE HOSPITAL FOR THAT MONTH WITH
8 THE LAST DAYS IN THE MONTH. AND WE'RE IMPROVING ON A DAILY
9 BASIS. ANOTHER IMPORTANT FACTOR IS THE AVERAGE WAITING TIME IN
10 THE EMERGENCY ROOM. FOR THE ENTIRE MONTH, THE AVERAGE WAITING
11 TIME IS 10 HOURS, 10-1/2 HOURS APPROXIMATELY. BUT IN THE LAST
12 FEW DAYS OF NOVEMBER, AND ACTUALLY THIS LAST WEEK, THE WAITING
13 TIME HAS ACTUALLY GONE DOWN TO 6 TO 8 HOURS. THE LEFT WITHOUT
14 BEING SEEN HAS UNFORTUNATELY RISEN TO ABOUT 14 PERCENT LEFT
15 WITHOUT BEING SEEN. AGAIN, AS THE PATIENT FLOW IMPROVES, WE
16 EXPECT THAT NUMBER TO REDUCE. I'D LIKE TO MAKE A COUPLE OF
17 OTHER COMMENTS ABOUT THE CENSUS SPECIFICALLY. FOR EXAMPLE,
18 YESTERDAY, THE CENSUS WAS ACTUALLY 490 AT THE MED CENTER OUT
19 OF THE 600 BEDS. OF THE MED-SURG PATIENTS, WE ACTUALLY HAD OUT
20 OF 286 OUT OF 299 GENERAL MED-SURG BEDS FILLED, WHICH IS A 96
21 PERCENT OCCUPANCY, OR A 94 PERCENT UTILIZATION. WHERE WE ARE
22 SEEING OUR LACK OF CAPACITY IS IN VERY SPECIALTY UNITS, LIKE
23 BURN, JAIL, O.B., THE N.I.C.U. AND PEDIATRICS. THOSE BEDS ARE
24 VERY SPECIFIC FOR VERY SPECIFIC PATIENTS, AND A BED IS NOT A
25 BED IS NOT A BED IN THOSE PARTICULAR CASES. SO OUR OCCUPANCY
