**RECOMMENDATION TO ADOPT RESOLUTION APPROVING
ONLINE AUCTION SALE (2016B) OF TAX-DEFAULTED PROPERTY
SUBJECT TO THE TAX COLLECTOR'S POWER TO SELL
(ALL SUPERVISORIAL DISTRICTS) (3 VOTES)**

SUBJECT

Pursuant to Revenue and Taxation Code (R&TC) Sections 3694 and 3698, the Treasurer and Tax Collector (TTC) seeks approval to conduct an online auction of tax-defaulted properties on August 6 through August 9, 2016.

IT IS RECOMMENDED THAT THE BOARD:

Adopt the resolution approving the online auction (2016B) of tax-defaulted property subject to the Tax Collector's power to sell.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

Attached is a list of tax-defaulted properties consisting of 859 vacant parcels that: (1) have been tax defaulted for unpaid property taxes for three years or more; (2) are subject to the Tax Collector's power to sell; and (3) have been offered for sale at previous County auctions, at least one of which was an in-person auction. The TTC proposes to sell these properties at an online auction, pursuant to the R&TC.

Bid4Assets will conduct the online auction at www.bid4assets.com/losangeles, starting Saturday, August 6, 2016, at 3:00 p.m., (Pacific Time) and run it continuously until Tuesday, August 9, 2016, at 12:00 p.m., (Pacific Time). Pursuant to R&TC Section 3698.5(c), the TTC will offer each of these

parcels at a reduced minimum bid price of \$1,426, which covers the TTC costs and the Bid4Assets per parcel fee.

Pursuant to State law, the TTC has published the tax status of each property in the applicable local newspapers. The TTC will provide a list of properties on its website at ttc.lacounty.gov, and Bid4Assets will also provide a similar list on its website at www.bid4assets.com/losangeles. The TTC has also mailed a Notice of Auction to the assessee(s) of record of each property advising him and/or her of the redemption deadline, which is 5:00 p.m. on August 5, 2016.

Pursuant to R&TC Section 3700, the TTC must send a copy of the attached list to all taxing agencies that have the right to levy taxes or assessments within the County, as well as any nonprofits that have requested a copy of the list. Along with the list, the TTC will include information pertaining to the provisions of R&TC Sections 3695, 3695.4 and 3695.5, which describe the procedures for either preserving a lien through a tax sale or purchasing tax-defaulted properties for public use by Chapter 8 Agreement Sale.

On behalf of the TTC, Bid4Assets will (1) require a pre-registration deposit of \$5,000 from each registered bidder; (2) apply respective deposits toward the purchase of any auction item(s); and (3) return unused deposits by mail to the respective bidders within 30 calendar days of the auction.

Implementation of Strategic Plan Goals

Approval of this online auction is in accordance with the Countywide Strategic Plan Goals of Operational Effectiveness/Fiscal Sustainability. The purpose of selling tax-defaulted properties is to collect some or all of the delinquent taxes owed on these properties and to return the properties to a revenue-generating status.

Strategic Asset Management Principles Compliance

Not applicable.

FISCAL IMPACT/FINANCING

The online auction of tax-defaulted properties allows the TTC to collect some or all of the unpaid property taxes, penalties, and costs as provided under the R&TC.

The TTC has budgeted the necessary funds for the mailing of the Notice of Auction, which must be sent by certified mail to all known parties of interest, pursuant to R&TC Section 3701.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

Pursuant to R&TC Section 3361, the Tax Collector published a Notice of Impending Power and Intent to Sell, which included the tax-defaulted properties on the attached list. In order to comply with the statutes governing the publication process, the TTC advertised these properties in the approved adjudicated local newspaper with the highest circulation in the geographic area in which each respective property is located.



Auction List Number 2016B, and the establishment by the Treasurer and Tax Collector of minimum bids for properties pursuant to the Revenue and Taxation Code Section 3698.5(c).

The foregoing resolution was on the 3rd day of May 2016, adopted by the Board of Supervisors of the County of Los Angeles and ex-officio the governing body of all other special assessment and taxing districts, agencies and authorities for which said Board so acts.
