LOS ANGELES ECONOMIC DEVELOPMENT CORPORATION "88 CITIES OF LOS ANGELES COUNTY REPORT"

This memorandum is in response to the May 3, 2016, Board motion by Supervisors Solis and Knabe to:

1. Authorize the Los Angeles County Chief Executive Officer (CEO), or her designee, to analyze the Quarterly Census of Employment and Wages (QCEW) industry and employment data of the County of Los Angeles (County) from the California State Employment Development Department (EDD) for economic development purposes related to the development and implementation of an economic development strategic plan for the County.
2. Direct the CEO to negotiate and execute a data sharing agreement with EDD to examine the QCEW industry and employment data for the County.
3. Direct the CEO to enter into contracts for the purpose of evaluating the QCEW industry and employment data and providing reports in a format as directed by the CEO to create economic development strategies and to strengthen and support economic development initiatives using a data-driven process.

The motion was further amended to have the Los Angeles Economic Development Corporation (LAEDC) serve as the entity that transacts with private sector entities that may want to obtain the data, and report back to the Board when transactions take place.

LAEDC has completed the initial *88 Cities of Los Angeles County Report* by using the fully-disclosed establishment level employment and payroll data at the 6-digit North American Industry Classification System (NAICS) to conduct the initial research on jobs and industry employment in each of the 88 cities in the County, unincorporated areas, and each supervisorial district. This report provides a baseline of activity, including employment, wages, and establishments for each city and the unincorporated areas, classified by industry sector. A trend analysis was conducted to show the fastest growing industries, wage growth within industries and cities, and the distribution of businesses by employment size.

LAEDC proposes to continue working with the County to produce both quarterly and annual updates to the *88 Cities of Los Angeles County Report*, as well as analysis that helps to advance the development of the County's seven priority industry clusters. The key advantage to utilizing establishment level data comes from the ability to place establishments in the various areas of the County, which can be used to help identify the locations where each priority industry cluster is concentrated, and where its jobs are growing or declining. LAEDC is positioned to produce custom-tailored reports upon the County's request for *any* or *all* of the priority industry clusters that can be used by the County in instrumental ways as listed below:

First, **market** reports can be crafted to help attract new prospective businesses in each priority industry cluster by providing them with information about the areas within the County where businesses in their supply-chain are concentrated and growing. These areas can then strengthen and support the priority industry clusters. One positive externality that occurs when new firms establish near existing businesses within their supply-chain is that the need to transport goods and persons across the County is reduced, thus preventing new sources of traffic congestion.

Second, **land-use** reports can help the County understand the best uses of vacant parcels that are being considered for development. Each priority industry cluster utilizes a single type of structure or a mix of types of structures. For example, manufacturing establishments generally operate out of industrial structures while professional business services establishments generally operate out of office structures. The areas where an industry cluster is concentrated and growing will have a higher demand for the type of structures that they generally utilize.

Third, **workforce development** reports can help develop a more localized approach to workforce development efforts. Local workforce development boards would benefit by understanding which priority industry clusters are highly concentrated and growing within their service area to help train workers for high-growth, high-wage jobs that are in

demand and growing and are in close proximity to where they live. Limited workforce development resources can be allocated more efficiently.

Fourth, **policy recommendation** reports can also be used to analyze how recent policies or incentive programs impact job growth in the priority industry clusters within local areas of the County to drive analysis and possible adoption of such policies or incentive programs to other areas within the County. The purpose is to ensure that only the most effective and appropriate policies and incentive programs that have the greatest benefits to County residents will be adopted.

EXECUTIVE SUMMARY

The Los Angeles County Economic Development Corporation (LAEDC) has produced a first of its kind employment report for L.A. County including its 88 incorporated cities, 14 aggregations of unincorporated areas, and five supervisorial districts. This report helps identify the business footprint within the many parts of the County, as well as the unique trends that have developed over recent years. The data used for the report was provided in a disaggregated form by the California Employment Development Department (EDD) and processed, verified, and geocoded, by the LAEDC to produce employment counts, business establishment counts, and payrolls for each jurisdiction from 2008 to 2015.

This report includes employment profiles of all cities, groups of unincorporated neighborhoods, and supervisorial districts in Los Angeles County. Each jurisdiction has a one-page profile with information about employment, establishments, and payrolls categorized by industry, industry cluster, and size of business.

The employment profiles are followed by a series of summary tables that show where each jurisdiction ranks. A few key figures from the summary tables are provided below:

- Approximately 1.7 million people worked in the City of Los Angeles in 2015, nearly 40% of the County total. The cities of Long Beach, Burbank, Glendale, and Torrance all had over 100,000 workers in 2015.
- From 2008 to 2015, the cities that added the most jobs were Los Angeles (36,400), Burbank (11,400), Culver City (9,400), Santa Monica (7,700), and Glendale (6,300). The cities adding jobs at the fastest rates over the same period were Sierra Madre

(40.0%), Bellflower (36.6%), Maywood (27.6%), Rancho Palos Verdes (23.0%), and Compton (21.3%). Supervisorial District 2 (5.5%) contained the highest job growth over the period among supervisorial districts. Meanwhile, Supervisorial District 1 (-0.4%) had net negative job growth due mainly to cuts from the public sector which accounts for almost one-quarter of all jobs in the district. Excluding the public sector, Supervisorial District 1 had 14,300 more private sector jobs in 2015 than in 2008.

- The cities with the highest average annual wages in 2015 were El Segundo (\$117,000), Hidden Hills (\$104,500), Beverly Hills (\$92,300), Westlake Village (\$84,500), and La Cañada-Flintridge (\$84,000).
- The County contained 202,336 small business establishments in 2015, excluding firms with more than 100 employees in the county, public sector establishments, and establishments with only one in-home health care aide. An estimated 83,924 (41.5%) small business establishments were based in the City of Los Angeles. Other cities with a high count of small business establishments include Long Beach (6,079), Santa Monica (5,548), Beverly Hills (5,009), Glendale (4,810), and Pasadena (4,797).

The employment, establishment, and payroll information provided in this report can be used to create economic development strategies and can help strengthen and support economic development initiatives. The report begins with the methodology that introduces the analysis process, then segues into employment profiles for Los Angeles County and each of the 88 cities, 14 aggregations of unincorporated areas, and five supervisorial districts.

INTRODUCTION AND METHODOLOGY

INTRODUCTION

Los Angeles County, a vast expanse of demographic and economic diversity, encompasses more than four thousand square miles with a rich tapestry of amenities, including beaches, national forests, the San Gabriel Mountains, Catalina Island, the Mojave Desert and numerous tourist destinations such as museums, theaters, sports venues and theme parks.

The most populous county in the nation, Los Angeles County is home to 10.2 million residents and boasts a labor force of over 5.1 million workers. With dense urban areas and suburban bedroom communities, the county has a diverse population that possesses a wide range of skills, as well as a varied industry base. With 88 incorporated cities and 122 unincorporated neighborhoods, its diversity cannot be fully represented using high-level data that reflect the overall County experience, which does not provide the nuanced detail that regional leaders and stakeholders need in order to adequately inform their decision-making.

This report, the first of its kind, is intended to fill in the gap in knowledge about the jobs and industries that are present within each individual jurisdiction in Los Angeles County, and how they have changed over time.

Most cities in the County have seen shifts in the nature of their industry base as they recover from lingering effects of the Great Recession. Those that are home to the flourishing industries of health care and leisure and hospitality have seen greater job growth than

cities with industries that have been more challenged, such as manufacturing. The ability of industries to produce high wages and wage growth also differ substantially across cities.

This report offers a comprehensive analysis of the jobs and industries within each city and unincorporated area to highlight these important differences to guide economic development strategies and support economic development initiatives.

The report begins with the methodology used to produce the tabulations. Next is the profile page for Los Angeles County and describes the data and variables shown. This can therein be used as a key for the profiles of all other jurisdictions that follow—incorporated cities, aggregated unincorporated areas and supervisory districts.

The last section of the report provides a number of summary tables ranking the cities and regions in terms of such variables as employment levels, the number of jobs added since 2008, job percentage growth, annual average wages and the number of small business establishments in 2015 as well as the net change since 2008.

The descriptions of industry sectors, industry combinations and industry clusters are provided in the Appendix.

This report uses establishment-level data from the joint efforts of the California Employment Development Department (EDD) and the Bureau of Labor Statistics (BLS) provided in the Quarterly Census of Employment and Wages (QCEW) program. Each quarter, this program tabulates employment and wages of establishments that report to unemployment insurance programs in the nation. Approximately 97 percent of all wage and salary civilian employment in the nation is represented in this program, according to the EDD and BLS.

The data excludes self-employed workers, most agricultural workers, members of the military, railroad employees, student workers and select nonprofits (such as religious organizations).

The EDD provided establishment-level data for all quarters from 2008Q1 through 2015Q4 under a confidentiality agreement.

MEASURES TO PROTECT CONFIDENTIALITY

The data used in this report was carefully aggregated within each city and region to comply with confidentiality requirements so that the identity of individual employers and their employment and wage data is protected.

The BLS publishes aggregated QCEW data for every county and state in the U.S. The data is often available at the detailed industry level. However, to protect the confidentiality of firms reporting their employment and wages, some data is not publicly disclosed. The establishment-level data provided by the EDD contains no such suppressions. However, all statistics and tabulations produced using this fully-disclosed data, such as those found in this report, must similarly adhere to the confidentiality protections afforded to all establishments by the EDD and BLS.

To ensure that individual establishment data is not identifiable in any of the reporting herein, data is aggregated when needed to comply with the EDD and BLS's established "80/3" guidelines. These guidelines call for data to be aggregated to a level where there are no fewer than three establishments in an industry for any given geography, and where a single firm cannot account for more than 80 percent of employment in an industry for the given geography.

Where preliminary data tabulations appear to violate these guidelines, the data are aggregated into larger industry groupings, sub-sectors or sectors in order to maintain confidentiality. When aggregation to a higher level to maintain confidentiality is not possible within a given geography, the data is suppressed. This is denoted by "S" in the tabulations on the employment profile pages.

Due to disclosure issues, industry-level detail is not possible for the following cities: Bradbury, Hidden Hills, La Habra Heights and Rolling Hills.

INDUSTRY CLASSIFICATION

Each establishment is classified by the EDD and BLS according to the industry it operates in using the North American Industry Classification System (NAICS). Each record was carefully reviewed to ensure consistency across time. Establishments which had not yet been classified by the EDD and BLS, such as newly-formed firms, were researched to the extent possible to identify their classification. The Census Bureau revises NAICS industry definitions every five years. In this report, that would include revisions made in 2007 and 2012. Establishment records prior to these changes were revised to reflect the prevailing industry classification system.

ABOUT INDUSTRY CLUSTERS

An industry cluster is a group of industries that generally work together to produce final goods and services. Clusters are geographic concentrations of firms, suppliers, support services, and infrastructure. For example, the local real estate, construction, and development industry cluster includes firms in various construction industries, such as specialty trade contractors, as well as service industries such as appraisers and property managers.

The industry clusters in this report are defined by the U.S. Cluster Mapping Project (www.clustermapping.us).

DEFINING BUSINESS ESTABLISHMENTS

The EDD and BLS define an establishment as an economic unit, typically operating at a single physical location. This report tabulates data for establishments with at least one employee (with the exception of one industry as noted below). These are further categorized by size based on the number of employees they have on payroll. **Large business establishments** are those that are part of a firm employing more than 500 workers throughout the County, while **Midsize business establishments** are those that are part of a firm employing between 100 workers and 500 workers throughout the County. Many large grocery chains, automobile dealerships, and manufacturing plants are part of these categories.

Small business establishments are those with fewer than 100 workers in the county. Counts of small business establishments under the 100 worker threshold align with the County's Local Small Business Enterprise (LBSE) certification program, with the exception that various parameters can not be measured using the QCEW database, including the verification that businesses are independently owned and operated or that businesses have their main office in Los Angeles County for the last twelve months.

Since employment at many establishments fluctuate from quarter

to quarter, firm and establishment size are based on the average number of employees from 2008Q1 to 2015Q4, excluding any quarter in which the establishment was inactive and did not report payroll data to the EDD.

Business establishment counts exclude single-employee establishments classified under NAICS 624120 (Services for the Elderly and Persons with Disabilities). Such single-employee establishments are typically in-home health care aides receiving payment for social assistance services to persons residing in their own homes. While these establishments are not included in establishment counts, their data is included in employee and wage tabulations.

UNINCORPORATED AREAS

Establishment-level data identifies the city where each establishment is located—when the establishment is located within the borders of an incorporated city. However, there are 122 unincorporated areas throughout the County that, according to the Los Angeles County Department of Regional Planning (LADRP), account for approximately two-thirds of the County as well as one-tenth of the population. The County identifies these unincorporated areas (many of which are quite small) for purposes of reporting to the Board of Supervisors, who oversee these unincorporated areas.

Fourteen aggregations of unincorporated areas have been generated to provide complete analysis of all geographic regions in the County. The borders of these aggregated unincorporated areas fall within individual supervisorial districts. The selection of unincorporated areas to include in the aggregations was based on proximity, size, and supervisorial district.

The following section provides an example of how each employment file is structured using the data tabulated for all of Los Angeles County.



ANNUAL EMPLOYMENT GROWTH









EMPLOYMENT PROFILE

The *Employment Profile* table provides summary statistics of the region:

- ▶ Total employment in Los Angeles County was almost 4.24 million in 2015. This was 1.8 percent higher than employment in 2008.
- ▶ The average annual wage paid to all employees in the County was \$57,368, and increase of 13.8 percent over 2008 (in nominal terms).
- ▶ There were 232,071 business establishments in 2015, which was an increase of 15,024 over 2008.
- ▶ Of these, 202,336 were small business establishments with fewer than 100 employees.
- ▶ In 2015, Video Production and Distribution was the most competitive industry cluster in Los Angeles County as measured by its employment location quotient (LQ) of 14.9 relative to the nation.
 - The *location quotient* shows the percentage of total employment in that industry compared to the average percentage nationwide. In this case, employment in Video Production and Distribution accounts for a larger share of overall employment in Los Angeles County than it does across the nation by a factor of 14.9. The threshold to demonstrate specialization (and competitiveness) is a location quotient of at least 1.2.

ANNUAL EMPLOYMENT GROWTH

The *Annual Employment Growth* chart shows the trend in employment in the region from 2008 to 2015 compared to the rest of Los Angeles County:

- ▶ Employment in Los Angeles County grew by 1.8 percent from 2008 to 2015.
- ▶ Although employment fell by approximately 8 percent between 2008 and 2010, employment thereafter reversed course and has been growing since.

ESTABLISHMENTS BY SIZE (2015)

The *Establishments by Size* table provides a tabulation of business establishments in the region and highlights those that are classified as small businesses (i.e., those with fewer than 100 employees):

- ▶ A majority of business establishments in Los Angeles County in 2015 have less than 25 employees (189,325 establishments).
- ▶ At the most granular industry classification permitted, Offices of Physicians (8,381 establishments) was the largest in terms of small business count in 2015, followed by Full-Service Restaurants (6,496 establishments).
 - A description of the industries appearing in this table can be found in Appendix Exhibit A3.
- ▶ In 2015, there were 12,988 business establishments in Los Angeles County with 100 to 499 employees and 16,747 businesses with 500 employees or more.

EMPLOYMENT BY INDUSTRY (2015)

The *Employment by Industry* chart shows the distribution of jobs by industry sector in 2015, and the share of overall employment:

- ▶ Health Care was the largest industry in Los Angeles County in 2015, accounting for 14.9 percent of all employment in the county.
- ▶ The Health Care sector has an employment location quotient of 1.1, which implies that this is not a competitive industry compared to the national average. However, note that local-serving sectors, such as Health Care, generally have location quotients close to 1.
- ▶ The Information sector held a 2.4 employment location quotient in 2015 (compared to the nation) because of the county's unparalleled mix of entertainment, media, and technology.

To maintain confidentiality of employers reporting this data, in some instances industry sectors have been combined.

- A description of the industry sectors appearing in this chart can be found in Appendix Exhibit A1.
- A description of industry combinations, if these are included in this chart, can be found in Appendix Exhibit A2.

AVERAGE ANNUAL WAGES (2015)

The *Average Annual Wages* chart show the average annual wage of all employees within each industry sector (or industry combination) regardless of job title or function, including both full-time and part-time employees:

- ▶ The highest average annual wage in 2015 was \$110,724 paid in the Information sector, followed by \$100,162 in the Arts and Entertainment sector.
- ▶ At the other end of the spectrum, average annual wages remain relatively low in service-oriented sectors such as Hospitality and Retail Trade. Many workers in these industry sectors are employed part-time.

The bars in this chart are color-coded to match the same sector pie wedges of the Employment by Industry chart.

JOB GROWTH (2008 TO 2015)

The *Job Growth* chart shows the number of net jobs added or lost by industry sector between 2008 and 2015:

- ▶ Overall, the County added 76,700 jobs across all industry sectors between 2008 and 2015.
- ▶ In Los Angeles County, the Health Care sector added 119,710 jobs since 2008, more than any other sector.
- ▶ Manufacturing jobs declined by 79,910 in the same period.

The bars in this chart are color-coded to match the same sector pie wedges of the Employment by Industry chart and the same sector bars in the Average Annual Wages chart.

STRONGEST INDUSTRY CLUSTERS (2015)

The ***Strongest Industry Clusters*** table shows the top two industry clusters in terms of location quotient:

- ▶ The top two industry clusters in Los Angeles County were Video Production and Distribution industry cluster, with an employment LQ of 14.9, and Apparel, with a LQ of 9.1.

To maintain confidentiality, in some instances the data in this table has been suppressed.

- These entries are denoted by “S.”
- While the data may be suppressed, all the industry clusters shown in this table employ more than 75 employees and account for more than 1 percent of the region’s overall employment.

A list of all industry clusters in Los Angeles County is can be found in Appendix Exhibit A4.

Throughout the remainder of the report, charts and tables are structured in this format to show the variety of employment trends, industry composition, industry cluster concentration and small business activity across Los Angeles County.









JOB GROWTH (2008 TO 2015)











JOB GROWTH (2008 TO 2015)

















































Piece Goods Merchant Whls.	424310	This industry comprises establishments primarily engaged in the merchant wholesale distribution of piece goods, fabrics, knitting yarns (except industrial), thread and other notions, and/or hair accessories.
Real Estate Agents and Brokers	531210	This industry comprises establishments primarily engaged in acting as agents and/or brokers in one or more of the following: (1) selling real estate for others; (2) buying real estate for others; and (3) renting real estate for others.
Recreational Goods Rental	532292	This U.S. industry comprises establishments primarily engaged in renting recreational goods, such as bicycles, canoes, motorcycles, skis, sailboats, beach chairs, and beach umbrellas.
Residential Electrical Contractors	238211	This industry comprises establishments primarily engaged in installing and servicing electrical wiring and equipment. Contractors included in this industry may include both the parts and labor when performing work. These contractors may perform new work, additions, alterations, maintenance, and repairs.
Residential Plumbing and Hvac Contractors	238221	This industry comprises establishments primarily engaged in installing and servicing plumbing, heating, and air conditioning equipment. Contractors in this industry may provide both parts and labor when performing work. The work performed may include new work, additions, alterations, maintenance, and repairs.
Residential Property Managers	531311	This U.S. industry comprises establishments primarily engaged in managing residential real estate for others.
Residential Remodelers	236118	This U.S. industry comprises establishments primarily responsible for the remodeling construction (including additions, alterations, reconstruction, maintenance, and repair work) of houses and other residential buildings, single-family, and multifamily. Included in this industry are remodeling general contractors, for-sale remodelers, remodeling design-build firms, and remodeling project construction management firms.
Supermarkets and Other Grocery Stores	445110	This industry comprises establishments generally known as supermarkets and grocery stores primarily engaged in retailing a general line of food, such as canned and frozen foods; fresh fruits and vegetables; and fresh and prepared meats, fish, and poultry. Basic knowledge of tax law and filing requirements is required.
Travel Agencies	561510	This industry comprises establishments primarily engaged in acting as agents in selling travel, tour, and accommodation services to the general public and commercial clients.
Wholesale Agents and Brokers	425120	This industry comprises wholesale trade agents and brokers acting on behalf of buyers or sellers in the wholesale distribution of goods. Agents and brokers do not take title to the goods being sold but rather receive a commission or fee for their service. Agents and brokers for all durable and nondurable goods are included in this industry.
Women & Child. Clothing Whls.	424330	This industry comprises establishments primarily engaged in the merchant wholesale distribution of (1) women's, children's, infants', and/or unisex clothing and accessories and/or (2) fur clothing.
Women's, Girls', Infants' Cut-Sew Apparel Mfg	315240	This industry comprises establishments primarily engaged in manufacturing women's, girls', and infants' apparel from purchased fabric. Women's, girls', and infants' clothing jobbers, who perform entrepreneurial functions involved in apparel manufacture, including buying raw materials, designing and preparing samples, arranging for apparel to be made from their materials, and marketing finished apparel, are included.
