



- Comprehensive Education Reform Committee (CERC)
  - Quarterly report to the Board of Supervisors (BOS)
    - Continuous quarterly review of 35 recommendations by Probation and LACOE.
  - Redesign of CERC report
- Examples of reforms initiated by CERC
  - Road to Success Academy (RTSA)
  - Individualized Learning Plan (ILP)




