REPORT BACK ON PILOT PROGRAM WITH SPAY-4-LA TO PROVIDE LOW-COST SPAY/NEUTER SERVICES IN HARD TO REACH AREAS OF THE COUNTY FOR A MAXIMUM ONE-YEAR PERIOD (ITEM NO. 6, AGENDA OF JULY 5, 2016)

Background

On July 5, 2016, a motion by Supervisor Antonovich instructed the Director of Animal Care and Control to enter into an agreement with SPAY-4-LA to conduct a pilot program to provide low-cost spay/neuter services in hard-to-reach areas of the County for a maximum period of one year, at an amount not to exceed \$300,000 in County costs and report back to the Board quarterly during the contract term on the spay/neuter services being provided.

Accomplishments

The agreement was signed on July 28, 2016, and the pilot program went into operation effect on August 1, 2016. This enables the Department to provide two full months of data for evaluation.

SPAY-4-LA services are provided via a 33-foot-long mobile clinic that was deployed at a variety of locations in order to enhance convenience for the client and maximize participation in the program.

During the month of August, SPAY-4-LA performed a total of 133 sterilization surgeries, including 87 dogs and 46 cats.

During the month of September, SPAY-4-LA performed a total of 215 sterilization surgeries, including 131 dogs and 84 cats. This yields a two-month total of 348 animals sterilized, many of which would not have been altered, but for the presence of the clinic in the various communities.

Surgeries were performed at a variety of locations in the communities served by the Department, but residents who live in the unincorporated area or cities serviced by the Department are free to utilize the services of SPAY-4-LA at any location where they set up, including in the City of Los Angeles. This flexibility provides additional convenience for the client and promotes the goal of maximum participation. SPAY-4-LA does track client residence data to ensure that information needed to evaluate the effectiveness of the program is accurately captured.

During the first two months of this program, the mobile clinic has been deployed to the following County-specific locations:

Additional County-specific locations are planned, including in the Antelope Valley, Carson, and Athens Park (12603 South Broadway, Los Angeles 90061), beginning in November.

Contract costs incurred for SPAY-4-LA services provided during this two-month period total \$34,476 (\$13,353 in August and \$21,123 in September). However, the County

only pays *half* of these costs. According to the terms of the agreement, the above costs are divided equally between the County and the Coalition for Pets and Public Safety. The expenditures for the County total \$17,238.

This yields a net average cost of \$52.50 per sterilization surgery (half of the contracted \$117 for dogs and \$69 for cats). By comparison a conservative cost range of a sterilization surgery for a dog in Los Angeles County is between \$100 and \$400; and for a cat it is from \$50 to \$200 (depending on sex, size, and other factors). Even these costs need to be examined through the lens of the overall purpose of the agreement. Absent the presence of the mobile clinic in the various communities we are serving through this program, a high percentage of those animals would not have been sterilized. The benefits of this program extend beyond the prevention of unwanted offspring from 348 animals, and include the awareness that the high visibility of the mobile clinic in the community brings. It is that awareness that creates exponential returns.

Conclusion

While it is too soon to draw conclusions on the overall effectiveness of this program, the initial data does show a significant return on investment.

Background

On July 5, 2016, a motion by Supervisor Antonovich instructed the Director of Animal Care and Control (Department) to enter into an agreement with SPAY-4-LA to conduct a pilot program to provide low-cost spay/neuter services in hard-to-reach areas of the County for a maximum period of one year, at an amount not to exceed \$300,000 in County costs and report back to the Board quarterly during the contract term on the spay/neuter services being provided.

Accomplishments

The agreement was signed on July 28, 2016, and the pilot program went into operation effect on August 1, 2016. This is the Department's second quarterly report with data for evaluation.

SPAY-4-LA services are provided via a 33-foot-long mobile clinic that is deployed at a variety of locations in order to enhance convenience for customers and maximize participation in the program.

During the month of October, SPAY-4-LA performed a total of 306 sterilization surgeries, including 152 dogs and 154 cats.

During the month of November, SPAY-4-LA performed a total of 211 sterilization surgeries, including 108 dogs and 103 cats.

During the month of December, SPAY-4-LA performed a total of 223 sterilization surgeries, including 130 dogs and 93 cats. This yields a quarterly total of 740 animals sterilized, many of which would not have been altered, but for the presence of the clinic in the various communities.

These numbers represent a significant increase of over 41 percent per month from the 348 surgeries performed during the first two months of the program.

Surgeries were performed at a variety of locations in the communities served by the Department, but residents who live in the unincorporated area or cities serviced by the Department are free to utilize the services of SPAY-4-LA at any location where they set up, including in the City of Los Angeles. This flexibility provides additional convenience for the customer and promotes the goal of maximum participation. SPAY-4-LA does track customer residence data to ensure that information needed to evaluate the effectiveness of the program is accurately captured.

Contract costs incurred for SPAY-4-LA services provided during this quarter total \$69,780 (\$28,410 in October, \$19,743 in November, and \$21,627 in December). However, the County only pays *half* of these costs. Per the terms of the agreement, the above costs are divided equally between the County and the Coalition for Pets and Public Safety. The expenditures for the County total \$34,890.

This yields a net average cost of \$47.15 per sterilization surgery (half of the contracted \$117 for dogs and \$69 for cats). By comparison a conservative cost range of a sterilization surgery for a dog in Los Angeles County is between \$100 and \$400; and for a cat it is from \$50 to \$200 (depending on sex, size, and other factors).

Even these costs need to be examined through the lens of the overall purpose of the agreement. Absent the presence of the mobile clinic in the various communities we are serving through this program, a high percentage of those animals would not have been sterilized. The benefits of this program extend beyond the prevention of unwanted offspring from 740 animals, and include the awareness that the high visibility of the mobile clinic in the community brings. It is that awareness that creates exponential returns.

Conclusion

The full return on investment will only be visible years after the termination of the program, with lower numbers of unwanted animals and the reduction of associated costs. But even the currently available data shows a positive immediate impact on the community and a substantial return on investment. The increase in numbers of realized in this second quarter also indicates greater community awareness and interest in this cost-saving and life-saving endeavor.

Accomplishments

The agreement was signed on July 28, 2016, and the pilot program went into operation effective on August 1, 2016. This is the Department's final report on the effectiveness of the program, with data for evaluation.

SPAY-4-LA services are provided via a 33-inch-long mobile clinic that is deployed at a variety of locations in order to enhance convenience for customers and maximize participation in the program. The costs to be divided equally between the Department and Coalition for Pets and Public Safety (CoPPS).

During the last months of the contract period, the breakdown of surgeries is as follows:

During the month of April, SPAY-4-LA performed a total of 401 sterilization surgeries, including 279 dogs and 122 cats.

During the month of May, SPAY-4-LA performed a total of 368 sterilization surgeries, including 253 dogs and 115 cats.

During the month of June, SPAY-4-LA performed a total of 430 sterilization surgeries, including 213 dogs and 217 cats.

On May 23, 2017, an approved subcontractor (Simi Valley Nonprofit Spay and Neuter Clinic, Inc.) began providing services in support of SPAY-4-LA's efforts. They performed 453 sterilization surgeries, including 59 dogs and 48 cats in May, as well as 157 dogs and 189 cats in June.

This yields a quarterly total of 1,652 animals sterilized.

Additionally, the contract continued through July 27, 2017. During the month of July, a combined total of 643 sterilization surgeries, including 302 dogs and 341 cats, were performed.

Total sterilization surgeries for the entirety of the one-year program are 4,507 surgeries, including 2,563 dogs and 1,944 cats.

Surgeries were performed at a variety of locations in the communities served by the Department, but residents who live in the unincorporated area or cities serviced by the Department are free to utilize the services of SPAY-4-LA or Simi Valley Nonprofit Spay and Neuter Clinic at any location where they set up, including in the City of Los Angeles. This flexibility provides additional convenience for the customer and promotes the goal of maximum participation. Customer residence data is captured to ensure that information needed to evaluate the effectiveness of the program is accurate.

Contract costs to the County incurred for sterilization services are \$20,530.50 in April, \$23,934 in May, \$35,410.50 in June, and \$18,431.50 in July.

The total of expenditures for the year-long pilot program is \$205,820.50, to perform a total of 4,507 surgeries, including 2,563 dogs and 1,944 cats.

The average cost to the County of \$45.67 per sterilization surgery (half of the contracted \$117 for dogs and \$69 for cats) is far lower than even the most conservative cost range. Sterilization surgery for a dog in Los Angeles County is between \$100 and \$400; and for a cat it is from \$50 to \$200 (depending on sex, size, and other factors).

Absent the presence of and work done by the mobile clinic in the various communities served through this program, a high percentage of those animals would not have been sterilized. The benefits of this program extend beyond the prevention of unwanted offspring from these individual animals and include the awareness that the high visibility of the mobile clinic in the community brings. That awareness creates exponential returns.

Conclusion

The full return on investment will only be visible in years to come, with lower numbers of unwanted animals and the reduction of related costs. But, the data shows a positive immediate impact on the community, and a substantial return on investment. The continuation of this program will be a valuable asset to the County and the communities we serve.
