#### HOUSING ALLOWANCE REIMBURSEMENT FOR INTERIM PROBATION OFFICER (UC) (ALL SUPERVISORIAL DISTRICTS) (3 VOTES)

## **SUBJECT**

Recommendation to approve temporary housing expenses for Calvin Remington as Interim Probation Officer (UC) for the County of Los Angeles.

# IT IS RECOMMENDED THAT THE BOARD:

Approve reimbursement of up to \$5,000 for temporary housing costs for Mr. Remington.

# PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

On January 12, 2016, the Board appointed Calvin Remington to serve as Interim Probation Officer (UC) following the resignation of the previous Probation Officer (UC), Jerry Powers. The intent of this appointment was to ensure the duties and responsibilities of this critical position were carried out without interruption while the County searched for a permanent replacement for this position.

In addition to the appointment, the Board approved the reimbursement of up to \$25,000 for reasonable actual costs of relocating Mr. Remington to the Los Angeles County area and for the reimbursement of temporary housing rental costs. Due to an extended recruitment period and to aid with the transition of the newly appointed Probation Officer (UC), Terri McDonald, it is recommended that the Board increase the reimbursement authorization by an additional \$5,000 which will allow Mr. Remington to continue serving the County through the end of January 2017.

Reimbursement of temporary housing costs is appropriate for an Interim Probation Officer during a transition period.

Implementation of these recommendations will provide continuity in leadership for the Probation Department.
