Communications Plan for Homeless Ballot Measure

On February 9 and 23, 2016, the Board of Supervisors (Board) directed the Chief Executive Officer (CEO) to work in collaboration with the Board to identify potential ballot measures to generate ongoing revenue and sustain the Homeless Initiative strategies approved by the Board on February 9, 2016. In response to those instructions, the CEO identified several potential options, secured an expert consultant to conduct polling, and reported to the Board on multiple occasions.

On December 6, 2016, the Board voted to submit a one-quarter cent special sales tax measure to the voters on the March 7, 2017 ballot. Given this action, it is appropriate for the County to ensure that voters are informed through a fair presentation of facts about the sales tax measure.

WE THEREFORE MOVE THAT THE BOARD OF SUPERVISORS:

1. Direct the Chief Executive Officer (CEO) to work with County Counsel, other County departments, Los Angeles Homeless Services Authority, and United Way of Greater Los Angeles to develop a communications plan and execute contracts as needed to inform communities, through a fair presentation of facts, about the March 2017 special sales tax measure approved by the Board on December 6, 2016 and its potential impact on the homeless crisis in Los Angeles County; and
