“On January 6, 2004, the Board approved a reward offer of \$10,000 for information leading to the arrest and conviction of the person or persons responsible for the hit-and-run accident of 12-year-old Brandon Martin at the intersection of Lake Manor Drive and Thompson Avenue in the unincorporated area of Chatsworth. The reward offer expires on April 5, 2004.”

**NOTICE OF \$10,000 REWARD
OFFERED BY THE

Notice is hereby given that the Board of Supervisors of the County of Los Angeles has extended the \$10,000 reward offer for any information leading to the arrest and conviction of the person or persons for the hit-and-run accident which seriously injured 12-year-old Brandon Martin at the intersection of Lake Manor Drive and Thompson Avenue, in the unincorporated area of Chatsworth, on Friday, December 19, 2003 at approximately 5:50 p.m.

Any person having any information related to this crime is requested to call Investigator Gary Bladow or Investigator Charles Jensen of the California Highway Patrol, West Valley Area Office at (818) 888-0980 and refer to Report No. 2003-120291.

The terms of the reward provide that:

- The information given that leads to the determination of the identity, the apprehension and conviction of any person or persons must be given no later than July 4, 2004. All reward claims must be in writing and shall be received no later than September 2, 2004.
- The total County payment of any and all rewards shall in no event exceed \$10,000 and no claim shall be paid prior to conviction unless the Board of Supervisors makes a finding of impossibility of conviction due to the death or incapacity of the person or persons responsible for the crime or crimes.
- The County reward may be apportioned between various persons and/or paid for the conviction of various persons as the circumstances fairly dictate.

Any claims for the reward funds should be filed no later than September 2, 2004 with the Executive Officer of the Board of Supervisors, 500 West Temple Street, Room 383 Kenneth Hahn Hall of Administration, Los Angeles, California 90012, Attention: Brandon Martin Reward Fund.
