The County of Los Angeles, in partnership with the City of Los Angeles, the LAC+USC Medical Center, the Violence Intervention Program (i.e., Forensic and Community-Based Treatment and Assessment Center (CATC) Clinics) and additional community-based organizations, is opening a new Family Justice Center on the LAC+USC Medical Center campus (Center). The Center is a unique partnership and provides a multi-disciplinary approach for responding to child and elder abuse, children in foster care, commercial sexual exploitation of children, transitional age youth, youth exiting the juvenile justice system, and those affected by domestic, sexual and interpersonal violence. The Center will be one of over 80 Family Justice Centers in the country and the second one in Los Angeles County. The stakeholders will include representatives from various disciplines including Health, Mental Health, Public Health, Children and Family Services, law enforcement, and the District Attorney's office.

The County will contribute to the effort by providing for the gratis use of approximately Four Thousand Seven Hundred and Fifty (4,750) square feet of licensed space on a portion of the 2nd floor of the General Laboratory Building on the LAC+USC Medical Campus (Property), allowing the Los Angeles City Police Department (LAPD) and their staff members to receive and interview victims and their families. The integration of LAPD services into a medical and mental health model program will help provide residents of Los Angeles County with access to the best assessment and investigative services at the same time that their health and mental health needs are addressed. Pursuant to Government Code section 26227, the Board has the authority to make

available real property not needed for County purposes to public agencies for operation of programs which serve public purposes and are necessary to meet the social needs of the population of the County.

WE, THEREFORE, MOVE THAT THE BOARD OF SUPERVISORS:

- 1. Find that the Property is not currently needed for County purposes.
- 2. Find that the services to be provided by LAPD are necessary to meet social needs of the County and serve public purposes which benefit the County.
- 3. Find that the proposed granting of a gratis license agreement to City of Los Angeles is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15301 of the State CEQA Guidelines (Existing Facilities) and Class 1 of the County's Environmental Document Reporting Procedures and Guidelines.
- 4. Authorize the Chief Executive Officer or her designee to negotiate on a gratis basis with the City of Los Angeles a three (3) year License Agreement with an option to renew for two (2) additional years. Authorize the Chief Executive Officer or her designee to execute the License Agreement and other ancillary documentation approved as to form by County Counsel necessary to effectuate the License Agreement, and to take any other actions necessary and appropriate to implement and effectuate the License Agreement.
