# APPROVAL OF AMENDMENTS TO THE PROPOSITION A HOUSEKEEPING SERVICES AGREEMENTS WITH SODEXO AMERICA, LLC AND SERVICON SYSTEMS, INC. TO EXTEND THE CONTRACT TERM (ALL SUPERVISORIAL DISTRICTS) (3 VOTES)

# **SUBJECT**

Request approval of Amendments to the existing Proposition A Housekeeping Services Agreements for Groups 1 and 3 with Sodexo America, LLC and Groups 2 and 4 with Servicon Systems, Inc. to extend the terms of each Agreement through February 28, 2019; modify the Statements of Work; and increase each Agreement's maximum obligation.

# IT IS RECOMMENDED THAT THE BOARD:

- 1. Make a finding pursuant to Los Angeles County Code Section 2.121.420 that the continued provision of housekeeping services, as described herein, continue to be performed more economically by independent contractors.
- 2. Approve and Instruct the Chairman of the Board (Chairman) to sign Amendment Number 10 (Exhibit I), to Proposition A (Prop A) Agreement Number 77855 with Sodexo America, LLC (Sodexo), for the provision of Housekeeping Services for Groups 1 and 3 as shown on Attachment A, effective upon Board approval to: (i) extend the term of the Agreement for the period of October 30, 2017 through February 28, 2019; (ii) add additional housekeeping services at Harbor UCLA Medical Center; (iii) increase the maximum obligation by \$23,155,291 to pay for the upcoming Living Wage rate increases as well as the housekeeping services for the period of October 30, 2017 through February 28, 2019, and (iv) increase the contingency

> fund of the Agreement to fifteen percent (15%) of the maximum obligation for the extension period, or \$3,473,294, to allow for additional housekeeping services due to unforeseen/emergent circumstances and to allow flexibility to quickly provide additional housekeeping services that may be required as new buildings are opened or closed down.

- 3. Approve and Instruct the Chairman to sign the attached Amendment Number 11 (Exhibit II), to Prop A Agreement Number 77529 with Servicon Systems, Inc. (Servicon), for the provision of Housekeeping Services for Groups 2 and 4 as shown on Attachment A, effective upon Board approval to: (i) extend the term of the Agreement for the period of December 1, 2017 through February 28, 2019; (ii) increase the maximum obligation by \$4,214,889, to pay for the upcoming Living Wage rate increases as well as the housekeeping services for the extension period; and (iii) increase the contingency fund of each Agreement to 15% of the maximum obligation for the extension period, or \$632,234, to allow for additional housekeeping services due to unforeseen/emergent circumstances and to allow flexibility to quickly provide additional housekeeping services that may be required as new buildings are opened or closed down.
- 4. Delegate authority to the Director of Health Services (Director), or his designee, to execute future amendments to Agreements Number 77855 and 77529 to: (i) add, delete and/or change non-substantive terms and conditions in the Agreements; and (ii) add and/or remove facilities and/or space identified in the Agreements, and approve necessary changes to the scope of services with the total cost of any additional services not to exceed the amount of each Agreement's contingency fund; with such amendments subject to prior review and approval by County Counsel.

# PURPOSE/JUSTIFICATION OF RECOMMENDED ACTIONS

# Recommendations

Approval of the first recommendation is necessary to comply with Los Angeles County Code Section 2.121.420. The Cost Analysis for Housekeeping Services was prepared in accordance with Auditor-Controller guidelines and methodologies. Contracting under Prop A requirements has been determined to be cost-effective for the provision of Housekeeping Services by DHS and the Auditor-Controller (A-C). Attachment B provides the cost analysis for the extension periods. For Agreement Number 77855, the cost savings is approximately \$5,216,268, a savings of 18.39 percent. For Agreement Number 77529, the cost savings is approximately \$1,226,514, a savings of 22.54 percent.

Sodexo - Agreement Number 77855

Approval of the second recommendation will allow the Chairman to execute Amendment Number 10 to Agreement Number 77855 with Sodexo for Housekeeping Services for Groups 1 and 3 to extend the term of the Agreement for the period October 30, 2017 through February 28, 2019 and with a maximum obligation of \$23,155,291 for that period. The current Agreement expires October 29, 2017.

In addition to the fixed monthly rate for providing Housekeeping Services for all covered facilities, the current Agreement has provisions for contingency funds of 10% of the annual maximum obligation to cover the cost of housekeeping services due to unforeseen and/or emergent circumstances such as clean up form broken water pipes. The contingency funds are also used if additional housekeeping services are needed due to changes in the amount of space covered by the contractor. Under authority previously delegated by the Board for use of these contingency funds, DHS purchased additional housekeeping services for Harbor-UCLA Medical Center (H-UCLA MC) MFI Buildings and LA BioMed Buildings on an interim basis. The space was previously occupied by LA BioMed staff and LA BioMed was financially responsible for the associated housekeeping services. As part of the implementation of the H-UCLA MC Master Plan, LA BioMed staff were relocated and the buildings are now occupied by County staff. Therefore, H-UCLA MC is financially responsible for the housekeeping services at those locations.

When the Agreement was initially executed H-UCLA MC remained financially responsible for purchasing the cleaning and sanitation supplies used by Sodexo at the facility. Sodexo was contractually responsible for purchasing all cleaning and sanitation supplies for use at all other facilities in the Agreement. Subsequently it was determined to be more financially and operationally viable to have Sodexo also purchase these supplies for use at H-UCLA MC. Under the current Agreement, H-UCLA MC's cleaning/sanitation supplies have been purchased by Sodexo using the Agreement's contingency fund. Pursuant to the recommended Amendment, Sodexo will purchase supplies for H-UCLA MC on a permanent basis as is the case for the other facilities.

The recommended Amendment increases the maximum obligation of the Agreement to cover these ongoing costs instead of continuing to use the contingency funds and also includes the cost of the upcoming increases due to new Living Wage Rates during the extension period. In addition, due to the anticipated changes to the H-UCLA MC campus as a result of construction and other activities as well as possible emergency, the contingency fund amount is being increased to 15%.

# Servicon – Agreement Number 77529

Approval of the third recommendation will enable the Chairman to execute Amendment Number 11 to Agreement Number 77529 for the Housekeeping Services for Groups 2

and 4 Agreement with Servicon to extend the term of the Agreement for the period December 1, 2017 through February 28, 2019, and with a maximum obligation \$4,214,889 for that period. This includes the cost of the upcoming increases due to new Living Wage Rates during the extension period. The current Agreement expires November 30, 2017.

# Both Agreements

Approval of the fourth recommendation will also enable the Director to execute future amendments to each Agreement to provide flexibility to address future needs. In compliance with Los Angeles County Code Section 2.121.300, the Agreements contain an express delegation of this authority to the Director.

The recommended extension of both Agreements will allow DHS sufficient time to complete a Prop A compliance Request for Proposals (RFP) for successor Agreements for these services. DHS has targeted the release of the RFP in winter 2017-18.

# Implementation of Strategic Plan Goals

The recommended actions support Strategy II.2, "Support the Wellness of Our Communities" and III.3, "Pursue Operational Effectiveness, Fiscal Responsibility and Accountability" of the County's Strategic Plan.

# **FISCAL IMPACT/FINANCING**

The total cost to extend the Housekeeping Services Agreement with Sodexo for Groups 1 and 3 for the period October 30, 2017 through February 28, 2019 is \$23,155,291 as set forth in Attachment C.

The total cost to extend the Housekeeping Services Agreement with Servicon for Groups 2 and 4 for the period December 1, 2017 through February 28, 2019 is \$4,214,889 as set forth in Attachment C.

# DHS:

The total cost for DHS is \$26,341,679 (Sodexo \$22,877,198 and Servicon \$3,464,481). Funding is included in DHS' Fiscal Year (FY) 2017-18 Final Budget and will be requested in the subsequent fiscal year as necessary.

DPH:

The total cost for DPH is \$1,028,501 (Sodexo \$278,092 and Servicon \$750,409). Funding is included in DPH' FY 2017-18 Final Budget and will be requested in the subsequent fiscal year as necessary.

# FACTS AND PROVISIONS/LEGAL REQUIREMENTS

Each of the Agreements may be terminated for convenience by the County in its sole discretion, with no less than ten (10) days' written notice.

County Counsel has reviewed and approved the recommended Amendments, set forth in Exhibit I and II, as to form.

It has been determined that the provision of services provided by Sodexo and Servicon, under the respective Agreements is subject to Prop A guidelines which includes the Living Wage Program set forth in Los Angeles County Code Chapter 2.201. Sodexo and Servicon continue to be in compliance with the Living Wage Program requirements and pays staff at or above the applicable Living Wage Rates.

# **CONTRACTING PROCESS**

The Agreement with Sodexo for Housekeeping Services for Groups 1 and 3 was approved by the Board on October 30, 2012. The Agreement with Servicon for Housekeeping Services for Groups 2 and 4 was approved by the Board on May 24, 2011. Sodexo and Servicon were each selected following a competitive solicitation.

# **IMPACT ON CURRENT SERVICES (OR PROJECTS)**

Prop A requires that departments assess any potential impact of the recommended Amendments to the Agreements. There continues to be no risk exposure to the County. Amending these Agreements will not infringe on the role of the County in its relationship to its residents, and the County's ability to respond to emergencies will not be impaired. Amending these Agreements will not result in reduced services, there is no employee impact, and pursuant to Los Angeles County Code, Section 2.121.380, will not result in the unauthorized disclosure of confidential information. In addition, DHS has determined that it has alternative resources available in the event of default.

Approval of the recommendations will ensure that critical housekeeping services for Groups 1 - 4 are continued without interruption and will allow DHS the time needed to select new contractors as a result of the pending competitive solicitation process and return to the Board with recommendations for successor agreements.

WHEREAS, reference is made to that certain document entitled "AGREEMENT BY AND BETWEEN COUNTY OF LOS ANGELES AND SODEXO AMERICA, LLC FOR HOUSEKEEPING SERVICES", dated October 30, 2012, and further identified as

Agreement No.: 77855, and any amendments thereto (all hereafter referred to as "Agreement") and,

WHEREAS, pursuant to Los Angeles County Code Section 2.121.420, the County finds that the continued provision of housekeeping services continues to be performed more economically by an independent Contractor; and

WHEREAS, it is the intent of the parties hereto to amend Agreement to extend the contract term through February 28, 2019; modify the Statement of Work; increase the annual Agreement sum to include additional Housekeeping Services and the increases in the Living Wage rates during the extension period; and to provide for the other changes as set forth herein; and

WHEREAS, Agreement provides that changes in accordance to Paragraph 8.1, Amendments may be made in the form of a written Amendment which is formally approved and executed by the parties; and

WHEREAS, Contractor warrants that it possesses the competence, expertise and personnel necessary to provide services consistent with the requirements of this Agreement and consistent with the professional standard of care for these services.

NOW, THEREFORE, THE PARTIES HERETO AGREE AS FOLLOWS:

1. This Amendment shall commence and be effective upon execution.

2. Agreement, Paragraph 3.0, Work, Subparagraph 3.2, is deleted in its entirety and replaced as follows:

"3.2 Notwithstanding subparagraph 3.1, the Facility may order additional housekeeping services up to the amount specified pursuant to Exhibits B-1(E), B-1(F), B-2(H), and B-2(I) for expanded and/or emergency services per contract year. The "contract year" is that period reflected in Exhibits B-1(E), B-1(F), B-2(H), and B-2(I). County shall not pay for such work without a price quote from the Contractor and written approval from the Facility Project Manager or his designee. Each Facility shall provide invoices for services that were provided to the Los County Department of Health Services Contracts and Grants Division quarterly."

3. Agreement, Paragraph 4.0, Term of Agreement, Sub-paragraph 4.1 and Subparagraph 4.2, are deleted in their entirety and replaced as follows:

"4.1 The term of this Agreement shall commence after execution by County's Board of Supervisors and shall expire on February 28, 2019, unless sooner terminated or extended, in whole or in part, as provided in this Agreement. Contractor services shall commence upon written notification of the Services Start Date from County's Project Director.

- 4.2 The County shall have the sole option to extend this Agreement term on a month-to-month basis, not to exceed six (6) months. Each such option and extension shall be exercised at the sole discretion of the Director or his designee as authorized by the Board of Supervisors in accordance with Sub-paragraph 8.1 Amendment."
- 3. Agreement is modified to add Sub-paragraph 5.1.1.3, as follows:
  - "5.1.1.3 The maximum obligation of the County for all Basic Housekeeping Services between October 30, 2017 through February 28, 2019 shall not exceed \$23,155,290.68."
- 4. Agreement is modified to add Sub-paragraph 5.1.3.4, as follows:
  - "5.1.3.4 From October 30, 2017 through February 28, 2019, the Director or designee, may increase County's obligation under this Agreement annually by no more than amounts specified pursuant to Exhibit B-1(F) or Exhibit B-2(I) for additional housekeeping services that arise out of Emergency or Expanded Services (e.g., adding areas in a facility or lengthening of service hours). To implement such an authorization, an Amendment to the Agreement shall be prepared in accordance with Sub-paragraph 8.1.4 and the specific amount authorized shall be not exceed the annual amount(s) specified pursuant to Exhibit B-1(F) or Exhibit B-2(I)."

5. Agreement, Exhibit B-(A-1), Housekeeping Services Budget Summary is modified to add Exhibit B-(A-2), is attached hereto and incorporated herein by reference. Any reference to Exhibit B-(A-1) shall also include Exhibit B-(A-2).

6. Agreement, Exhibit B-1(E), Housekeeping Services Pricing Sheets Group 1, is modified to add Exhibit B-1(F), is attached hereto and incorporated herein by reference. Any reference to Exhibit B-1(E) shall also include Exhibit B-1(F).

7. Agreement, Exhibit B-2(H), Housekeeping Services Pricing Sheets Group 3, is modified to add Exhibit B-2(I), is attached hereto and incorporated herein by reference. Any reference to Exhibit B-2(H) shall include Exhibit B-2(I).

8. Agreement, Exhibit C-2.1(B), Harbor-UCLA Medical Center Facility Description Cleaning Requirements, Hours of Operation, Staffing and Specification Sheet is modified to add Exhibit C-2.1(C), is attached hereto and

incorporated herein by reference. Any reference to Exhibit C-2.1(B) shall include Exhibit C.2.1(C).

9. Except for the changes set forth hereinabove, Agreement shall not be changed in any respect by this Amendment.

WHEREAS, pursuant to Los Angeles County Code Section 2.121.420, the County finds that the continued provision of housekeeping services continues to be performed more economically by an independent Contractor; and

WHEREAS, it is the intent of the parties hereto to amend Agreement to extend the contract term through February 28, 2019; increase the annual Agreement sum to include the increases in the Living Wage rates during the extension period; and to provide for the other changes as set forth herein; and

WHEREAS, Agreement provides that changes in accordance to Paragraph 8.1, Amendments may be made in the form of a written Amendment which is formally approved and executed by the parties; and

WHEREAS, Contractor warrants that it possesses the competence, expertise and personnel necessary to provide services consistent with the requirements of this Agreement and consistent with the professional standard of care for these services.

NOW, THEREFORE, THE PARTIES HERETO AGREE AS FOLLOWS:

- 1. This Amendment shall commence and be effective upon execution.
- 2. Agreement is modified to add Sub-paragraph 3.3.1 as follows:
