CHILD PROTECTION

Family Finding Pilot

- Placed youth with relatives at a rate of 80% or higher through the Family Finding pilot.

ESSA Pilot

- Transported over 70 youth to their schools of origin through the Every Student Succeeds Act (ESSA) pilot.

A Portrait of Los Angeles County

- Utilized the *A Portrait of Los Angeles County* report in planning efforts to improve resident outcomes across Los Angeles County.



INTEGRATED HEALTH

Housing Individuals

- 4000 people moved into Permanent Supportive Housing (PSH)
- Established 1000 units of interim housing as a pathway to PSH.
- Created the Flexible Housing Subsidy Pool (FHSP) which has supported rental subsidies for over 3000 clients since 2014.

Client Support Services

- Established LA's first Sobering Center in Skid Row
- Launched C-BEST to obtain SSI benefits for homeless individuals
- Deployed 28 street based outreach teams

CHAMP

- Established CHAMP as a HFH client- and bed-tracking tool.
- Has become the Whole Person Care IT platform to establish a Countywide social services case management solution.



JUSTICE REFORM

Office of Diversion and Reentry (ODR)

Over 1,500 exits from
jail to housing and
treatment

- Placed 1,515 clients from jail into housing and treatment through Misdemeanor Incompetent to Stand Trial Community Based Restoration (MIST-CBR) and ODR Housing program.

Expanded justice
partnerships

- Partnered with the Probation Department to launch reentry programming under SB678.
- Launched the Law Enforcement Assisted Diversion (LEAD) program to divert at the point of arrest.

Leveraged non-county
funding

- Awarded \$20M in Prop 47 funding for services.
- Leveraged \$10M in private funding to launch LA County's first Pay for Success project.



JUSTICE REFORM

Sheriff's Civilian Oversight Commission

Engagement

- Provided a forum for community members to discuss issues and concerns with the LASD and increase the level of communication between the LASD and community. To date, over 1000 people have participated in our Commission or Town Hall meetings.

Transparency

- Increased the transparency of the LASD. COC has worked with LASD to increase the amount of information on their website, including use of force, discipline and other vital department statistics.

Policy

- Made substantive policy recommendations on the use of Unmanned Aerial Systems, Mental Evaluation Teams and sexual assaults in the jail system (PREA).



JUSTICE REFORM

Sheriff's Department

Mira Loma Women's Detention Center

- Signed the Project Delivery and Construction Agreement
- Re-released Part A of the Request for Proposal (RFP) in mid November 2017.
- The Statement of Qualifications is due at the end January 2018 to pre-qualify interested proposers.

Consolidated Correctional Treatment Center

- Completed the public comment period for the Draft Environmental Impact Report (EIR) on December 18, 2017.
- The Department of Public Works is working with two pre-qualified design teams and County Council to finalize Part B of the RFP which is expected to be released mid-January in 2018.



HOMELESS INITIATIVE

Strategy B3

- **Partnered with Cities to Expand Rapid Re-Housing:** Between July and December 2017, housed 1,073 families and individuals through Rapid Re-Housing programs administered by LAHSA and DHS, for a total of 3,271 people housed since this strategy was implemented in January 2016.

Strategy E6

- **Countywide Outreach System:** Connected over 2,738 individuals to services, placed 441 into interim housing and linked 359 to a permanent housing program between July and December 2017.

Strategy E8

- **Enhanced the Emergency Shelter System:** Since July 2017, LAHSA increased family shelter by more than 200 beds. DMH and DHS have approximately 1,100 emergency shelter beds for individuals with complex health and/or behavioral health conditions.



ENVIRONMENTAL HEALTH OVERSIGHT

City of Paramount

- Directed six facilities to take all necessary actions to eliminate elevated hexavalent chromium emissions to reduce harmful exposures to residents and workers in the surrounding communities.

Exide Facility

- Conducted door-to-door outreach to communicate health risks to residents of highly contaminated properties and link them to available resources in the community.

Florence- Firestone Project

- Identified six priority facilities of concern and convened a multi-agency task force to conduct joint inspections and take necessary enforcement actions.



IMMIGRATION

Outreach and Education

- Launched a website to provide information about legal representation, immigration and consumer protection, and County services;
- Conducted a “Know Your Rights and LA County Resources” telethon.

IPAA Taskforce

- Launched the Immigrant Protection and Advancement Taskforce (IPAA) to create a broad vision to protect the rights and advance the success of all County immigrants.

Los Angeles Justice Fund (LAJF)

- Implemented the LAJF to provide legal representation to County immigrants who are at high risk of removal and who cannot afford an attorney.
