## APPROVAL OF AN ORDINANCE TO AMEND LOS ANGELES COUNTY CODE TITLE 8 – CONSUMER PROTECTION, BUSINESS AND WAGE REGULATIONS, AND TITLE20 – UTILITIES, TO IMPLEMENT NEW AND REVISED PUBLIC HEALTH FEES AND MODIFY BUSINESS CATEGORY DEFINITIONS (ALL SUPERVISORIAL DISTRICTS) (3 VOTES)

## **SUBJECT**

Approval of an ordinance to amend Los Angeles County Code, Title 8 – Consumer Protection, Business and Wage Regulations, and Title 20 – Utilities to implement new and revised public health fees and modify business category definitions for fiscal year (FY) 2018-19.

# IT IS RECOMMENDED THAT THE BOARD AFTER THE PUBLIC HEARING,

Introduce, waive reading, and adopt the attached ordinance (Exhibit A) that amends the Los Angeles County Code (LACC) Title 8 – Consumer Protection, Business and Wage Regulations, and Title 20 – Utilities to implement revised public health permit, license and service fees; create new business categories of public health permit, license and service fees; and modify existing business category definitions, effective FY 2018-19.

# PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

On August 2, 2011, your Board approved an ordinance to adjust existing public health permit, license, and service fees, effective FY 2011-12, and implement new fees to allow the Department of Public Health (DPH), Environmental Health (EH) Division to recover its costs for services. Those fee changes were based on a new methodology designed to determine the actual cost of the services

provided by DPH and to align the fee structure accordingly. These fee changes for FY 2011-12 were the last time public health permit, license, and service fees were adjusted. During the ensuing six years, the EH Division's total operating costs have increased, in part, due to Cost-of-Living Adjustments (COLAs), employee benefits, and indirect costs, while revenues from public health fees have remained the same and are insufficient to cover the increases in costs for services rendered. As a result, a fee increase is recommended to offset the increase in operating costs for DPH EH.

Approval of the recommended action will effectively increase most existing public health fees by approximately 15 percent (%) to recover costs due to COLAs, employee benefits, and indirect costs. In addition, approval of the recommended action will establish new public health permit fees for x-ray machines according to their energy source (low, medium or high), recycled water systems, and soft serve machines consistent with definitions found in State law; and modify existing plan check service fees related to swimming pool renovations to fully recover actual costs.

## **Implementation of Strategic Plan Goals**

The recommended action supports Goal III - Realize Tomorrow's Government Today, Strategy III3, Pursue Operational Effectiveness, Fiscal Responsibility, and Accountability, of the County's Strategic Plan.

## **FISCAL IMPACT/FINANCING**

The last fee adjustment adopted by your Board was for FY 2011-12 public health fees. The DPH EH operating budget in FY 2011-12 was \$85 million. With the FY 2011-12 fee adjustment, revenues increased to approximately \$85 million. Annual fee revenue collections have incrementally increased since then. However, as a result of COLAs, employee benefits, indirect costs, and other increases in operating expenses, the DPH EH operating budget increased by \$19.2 million and is projected at \$104.2 million for FY 2018-19. The operating budget for DPH EH increased 22% since FY 2011-12. DPH has determined that capping the fees at the 15% increase based on the service cost is sufficient to manage the increase in the operating budget. The approximate 15% fee increase represents an additional \$12.9 million in annual revenue. The variance will be balanced with funds available in the EH Trust Fund. These funds represent operating reserves that have accumulated over the years due to collections exceeding actual expenditures. We project the balance in the EH Trust Fund is sufficient to address this variance for the next three years, while maintaining prudent reserves. Thereafter, DPH will annually reevaluate the need to adjust fees consistent with increases in COLAs, employee benefits, indirect costs, and other operational needs to fully recover its costs.

Fee payments for FY 2018-19 are due July 1, 2018. Permit holders will be offered the option to pay the portion that represents the approximate 15% fee increase by October 1, 2018, thereby extending by three months the payment due date for the fee increase. DPH EH will work with County Counsel to evaluate the current payment schedule, and determine the feasibility of other payment schedules for future fiscal years.

## FACTS AND PROVISIONS/LEGAL REQUIREMENTS

Pursuant to State and local laws, DPH EH has authority to carry out regulatory activities to protect public health and safety. Accordingly, DPH EH is a regulatory agency that performs mandated services, such as inspections and investigations related to food, housing, drinking water, water quality, recreational waters, land use, solid waste, and vector management. These regulatory

activities are principally offset by the collection of fees for licenses, permits, and services. State law permits DPH to collect fees to offset the "reasonable expenses" that arise from its general enforcement activities.

Since FY 2011-12, the EH has created many operational efficiencies. These include replacing outdated computer systems with one primary EH enterprise-wide computer system called EnvisionConnect (EC) and a field inspection application called EnvisionConnect Remote; establishing Complaint Investigation Units to investigate complaints, leaving remaining program staff to conduct only routine inspections; reorganizing a selected programs to focus on priority items, meet productivity goals, and reduce response/wait times; and developing Inspection Frequency Stickers as visual identifiers to verify completed inspections, rather than having field staff stop and check for documentation. These are just a few of the efficiencies created, and the DPH EH continues to incorporate efficiencies in its business practices.

DPH EH has informed permit holders of the recommended 15% increase at meetings with various industry associations, and communications sent through mail or e-mail at the end of March 2018. Information was also posted on the EH website regarding the proposed fee increase.

Pursuant to California Government Code, Section 66018, a local agency must hold a public hearing as part of a regularly scheduled meeting of the Board of Supervisors, before adopting an ordinance, resolution, or other legislative enactment adopting a new fee, and shall publish notice of the public hearing in a newspaper in accordance with Government Code Section 6062a.

The Auditor-Controller has reviewed and approved the proposed fees as to reasonableness. County Counsel has reviewed and approved Exhibit A as to form.

## **ENVIRONMENTAL DOCUMENTATION**

The adoption of the revised Ordinance is for the purpose of meeting operating expenses and is exempt from the California Environmental Quality Act pursuant to Section 21080(b)(8) of the Public Resources Code and Section 15273(a) of the California Environmental Quality Act Guidelines.

## **IMPACT ON CURRENT SERVICES (OR PROJECTS)**

If adopted, the Ordinance will increase fees to allow DPH EH to recover most of its operating costs, implement new fees, and modify plan check service fees to fully recover costs for services provided. The DPH EH will continue to look for efficiencies in its business practices, improve service quality and access, and advocate for health equity.

An ordinance amending Title 8 – Consumer Protection, Business and Wage Regulations and Title 20 - Utilities of the Los Angeles County Code, relating to the implementation of new and revised public health fees and modification of business category definitions.

The Board of Supervisors of the County of Los Angeles ordains as follows:

SECTION 1. Section 8.04.392 is hereby added to read as follows:

#### 8.04.392 Recycled Water Existing Site.

"Recycled Water Existing Site" means a project to covert an existing building or irrigation system to recycled water for non-potable uses.

SECTION 2. Section 8.04.393 is hereby added to read as follows:

## 8.04.393 Recycled Water New Submittal.

"Recycled Water New Submittal" means a project to install a recycled water system for non-potable uses in conjunction with the construction of a new building.

SECTION 3. Section 8.04.444 is hereby amended to read as follows:

## 8.04.444 Swimming <u>pPool</u> <u>rR</u>enovation, <u>mM</u>ajor.

"Swimming pool renovation, major" means any one of the following: re-plaster, resurface, orre-plumb of a pool greater than one-hundred-thousand (100,000) gallons, installation of an ozone corona discharge system, <u>a chlorine salt generator, a solar</u> <u>heating system</u>, installation of all new equipment, or any combination of standard or minor renovations, as those terms are defined in Section 8.04.446 and Section 8.04.445, respectively, estimated to require more than three (3) hours for review and approval by the e<u>C</u>ounty <u>hH</u>ealth <u>eO</u>fficer. <u>"Swimming pool renovation, major"</u> <u>includes any resurfacing related to the work identified herein.</u>

SECTION 4. Section 8.04.445 is hereby amended to read as follows:

#### 8.04.445 Swimming <u>PPool rR</u>enovation, <u>mMinor</u>.

"Swimming pool renovation, minor," means any one of the following: replacement of a piece of equipment or drain cover, <u>deck replacement and/or coping</u>, a fencing <u>addition or change</u>, <u>filter change</u>, restroom <u>addition or</u> change, <u>racing lanes</u>, <u>lighting</u> or other renovation estimated to require one (1) hour or less for review and approval by the e<u>C</u>ounty <u>hH</u>ealth e<u>O</u>fficer.

**SECTION 5.** Section 8.04.446 is hereby amended to read as follows:

## 8.04.446 Swimming pPool rRenovation, sStandard.

"Swimming pool renovation, standard," means any one of the following: replaster, resurface, or re-plumb of a pool less than one-hundred-thousand (100,000) gallons or any combination of standard or minor renovations, as those terms are defined in Section 8.04.446 and Section 8.04.445, respectively, estimated to require more than one (1) hour but less than three (3) hours for review and approval by e<u>C</u>ounty <u>hH</u>ealth e<u>O</u>fficer. <u>"Swimming pool renovation, standard" includes any resurfacing related to the</u> work identified herein.

SECTION 6. Section 8.04.447 is hereby added to read as follows:

#### 8.04.447 Swimming Pool, Resurface.

"Swimming Pool, resurface" means any of the following: verification of rails, waterline and divider line tile, depth markers, covers, and coping. Resurface of pool or

deck.

**SECTION 7.** Section 8.04.535 is hereby added to read as follows:

## 8.04.535 X-ray Machine, High Energy Source.

"X-ray Machine, High Energy Source" means an X-ray or other radiation emitting device operating at 301 kVp and greater.

SECTION 8. Section 8.04.536 is hereby added to read as follows:

## 8.04.536 X-ray Machine, Low Energy Source.

"X-ray Machine, Low Energy Source" means an X-ray or other radiation emitting

device operating at 70 kVp and lower.

**SECTION 9.** Section 8.04.537 is hereby added to read as follows:

## 8.04.537 X-ray Machine, Medium Energy Source.

"X-ray Machine, Medium Energy Source" means an X-ray or other radiation

emitting device operating at 71 kVp to 300kVp.

**SECTION 10.** Section 8.04.720 is hereby amended to read as follows:

SECTION 12. Section 8.04.728 is hereby amended to read as follows:

#### 8.04.728 Service Charges—Basis—Payment.

A. Whenever another government jurisdiction requires a person to secure an inspection, evaluation, report or approval by the eCounty hHealth eOfficer, necessitating the eCounty hHealth eOfficer to provide a service, such person shall pay a fee to offset the costs incurred by the eCounty hHealth eOfficer as set forth in this section.

B. Any person who voluntarily seeks to secure, from the e<u>C</u>ounty hHealth = 0 fficer, an inspection, evaluation, report, approval, or other service not listed in Section 8.04.720 shall pay a fee to offset the costs incurred by the e<u>C</u>ounty hHealth = 0 fficer as set forth in this section.

C. Requests for special services described in Subsections A and B of this section shall be made on forms provided for that person by the e<u>C</u>ounty <u>hH</u>ealth <u>eQ</u>fficer. Services provided by the e<u>C</u>ounty <u>hH</u>ealth <u>eQ</u>fficer that are not listed in Section 8.04.720 and that are not detailed in the Schedule of Service Charge in

Subsection F, shall be charged in accordance with the following Standard Billing Hourly Rate Schedule. All applicable fees, as provided in this chapter, shall be paid at the time of application or request.

D. The e<u>C</u>ounty <u>hH</u>ealth <u>o</u><u>O</u>fficer, upon request and in his discretion, may provide to a party requesting plan review an Expedited Construction Inspection. The initial Expedited Construction Inspection shall be completed within forty-eight (48) hours from receipt of payment of the fee. The fee charged shall be one-half (0.5) of the appropriate plan check fee and shall cover the cost of the initial and, if the e<u>C</u>ounty <u>hH</u>ealth <u>o</u><u>O</u>fficer deems it necessary, a final construction inspection. If a final construction inspection is deemed necessary, the party shall submit a separate request for such final construction inspection which shall be completed within forty-eight (48) hours from the time said request is received. Any additional construction inspections will be charged according to the Standard Billing Hourly Rate Schedule in Subsection C above.

E. The e<u>C</u>ounty <u>hH</u>ealth <u>e</u><u>O</u>fficer, upon request and in his discretion, may provide to a party requesting an Expedited Plan Check Review Process. An Expedited Plan Check Review Process shall consist of the initial plan review to be completed within ten (10) working days from receipt of payment of the fee and one follow-up plan review, and upon separate request, an initial and, if the e<u>C</u>ounty <u>hH</u>ealth <u>e</u><u>O</u>fficer deems it necessary, a final construction inspection to be completed within fortyeight (48) hours from the time said request is received. A fee shall be charged at the rate of one and a half (1.5) times the appropriate plan check fee and shall cover the cost of the expedited initial and follow-up plan review and the expedited initial and final construction inspections. Any additional reviews or inspections will be charged according to the Standard Billing Hourly Rate Schedule in Subsection C above.
