

An ordinance amending Title 6 - Salaries of the Los Angeles County Code relating to County holidays.

The Board of Supervisors of the County of Los Angeles ordains as follows:

SECTION 1. Section 6.12.040 is hereby amended to read as follows:

6.12.040 - Holidays ~~d~~Defined.

A. Holidays are defined as follows:

| New Year's Day | January 1 |
| Martin Luther King Jr.'s Birthday | The third Monday in January |
| Presidents' Day | The third Monday in February |
| Memorial Day | The last Monday in May |
| Independence Day | July 4 |
| Labor Day | The first Monday in September |
| <u>Columbus Day</u> <u>Indigenous Peoples Day</u> | The second Monday in October |
| Veterans Day | November 11 |
| Thanksgiving Day | The fourth Thursday in November |
| Friday after Thanksgiving | The fourth Friday in November |
| Christmas | December 25 |

B. If January 1st, July 4th, November 11th, December 25th falls upon a Saturday, the preceding Friday is a holiday. If January 1st, July 4th, November 11th, or December 25th falls upon a Sunday, the following Monday is a holiday.

C. Beginning January 1, 2017, the last Monday in March is designated as a holiday for Cesar Chavez Day.

SECTION 2. Pursuant to Government Code section 25123(f), this ordinance shall be effective immediately upon final passage.
