CANYON COUNTRY, EAST SAN GABRIEL, KAGEL CANYON,
NORTH EAST SAN GABRIEL, PALMDALE, AND SAUGUS/CANYON COUNTRY
(ALL SUPERVISORIAL DISTRICTS)
(3 VOTES)**

SUBJECT

Public Works is seeking Board approval to implement traffic regulations to support traffic safety, enhance traffic flow, provide adequate parking for disabled persons, and facilitate street sweeping in the unincorporated communities of East Los Angeles, Athens/Westmont, East Rancho Dominguez, El Camino Village, Florence/Firestone, West Carson, Willowbrook, Malibu, South Whittier, Agua Dulce, Canyon Country, East San Gabriel, Kagel Canyon, North East San Gabriel, Palmdale, and Saugus/Canyon Country.

IT IS RECOMMENDED THAT THE BOARD:

1. Find that adopting and/or rescinding various traffic regulation orders and posting the corresponding regulatory and advisory signage are categorically exempt from the provisions of the California Environmental Quality Act.
2. Adopt a traffic regulation order establishing a disabled persons' parking zone on the north side of Union Pacific Avenue between a point 60 feet and a point 80 feet west of Woods Avenue, in the unincorporated community of East Los Angeles (First Supervisorial District).

3. Adopt a traffic regulation order establishing a disabled persons' parking zone on the east side of Wyman Avenue between a point 4 feet and a point 24 feet south of Eagle Street, in the unincorporated community of East Los Angeles (First Supervisorial District).
4. Adopt a traffic regulation order establishing a disabled persons' parking zone on the west side of Ferris Avenue between a point 170 feet and a point 190 feet north of Olympic Boulevard, in the unincorporated community of East Los Angeles (First Supervisorial District).
5. Adopt a traffic regulation order prohibiting parking for a period longer than 1 hour from 7a.m. to 6 p.m. on the north side of Floral Drive between a point 94 feet and a point 202 feet east of Eastern Avenue, in the unincorporated community of East Los Angeles (First Supervisorial District).
6. Adopt a traffic regulation order establishing a passenger loading zone from 7 a.m. to 9 a.m. and from 1 p.m. to 3 p.m., school days only, on the east side of Humphreys Avenue between a point 120 feet and a point 380 feet south of Burger Avenue, in the unincorporated community of East Los Angeles (First Supervisorial District).
7. Adopt a traffic regulation order prohibiting parking for a period longer than 2 hours from 9 a.m. to 1 p.m., school days only, on the east side of Humphreys Avenue between a point 120 feet and a point 380 feet south of Burger Avenue, in the unincorporated community of East Los Angeles (First Supervisorial District).
8. Adopt a traffic regulation order establishing a disabled persons' parking zone on the west side of Haas Avenue between a point 225 feet and a point 245 feet south of 112th Street, in the unincorporated community of Athens/Westmont (Second Supervisorial District).
9. Adopt a traffic regulation order establishing a disabled persons' parking zone on the north side of 112th Street between a point 128 feet and a point 148 feet west of Berendo Avenue, the unincorporated community of Athens/Westmont (Second Supervisorial District).
10. Adopt a traffic regulation order establishing a disabled persons' parking zone on the east side of White Avenue between a point 240 feet and a point 260 feet north of Alondra Boulevard, in the unincorporated community of East Rancho Dominguez (Second Supervisorial District).
11. Adopt a traffic regulation order prohibiting the parking of vehicles over 6 feet in height, within 100 feet of an intersection, on the west side of Doty Avenue between 157th Street and a point 100 feet north of 157th Street, in the unincorporated community of El Camino Village (Second Supervisorial District).
12. Adopt a traffic regulation order establishing a disabled persons' parking zone on the east side of Fir Avenue between a point 166 feet and a point 186 feet north of Firestone Boulevard, in the unincorporated community of Florence/Firestone (Second Supervisorial District).
13. Adopt a traffic regulation order establishing a disabled persons' parking zone on the west side of Grape Street between a point 394 feet and a point 414 feet south of Firestone Boulevard, in the unincorporated community of Florence/Firestone (Second Supervisorial District).
14. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 8 a.m. to 10 a.m., Mondays only, on the west side of Vermont Avenue between Del Amo Boulevard and Torrance Boulevard, in the unincorporated community of West Carson (Second Supervisorial District).

15. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 10 a.m. to 12 p.m., Tuesdays only, on the east side of Vermont Avenue between Del Amo Boulevard and Torrance Boulevard, in the unincorporated community of West Carson (Second Supervisorial District).
16. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 3 a.m. to 5 a.m., Tuesdays only, on the south side of Del Amo Boulevard between New Hampshire Avenue and Hamilton Avenue, in the unincorporated community of West Carson (Second Supervisorial District).
17. Adopt a traffic regulation order prohibiting parking at any time on the north side of Lomita Boulevard between Frampton Avenue and Normandie Avenue, in the unincorporated community of West Carson (Second Supervisorial District).
18. Adopt a traffic regulation order establishing a disabled persons' parking zone on the east side of San Pedro Street between a point 195 feet and a point 215 feet north of 135th Street, in the unincorporated community of Willowbrook (Second Supervisorial District).
19. Adopt a traffic regulation order establishing a 30-mph speed limit on Coastline Drive between Pacific Coast Highway and Malibu Vista Drive, in the unincorporated community of Malibu (Third Supervisorial District).
20. Adopt a traffic regulation order requiring northbound and southbound traffic on Maryknoll Avenue to stop at its intersection with Calmada Avenue, in the unincorporated community of South Whittier (Fourth Supervisorial District).
21. Adopt a traffic regulation order requiring northbound traffic on Sierra Highway in the lane nearest the curb to turn right onto Ryan Lane, in the unincorporated community of Canyon Country (Fifth Supervisorial District).
22. Adopt a traffic regulation order prohibiting stopping at any time on the east side of Sierra Highway between Ryan Lane and a point 700 feet south of Ryan Lane, in the unincorporated community of Canyon Country (Fifth Supervisorial District).
23. Rescind a traffic regulation order prohibiting parking for street sweeping purposes from 9 a.m. to 1 p.m., Wednesdays only, on the west side of Muscatel Avenue between Broadway and its southerly terminus south of Andes Street, in the unincorporated community of East San Gabriel as established on April 3, 2012 (Fifth Supervisorial District).
24. Rescind a traffic regulation order prohibiting parking for street sweeping purposes from 9 a.m. to 1 p.m., Thursdays only, on the east side of Muscatel Avenue between Broadway and its southerly terminus south of Andes Street, in the unincorporated community of East San Gabriel as established on April 3, 2012 (Fifth Supervisorial District).
25. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Wednesdays only, on the west side of Muscatel Avenue between Broadway and its southerly terminus south of Andes Street, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).

26. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Thursdays only, on the east side of Muscatel Avenue between Broadway and its southerly terminus south of Andes Street, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).
27. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Wednesdays only, on the north side of Andes Street between Muscatel Avenue and its easterly terminus east of Muscatel Avenue, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).
28. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Thursdays only, on the south side of Andes Street between Muscatel Avenue and its easterly terminus east of Muscatel Avenue, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).
29. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Wednesdays only, on the west side of Acacia Street between Broadway and Key West Street, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).
30. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Thursdays only, on the east side of Acacia Street between Broadway and Key West Street, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).
31. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Thursdays only, on the north side of Key West Street between Acacia Street and its easterly terminus east of Acacia Street, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).
32. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Wednesdays only, on the south side of Key West Street between Acacia Street and its easterly terminus east of Acacia Street, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).
33. Rescind a traffic regulation order prohibiting parking for street sweeping purposes from 7 a.m. to 11 a.m., Wednesdays only, on the west side of Muscatel Avenue between Wedgewood Street and Broadway, in the unincorporated community of East San Gabriel as established on January 29, 2002 (Fifth Supervisorial District).
34. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Thursdays only, on the west side of Muscatel Avenue, between Las Tunas Drive and Broadway, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).
35. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Wednesdays only, on the east side of Muscatel Avenue between the City of Temple City boundary located 110 feet south of Las Tunas Drive and a point 160 feet north of Wedgewood Street, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).

36. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 5 a.m. to 7 a.m., Wednesdays only, on the east side of Muscatel Avenue between a point 160 feet north of Wedgewood Street and Broadway, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).
37. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Thursdays only, on the south side of Wedgewood Street between Muscatel Avenue and its westerly terminus west of Muscatel Avenue, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).
38. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Wednesdays only, on the west side of La Presa Avenue between Broadway and its southerly terminus south of Broadway, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).
39. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Thursdays only, on the east side of La Presa Avenue between Broadway and its southerly terminus south of Broadway, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).
40. Rescind a traffic regulation order prohibiting parking for street sweeping purposes from 9 a.m. to 1 p.m., Wednesdays only, on the west side of Bartlett Avenue between Broadway and its southerly terminus south of Andes Street, in the unincorporated community of East San Gabriel as established on April 3, 2012 (Fifth Supervisorial District).
41. Rescind a traffic regulation order prohibiting parking for street sweeping purposes from 9 a.m. to 1 p.m., Thursdays only, on the east side of Bartlett Avenue between Broadway and its southerly terminus south of Andes Street, in the unincorporated community of East San Gabriel as established on April 3, 2012 (Fifth Supervisorial District).
42. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Wednesdays only, on the west side of Bartlett Avenue between Broadway and its southerly terminus south of Andes Street, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).
43. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Thursdays only, on the east side of Bartlett Avenue between Broadway and its southerly terminus south of Andes Street, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).
44. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Wednesdays only, on the north side of Daines Drive between Bartlett Avenue and Dubonnet Avenue, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).
45. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Thursdays only, on the south side of Daines Drive, between Bartlett Avenue and Dubonnet Avenue, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).

46. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Thursdays only, on both sides of Daines Drive between Dubonnet Avenue and its easterly terminus east of Dubonnet Avenue, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).

47. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Wednesdays only, on the west side of Dubonnet Avenue between Daines Drive and its northerly terminus north of Daines Drive, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).

48. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Thursdays only, on the east side of Dubonnet Avenue between Daines Drive and its northerly terminus north of Daines Drive, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).

49. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Thursdays only, on the south side of Nadine Street between Bartlett Avenue and its easterly terminus east of Bartlett Avenue, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).

50. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Wednesdays only, on the north side of Andes Street between Bartlett Avenue and its easterly terminus east of Bartlett Avenue, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).

51. Adopt a traffic regulation order prohibiting parking for street sweeping purposes from 12 p.m. to 4 p.m., Thursdays only, on the south side of Andes Street between Bartlett Avenue and its easterly terminus east of Bartlett Avenue, in the unincorporated community of East San Gabriel (Fifth Supervisorial District).

52. Adopt a traffic regulation order prohibiting stopping at any time on both sides of Lopez Canyon Road between the City of Los Angeles boundary located 500 feet south of Bailey Road and a point 1,300 feet north of Kagel Canyon Road, in the unincorporated community of Kagel Canyon (Fifth Supervisorial District).

53. Adopt a traffic regulation order prohibiting parking from 10 p.m. to 6 a.m. on both sides of Lopez Canyon Road between Kagel Canyon Road and a point 1,300 feet north of Kagel Canyon Road, in the unincorporated community of Kagel Canyon (Fifth Supervisorial District).

54. Adopt a traffic regulation order prohibiting parking from 10 p.m. to 6 a.m. on both sides of Kagel Canyon Road between Lopez Canyon Road and a point 1,300 feet north of Lopez Canyon Road, in the unincorporated community of Kagel Canyon (Fifth Supervisorial District).

55. Adopt a traffic regulation order requiring eastbound and westbound traffic on Mohawk Street to stop at its intersection with Quigley Avenue, establishing all-way stop control, in the unincorporated community of North East San Gabriel (Fifth Supervisorial District).

56. Adopt a traffic regulation order requiring northbound traffic on 50th Street East to stop at its intersection with Avenue M, in the unincorporated community of Palmdale (Fifth Supervisorial District).

57. Rescind a traffic regulation order requiring westbound traffic on Vasquez Canyon Road to stop at its intersection with Bouquet Canyon Road, in the unincorporated community of Saugus/Canyon Country (Fifth Supervisorial District).

58. Adopt a traffic regulation order requiring northbound and southbound traffic on Bouquet Canyon Road to stop at its intersection with Vasquez Canyon Road, in the unincorporated community of Saugus/Canyon Country (Fifth Supervisorial District).

59. Adopt a traffic regulation order requiring northbound traffic on Bouquet Canyon Road in the lane nearest the shoulder to yield before turning right onto Vasquez Canyon Road, in the unincorporated community of Saugus/Canyon Country (Fifth Supervisorial District).

60. Adopt a traffic regulation order requiring westbound traffic on Vasquez Canyon Road in the lane nearest the shoulder to yield before turning right onto Bouquet Canyon Road, in the unincorporated community of Saugus/Canyon Country (Fifth Supervisorial District).

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The purpose of the recommended actions is to improve traffic safety, enhance traffic flow, provide adequate parking for disabled persons, and facilitate street sweeping. The requests for these traffic regulations were generated by the residents or community groups or as a result of roadway improvements.

Implementation of Strategic Plan Goals

The County Strategic Plan directs the provision of Strategy II.3, Make Environmental Sustainability our Daily Reality. The recommended actions support a clean, flexible, and integrated Multi-Modal Transportation System that improves mobility and traffic safety.

FISCAL IMPACT/FINANCING

There will be no impact to the County General Fund. Sufficient funds are included in the Road Fund Fiscal Year 2017-18 Budget to cover the minor costs of removing and installing the necessary signs and markings.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

The California Vehicle Code authorizes the Board to implement these traffic regulations that are required prior to enforcement by the California Highway Patrol and the Sheriff's Department.

ENVIRONMENTAL DOCUMENTATION

The establishment of these regulations, including the installation of related traffic control devices required to notify the motoring public is categorically exempt from the provisions of the California Environmental Quality Act pursuant to Section 15301(c) of the California Environmental Quality Act Guidelines and Class 1(x) (7) of the Environmental Reporting Procedures and Guidelines approved by the Board on November 17, 1987.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

Implementation of these traffic controls will have a positive impact by enhancing traffic flow and safety.
