- As of December 19, 2016, the Panel certified that LASD has implemented 101 of the 104 substantive provisions
 - *Effective January 1, 2017, 101 of the 104 are subject to active compliance monitoring*

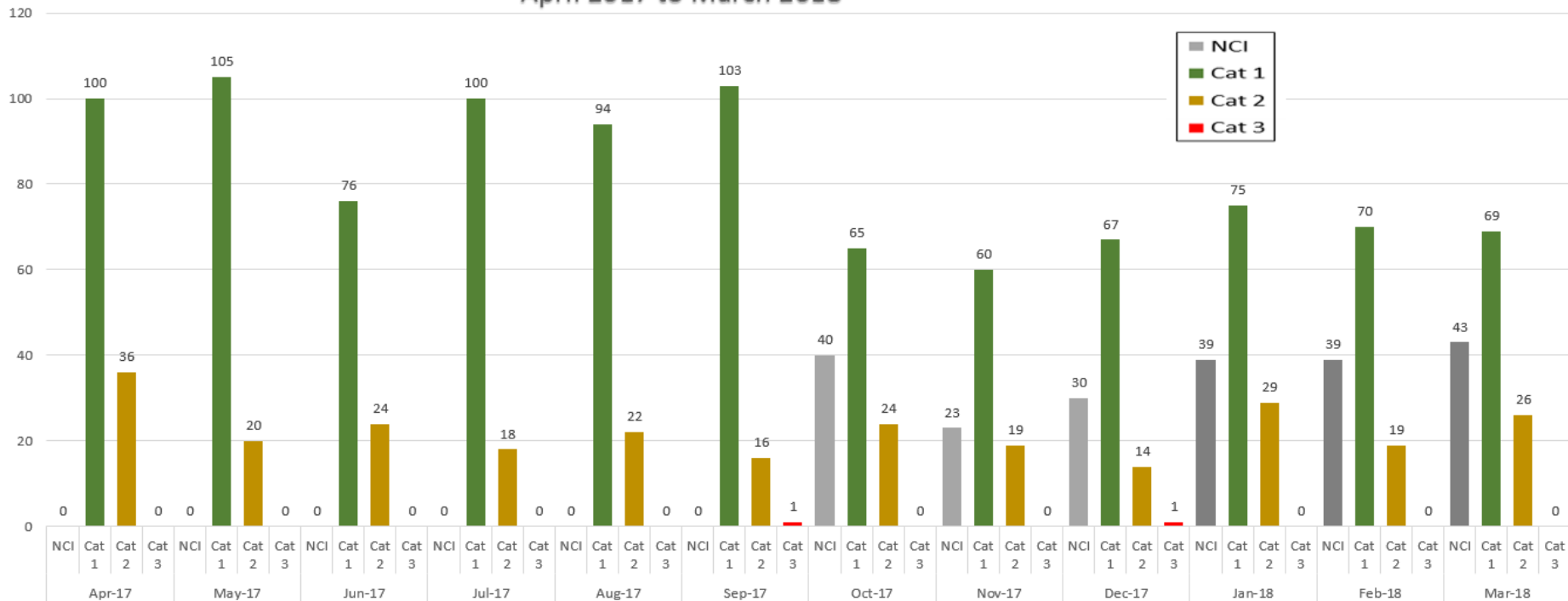
