SERVICES CONTRACT BUSINESS OUTREACH/TECHNICAL SERVICES AWARD OF SERVICES CONTRACTS FOR ENVIRONMENTAL LABORATORY SERVICES PROGRAM (ALL SUPERVISORIAL DISTRICTS) (3 VOTES)

### **SUBJECT**

Public Works is seeking Board approval to authorize three services contracts to American Environmental Testing Laboratory, Inc.; Enthalpy Analytical, LLC.; and TestAmerica Laboratories, Inc., for laboratory services to analyze soil and water samples and other substances at various jobsites and projects in the County of Los Angeles.

### IT IS RECOMMENDED THAT THE BOARD:

1. Find that the contract work is categorically exempt from the provisions of the California Environmental Quality Act.

2. Award three contracts for Environmental Laboratory Services Program to the following: a smallsized firm, a Local Small Business Enterprise, American Environmental Testing Laboratory, Inc.; a medium-sized firm, Enthalpy Analytical, LLC.; and a large-sized firm, TestAmerica Laboratories, Inc. These contracts will be for a term of 1 year with four 1-year renewal options and a month-to-month extension up to 6 months for a maximum potential program term of 66 months and with an estimated maximum potential program sum of \$18.15 million.

3. Authorize the Director of Public Works or his designee to execute these contracts; to renew the contracts for each additional renewal option and extension period if, in the opinion of the Director of Public Works or his designee, American Environmental Testing Laboratory, Inc.; Enthalpy Analytical, LLC.; and TestAmerica Laboratories, Inc., have successfully performed during the previous contract period and the services are still required; to approve and execute amendments to incorporate necessary changes within the scope of work; and to suspend work if, in the opinion of the Director of Public Works or his designee, it is in the best interest of the County to do so.

4. Authorize the Director of Public Works or his designee to annually increase the program amount up to an additional 10 percent of the annual program sum for unforeseen, additional work within the scope of the program, if required.

### PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The purpose of the recommended action is to provide on-call laboratory services to analyze soil and water samples and other substances at various jobsites and projects in the County of Los Angeles. For example, services may be required if potential environmental contaminant hazards are encountered on County construction projects. These services also may be needed to monitor and mitigate hazardous waste sites under regulatory oversight, to determine if discharges to water resource systems meet permit requirements, or to identify environmental health-risk conditions that may affect County workers and the public.

These contractors are certified by the California State Water Resources Control Board's Environmental Laboratory Accreditation Program and have the specific resources including equipment, trained personnel, and systems to provide comprehensive and responsive analytical laboratory support.

The award of these contracts will continue the current service with recommended contractors.

### **Implementation of Strategic Plan Goals**

The work performed under these contracts is in alignment with the County Strategic Plan including the provisions of Strategy II.2, Support the Wellness of our Communities and Objective II.2.3, Prioritize Environmental Health Oversight and Monitoring; and Strategy II.3, Make Environmental Sustainability our Daily Reality and Objective II.3.1, Improve Water Quality, Reduce Water Consumption, and Increase Water Supplies and Objective II.3.4, Reduce Waste Generation and Recycle and Reuse Waste Resources. The recommended actions support the County's capability to respond to emergent environmental hazards, reduce storm water pollution, and increase landfill diversion, and will support Public Works in meeting these goals.

### **FISCAL IMPACT/FINANCING**

The program is for an aggregate annual amount of \$3 million plus 10 percent of the annual program sum for unforeseen, additional work within the scope of the contract with an estimated maximum potential program sum of \$18.15 million. This amount is based on Public Works' estimated annual utilization of the contractors' services.

The total expenditures for these services, however, will not exceed the amount approved by the Board. Funding for the services is included in various Public Works Funds Fiscal Year 2018-19 Budgets. Any expenditure from the Public Works General Fund will be included in the Public Works General Fund Budget for that fiscal year. Funds to finance the contracts' optional years and 10 percent additional funding for contingencies will be requested through the annual budget process.

### FACTS AND PROVISIONS/LEGAL REQUIREMENTS

The recommended contractors are the following: a small-sized firm, a Local Small Business Enterprise, American Environmental Testing Laboratory, Inc.; a medium-sized firm, Enthalpy Analytical, LLC.; and a large-sized firm, TestAmerica Laboratories, Inc. This Contracting Program will be for a period of 1 year. With the Board's delegated authority, Public Works may renew these contracts for four 1-year renewal options and a month-to-month extension up to 6 months for a maximum potential total program term of 66 months.

The recommended contracts were solicited on an open-competitive basis and are in accordance with applicable Federal, State, and County requirements.

A standard service contract has been used that contains terms and conditions in compliance with the Board's ordinances, policies, and programs. Enclosure A reflects the contractors' minority participation. Data regarding the proposers' minority participation is on file with Public Works. The contractors were selected upon final analysis and consideration without regard to race, creed, gender, or color.

Public Works has evaluated and determined that the contracted services are required on an on-call basis; therefore, Proposition A (County Code Chapter 2.121) and the Living Wage Program (County Code Chapter 2.201) do not apply to this contract.

### ENVIRONMENTAL DOCUMENTATION

These services are categorically exempt from the provisions of the California Environmental Quality Act. These services, which are to analyze soil and water samples and other substances to identify the existence of substances of concern are within the class of projects that have been determined not to have a significant effect on the environment in that it meets the criteria set forth in Sections 15304 and 15306 of the State California Environmental Quality Act Guidelines and Classes 4 and 6 of the County's Environmental Document Reporting Procedures and Guidelines Appendix G. In addition, the proposed sampling will comply with all applicable regulations, will not be performed in a sensitive environment, and there will be no cumulative impacts, unusual circumstances, damage to scenic highways, listing on hazardous waste site lists compiled pursuant to Government Code Section 65962.5, or indications that the sampling may cause a substantial adverse change in the significance of a historical resource that would make the exemptions inapplicable.

### **CONTRACTING PROCESS**

On December 18, 2017, a notice of the RFSQ was placed on the County's "Doing Business With Us" website (Enclosure B); Public Works' "Business Opportunities" website; Twitter; and an advertisement was placed in the Los Angeles Daily Journal, Los Angeles Sentinel, and La Opinión Advertisement. Also, Public Works informed 1,531 Local Small Business Enterprises; 127 Disabled

Veteran Business Enterprises; 75 Social Enterprises; and 149 independent contractors, various business development centers, and municipalities about this business opportunity.

The RFSQ allowed firms to compete as primes in one of three categories: small-, medium-, or largesized firms. Each firm was requested to certify its own size based on number of personnel for competition with other firms in the same size category. The RFSQ stated that the goal would be to award contracts to a total of five firms as follows: two small-sized firms (with 25 or fewer personnel), two medium-sized firms (with 26 to 75 personnel), and one large-sized firm (with over 75 personnel).

On January 16, 2018, three Statements of Qualifications were received. They were first reviewed to ensure that they met the minimum requirements in the RFSQ. All statements having met these requirements were then evaluated by an evaluation committee consisting of Public Works staff. The evaluation was based on criteria described in the RFSQ, which included the price, experience, work plan, references, and on-site laboratory inspection utilizing the informed averaging methodology for applicable criteria. Based on this evaluation, Public Works selected three responsive and responsible vendors.

### **IMPACT ON CURRENT SERVICES (OR PROJECTS)**

The award of this program will continue the services without disruption to the public and will not result in the displacement of any County employees as these services are presently contracted with the private sector.
