Malibu Park n Ride

The City of Malibu proposes to develop a transit system park-and-ride/shuttle facility within the City to provide increased mobility options for transit users and commuters. Measure M, the 1/2-cent transportation sales tax measure approved by the voters of the County in November 2016, allocates Multi-Year Subregional (MSP) funding to the Las Virgenes-Malibu Subregion for an Active Transportation, Transit, and Technology Program, a Highway Efficiency Program, a Modal Connectivity Program, and a Traffic Congestion Relief and Improvement Program. The City's proposed transit system park-and-ride/shuttle facility would be an eligible project within one or more of these Programs.

Since the aforementioned MSP funding is not immediately available, a County commitment to advance Proposition C Local Return funds to the City for the proposed transit system park-and-ride/shuttle facility will enhance its near-term viability and well-position it for Las Virgenes-Malibu MSP funding when it becomes available. This supports the County's Strategic Plan Goal to Foster Vibrant and Resilient Communities (Goal II).

I, THEREFORE, MOVE that the Board of Supervisors:

1. Find that the recommended authorization herein is not a project pursuant to Section 15378(b) of the California Environmental Quality Act (CEQA) because it is an organizational or administrative activity of government and involves the creation of a government funding mechanism that does not commit the City to any specific project that may result in a potentially significant physical impact on the environment. As the lead agency under CEQA, the City would be required to complete the environmental review process and make any necessary findings under CEQA before approving the project;
2. Commit to the City of Malibu the advance of up to \$4,000,000 for the City's proposed transit system park-and-ride/shuttle facility with reimbursement of such advance to be made to the County from the Las Virgenes-Malibu Subregion's allocation of Measure M Multi-Year Subregional Program funds; and
3. Upon the City's approval of a project description or environmental finding satisfactory to the Director of Public Works, authorize the Director of Public Works or his designee to enter into a funding agreement with the City providing for the County to advance up to \$4,000,000 toward those costs of the City's proposed transit system park-and-ride/shuttle facility that are eligible to be funded from Proposition C Local Return funds; and authorize the Director of Public Works or his designee to enter into a funding agreement with the Los Angeles County Metropolitan Transportation Authority for reimbursement of the County's advance of funds from eligible funds within the Las Virgenes-Malibu Subregion's allocation of Measure M Multi-Year

Subregional Program funds. The necessary funds for the advance can be made available from the Third Supervisorial District's Road Construction Program included in the Proposition C Local Return Fund Fiscal Year 2017-18 Budget.
