APPOINTMENT AND SALARY FOR EXECUTIVE OFFICER, BOARD OF SUPERVISORS ALL DISTRICTS (3 VOTES)

SUBJECT

Recommendation to appoint and set the salary for Celia Zavala to serve as Executive Officer, Board of Supervisors.

IT IS RECOMMENDED THAT THE BOARD:

1. Appoint Celia Zavala as the Executive Officer, Board of Supervisors, effective September 25, 2018, at an annual salary of \$262,911.
2. Instruct the Director of Personnel to execute an at-will employment contract, which is approved as to form by County Counsel.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

The purpose of the recommended actions is to appoint Ms. Celia Zavala to the position of Executive Officer, Board of Supervisors and to set the salary for the position.

As Executive Officer, Ms. Zavala oversees the support services for the Board of Supervisors (Board) in administering and managing technology, staffing, procurement and facilities resources, as well as the publication of information for the Board, various County departments, and the public. The Executive Office of the Board also administers and oversees the Office of the Inspector General and other County commissions.

Ms. Zavala has been serving as Acting Executive Officer since February 2018. Prior to her current assignment, Ms. Zavala held several positions in the Executive Office of the Board. As Chief Deputy Executive Officer, Ms. Zavala was responsible for overseeing the Administrative and Support Services, General Operations and Commissions, and Technology Planning Divisions. Ms. Zavala also served as Assistant Executive Officer where she had executive, management, and administrative responsibility for assisting in the overall management of divisions. As Administrative Deputy II, Ms. Zavala directed the planning, implementation, and evaluation of administrative operations and services for the Executive Office. While serving as Departmental Finance Manager II, Ms. Zavala was responsible for the management of the financial resources of the Executive Office.

Ms. Zavala earned a Bachelor of Science in Business Administration from California State University, Dominguez Hills.

Implementation of Strategic Plan Goals

Approval of these recommendations will further the County of Los Angeles' Strategy III.3, Pursue Operational Effectiveness, Fiscal Responsibility, and Accountability to continually assess our efficiency and effectiveness, maximize and leverage resources, and hold ourselves accountable.

IMPACT ON CURRENT SERVICES (OR PROJECTS)


