A. Any person employed in the PublicLA County Library who performs professional librarian work on a Bookmobile and also drives such vehicle shall be entitled to receive compensation at a rate of two schedules above that provided by Section 6.28.140 of this code.

B. Effective with the pay period ending April 15, 2012 and upon notification to the hBoard of sSupervisors by the eChief eExecutive eOfficer that the hHuman rResources mManagement sSystem implementing this provision is fully operational, any person employed in the PublicLA County Library who performs professional librarian work on a Bookmobile and also drives such vehicle shall be entitled to receive compensation at a rate 5.6468 percent above that provided by Section 6.28.140 of this code.
