SUBJECT

To ensure access to high-quality, patient-centered, cost-effective health care to Los Angeles County residents through direct services at DHS facilities and through collaboration with community and university partners.



Delegate authority to execute amendments to Temporary Nursing Personnel Services, Temporary Medical Personnel Services, Temporary Certified Registered Nurse Anesthetist Services, Temporary Therapeutic Hemapheresis and Dialysis Services, Specialty Medical Services, and Physician Registry Services Master Agreements (collectively referred to as temporary medical personnel agreements) with multiple vendors to extend the term of each agreement, to negotiate increased rates, and to establish Cost of Living Adjustments for Department of Health Services, Department of Public Health, Department of Mental Health and other County Department facilities, as needed.

IT IS RECOMMENDED THAT THE BOARD:

1. Delegate authority to the Director of Health Services (Director), or designee, to execute amendments, effective upon execution, to: a) extend the term of each of the Temporary Nursing Personnel Services (TNPS), Temporary Medical Personnel Services (TMPS), Temporary Therapeutic Hemapheresis and Dialysis Services (TTHDS), and Temporary Certified Registered Nurse

Anesthetist Services (TCRNAS) Master Agreements listed in Attachment A from July 1, 2019 through June 30, 2022 with two (2) one-year extension options; for an estimated annual cost of \$37,140,679 and b) extend the term of each of the Specialty Medical Services (SMS) and Physician Registry Services (PRS) Master Agreements listed in Attachment A from July1, 2020 through June 30, 2022 with two (2) one-year extension options; for an estimated annual cost of \$29,285,607 for continued provision of as-needed services at the Department of Health Services (DHS) and other County Department facilities and to reaffirm currently provided rate differentials of up to 20% and 36% for staff working at High Desert Regional Health Center (HDRHC) and Integrated Correctional Health Services (ICHS), respectively.

- 2. Delegate authority to the Director, or designee, to execute new temporary medical personnel agreements, effective upon execution and coterminous with the term of the current agreements referenced in Recommendation 1 above, with new Contractors in the six categories identified on Attachment A to be selected through a qualification process.
- 3. Delegate authority to the Director, or designee to execute amendments to the categories of temporary medical personnel agreements listed in Attachment B to: a) increase current rates of individual staffing categories (e.g., Dental Technician, Respiratory Therapist, Laboratory Assistant, etc.) to remain competitive for qualified staff, based on an industry review of comparable rates; and b) provide for future cost of living adjustments (COLA) based upon the most recently published percentage change in the Bureau of Labor Statistics, Los Angeles-Riverside-Orange County, Consumer Price Index for Urban Consumers (CPI-U) for the 12-month period preceding the contract anniversary date, or the general salary movement percentage for County employees for the 12-month period preceding the prior July 1st, upon approval by the County Counsel, and Chief Executive Office.
- 4. Delegate authority to the Director, or designee, to (a) exercise term extension options under the same terms and conditions as the original agreement; and to execute future amendments to all temporary medical personnel agreements to: (b) make changes to the agreements, including statements of work and compensation, for operational efficiencies, meeting service requirements and/or changes to the needs of the serviced facilities and/or technology; (c) add service and/or staff categories at rates not to exceed those approved by the Board, (d) change the number of services hours to be provided, not to exceed the maximum hours authorized by the Board; (e) adjust compensation for services, to remain competitive with prevailing market rates; and (f) adjust the annual maximum obligation, as applicable, in accordance with actions taken under subparts (d) and/or (e) above.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

Background

Historically, DHS has encountered difficulty in recruiting and hiring enough physicians, nurses, and other medical personnel to adequately meet the health care needs of patients. Temporary medical staffing registries have long been used to help fill in the gaps and provide a more consistent quality of care. Specifically, the agreements identified in this Board Letter are used to address critical staffing shortages, peak workloads, unexpected emergencies, and vacation coverage at the DHS and Department of Public Health (DPH) facilities. In recent years, DHS has experienced increasing difficulty in obtaining qualified temporary medical personnel as rapidly as needed. Input from Contractors providing services under the current agreements indicates that the rates offered by DHS are less than competitive based on industry standards.

As a result, is fewer and less qualified or more inexperienced staff is being placed at the serviced facilities. This situation undermines the County's ability to meet the constantly changing needs of our patient population and to provide consistency in our quality of care needed to meet regulatory standards.

Recommendations

Approval of the first and second recommendations will allow the Director, or designee, to amend the current temporary medical personnel agreements to extend the term, and to enter into agreements with new contractors to ensure that the County can continue to obtain temporary medical personnel services to support critical County operations. In addition, the recommendation will allow for continuing current rate differentials granted to Contractors providing services at HDRHC and ICHS facilities. Traditionally these facilities have found it difficult to access registry staff without consideration for higher rates.

Approval of the third recommendation will allow the Director, or designee, to execute Amendments to the agreements to apply current rate increases to those Contractors listed on Attachment A, based on a salary survey and analysis of rates applicable to private industry. This will also delegate authority to the Director, or designee, to effectuate future rate changes utilizing a COLA. These processes will allow the County to become nimble in a fast-paced industry and to remain competitive in contracting with the most qualified and experienced temporary medical staff available, thus enabling DHS and other County facilities to remain fully-staffed, even at times of peak need.

Approval of the fourth recommendation will allow the Director, or designee, to (a) exercise extension options; and to execute amendments to the agreements to: (b) make necessary changes to the agreements, including scopes of work and compensation, based on operational efficiencies, meeting service requirements and/or the changes in the needs of the serviced facilities and/or technology; (c) execute new agreements or amendments to add service categories or additional staff, if needed; (d) if the agreement specifies a certain number, to change the number of service hours to be provided, up to the maximum authorized by the Board; (e) adjust compensation for services, up to the maximum hourly rate allowed by the Board, and adjust the maximum obligation under the agreements to which it applies, based upon any action associated with a change in rates or maximum hours; and (f) amend all registry agreements to add protocols for requesting registry staff in response to work stop actions and other emergencies.

<u>Implementation of Strategic Plan Goals</u>

The recommended actions support Strategy II.2 "Support the Wellness of Our Communities" and III.3 "Pursue Operational Effectiveness, Fiscal Responsibility, and Accountability" of the County's Strategic Plan.

FISCAL IMPACT/FINANCING

The DHS estimated annual cost for (a) TNPS, TMPS, TTHDS, and TCRNA agreements is \$37,140,679, and (b) SMS and PRS agreements is \$29,285,607.

Funding is included in the DHS Fiscal Year (FY) 2019-20 Recommended Budget and will be included as a continuing appropriation in future fiscal years' budget as necessary.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

The temporary medical personnel agreements are not Proposition A agreements due to the fact that the services provided under the agreement are intermittent and as needed and, therefore, not subject to the Living Wage program (Los Angeles County Code Chapter 2.201).

The agreements may be terminated for convenience by the County upon 30 days' prior written notice. The agreements include all Board of Supervisors' required provisions.

CONTRACTING PROCESS

On May 20, 2014, DHS released a Request for Submission of Qualifications (RFSQ) to identify qualified vendors for TNPS, TCRNAS and TTHDS. On June 16, 2015, DHS executed successor agreements for TMPS and released an RFSQ to identify new qualified vendors, with notices of availability of the RFSQ posted on the County and DHS websites provided to vendors on DHS' internal mailing lists.

The RFSQs are open continuously for responses, which will be accepted and reviewed in accordance with the RFSQ process. If qualified, additional firms will be offered a new TMP master agreement.

Approval and execution of a master agreement does not guarantee a Contractor any minimum amount of business. The County only incurs an obligation if staff members are certified and provide work following County's request.

Due to the sensitive nature of the services provided under the temporary medical personnel agreements, potential contractors must complete a rigorous qualification process, including credentialing and background check, prior to receiving an agreement from DHS.

IMPACT ON CURRENT SERVICES (OR PROJECTS)

Approval of the recommendations will ensure that serviced County facilities will remain fully staffed at all times and especially in times of peak, as needed.
