FIVE JOB ORDER CONTRACTS
FOR MAINTENANCE, REPAIR, REMODELING, AND REFURBISHMENT
OF COUNTY INFRASTRUCTURE AND FACILITIES,
AWARD JOB ORDER CONTRACTS 1915, 1916, 1917, 1918, AND 1919,
APPROVE REPAIR AND MAINTENANCE PROJECTS
(SPECIFICATIONS - VARIOUS)
(ALL SUPERVISORIAL DISTRICTS)(3 VOTES)

#### SUBJECT

The recommended actions will award five separate Job Order Contracts 1915, 1916, 1917, 1918, and 1919 to the apparent lowest responsive and responsible bidder, authorize the Director of Parks and Recreation or his designee to issue work orders for County facilities and infrastructure, approve the list of repair, refurbishment, remodeling and maintenance projects, and authorize their delivery using Board-approved Job Order Contracts.

#### IT IS RECOMMENDED THAT THE BOARD:

- 1. Find the award of Job Order Contracts 1915, 1916, 1917, 1918, and 1919 are categorically exempt from the California Environmental Quality Act for the reasons stated herein and in the records pertaining to the Job Order Contracts.
- 2. Find that the various repair, remodeling, refurbishment and maintenance projects on the attached list (Attachment I), except for projects at the South Coast Botanic Garden, are categorically exempt from the California Environmental Quality Act for the reasons stated herein and the reasons reflected in the records of the projects.

- 3. Determine that the proposed projects at the South Coast Botanic Garden listed in Attachment I are within the scope of the South Coast Botanic Garden Vision Plan project impacts analyzed in the Mitigated Negative Declaration previously adopted by your Board.
- 4. Approve the enclosed list of proposed repair, remodeling, refurbishment and maintenance projects (Attachment I), including the proposed budget for each project.
- 5. Authorize the Director of Parks and Recreation or his designee to deliver the list of repair, remodeling, refurbishment and maintenance projects set forth in Attachment I using Board-approved Job Order Contracts.
- 6. Award Job Order Contract 1915 to SJD & B, Inc., the lowest responsive and responsible bidder, for a maximum amount of \$5,100,000 to be financed from repair and maintenance project budgets as deemed appropriate by the Director of Parks and Recreation or his designee, for a 12-month term.
- 7. Award Job Order Contract 1916 and 1917 to New Creation Engineering and Builders, Inc., dba New Creation Builders, the lowest responsive and responsible bidder, for a maximum amount of \$5,100,000 each to be financed from repair and maintenance project budgets as deemed appropriate by the Director of Parks and Recreation or his designee, for a 12-month term.
- 8. Award Job Order Contract 1918 and 1919 to Access Pacific, Inc., the lowest responsive and responsible bidder, for a maximum amount of \$5,100,000 each to be financed from repair and maintenance project budgets as deemed appropriate by the Director of Parks and Recreation or his designee, for a 12-month term.
- 9. Authorize the Director of Parks and Recreation or his designee to execute Job Order Contracts 1915, 1916, 1917, 1918, and 1919 in the form previously approved by County Counsel and to establish the effective date following the receipt of approved Faithful Performance and Labor and Materials Bonds filed by SJD & B, Inc., New Creation Builders, and Access Pacific, Inc.
- 10. Authorize the Director of Parks and Recreation or his designee to issue work orders for projects that are subject to the State Public Contract Code, including repair, remodeling and refurbishment work, in an amount not to exceed \$75,000 per work order, in accordance with Public Contract Code Section 20145, subject to the limitation that the aggregate amount of all work orders issued under a particular Job Order Contract does not exceed the \$5,100,000 not-to-exceed contract amount of the Job Order Contract.
- 11. Authorize the Director of Parks and Recreation or his designee to issue work orders for projects that are not subject to the State Public Contract Code, including maintenance work, as applicable, in an amount not to exceed \$5,100,000 per work order, subject to the limitation that the aggregate amount of all work orders issued under a particular Job Order Contract does not exceed the \$5,100,000 not-to-exceed contract amount of the Job Order Contract.
- 12. Authorize the Director of Parks and Recreation or his designee to accept such projects and file notices of completion upon final completion of the projects. The Director may also approve the release of the retention money withheld, pursuant to the applicable provisions of the Public Contract Code. The Director is further authorized to grant extensions of time on such projects due to delay deemed to be beyond the contractor's control, and to assess liquidated damages, as authorized by Government code section 53069.85 and the contract specification.

#### PURPOSE/JUSTIFICATION OF RECOMMENDED ACTION

Approval of the recommended actions will find the award of Job Order Contracts (JOC) 1915, 1916, 1917, 1918, and 1919 and the proposed repair and maintenance projects, except the projects at South Coast Botanic Garden, reflected on the attached list (Attachment I) exempt from the California Environmental Quality Act (CEQA); will find the proposed repair and maintenance projects at South Coast Botanic Garden, reflected in the Attachment I are within the scope of the previously adopted Mitigated Negative Declaration; authorize the delivery of the proposed repair, remodeling, refurbishment and maintenance projects using Board-approved JOCs; award and authorize the Director of the Department of Parks and Recreation (Director) or his designee to execute JOC 1915, 1916, 1917, 1918, and 1919 with the lowest responsive and responsible bidder; ; and authorize issuance of work orders pursuant to Article 20145 of the California Public Contract Code and as set forth in further detail below.

Upon the Board's approval of the recommended actions, the Department of Parks and Recreation (Department) will implement the projects included in the attached list (Attachment I). These projects consist of repair, replacement, refurbishment and maintenance of certain Department amenities, including but not limited to HVAC systems, roofs, water controllers, park facility restrooms, community buildings, concrete walkways, parking lots, and trails.

JOC is a competitively procured, flexible, and cost-effective unit price contracting method used by the Department to accomplish repair, refurbishment, remodeling, maintenance and alteration of County infrastructure and facilities without extensive plans and specifications. The State Public Contract Code provides that JOCs are annual contracts that may be awarded for repair, remodeling, refurbishment, or other repetitive work, but not for new construction. The JOC delivery method reduces administrative requirements and lowers direct construction costs while meeting all Federal, State, and County procurement requirements.

Approval of the recommended actions will allow the Director or his designee to issue JOC work orders for projects that are subject to the State Public Contract Code, including repair, remodeling, and refurbishment work, in an amount not to exceed \$75,000 per work order, in accordance with Public Contact Code section 20145, subject to the limitation that the aggregate amount of all work orders issued under a particular JOC does not exceed the \$5,100,000 maximum contract amount of the JOC. For projects subject to the State Public Contract Code, the Department will seek advance approval from the Board to issue JOC work orders for any such project that exceeds \$75,000.

Approval of the recommended actions will also delegate authority to the Director or his designee to issue work orders for projects that are not subject to the State Public Contract Code (including, for example, maintenance, demolition or procurement and installation of equipment, as applicable), in an amount not to exceed \$5,100,000 per work order, subject to the limitation that the aggregate amount of all work orders issued under a particular JOC does not exceed the \$5,100,000 maximum contract amount of the JOC.

In order to have adequate JOC capacity available on a continuous basis, the aggregate requested amount of JOC authority is \$25,500,000 across all 5 JOCs. The proposed JOCs will be used to deliver the proposed repair, remodeling, refurbishment and maintenance projects reflected on the attached list (Attachment I), and other projects previously approved by the Board to be performed under Board approved JOCs. This capacity is based on the anticipated need for various projects to be performed under the JOCs, including repair, remodeling, refurbishment, and maintenance work for County General and Special Fund departments.

### **Implementation of Strategic Plan Goals**

The Countywide Strategic Plan directs the provisions of Strategy II.1, Drive Economic and Workforce Development in the County, Objective II.1.2, Support Small Business and Social Enterprises; and Strategy III.3, Pursue Operational Effectiveness, Fiscal Responsibility, and Accountability, Objective III.3.2, Manage and Maximize County Assets. The recommended actions improve the economic and social well-being of our communities while maximizing and leveraging resources.

#### FISCAL IMPACT/FINANCING

The recommended contracts have a maximum limit of \$5,100,000 each. Work orders will be financed through the appropriate refurbishment projects as budgeted in the Capital Projects/Refurbishments and Extraordinary Maintenance Budget, or as funded through the Department's Operating and Special Funds Budgets.

**Operating Budget Impact** 

The Department's proposed JOC program requires technical and administrative support provided by the Department of Public Works (DPW) for bid solicitation services; the technical and administrative support fees, based on the written agreement between DPW and the Department, will be charged to the operating budget.

#### FACTS AND PROVISIONS/LEGAL REQUIREMENTS

A standard contract will be used in the form previously approved by County Counsel. The standard Board-directed clauses for contract terminations, renegotiations, and hiring qualified displaced County employees will be included.

Each JOC agreement will contain terms and conditions in compliance with the Board's ordinances, policies, and programs.

Data regarding the bidders' minority participation may be found in Attachment III. The contractors have been selected upon final analysis and consideration without regard to race, creed, color, or gender.

The JOCs are subject to the Board-adopted Countywide Local and Targeted Worker Hire Policy.

#### **ENVIRONMENTAL DOCUMENTATION**

The proposed projects listed in Attachment I, except for the projects at the South Coast Botanic Garden, are categorically exempt from CEQA. The projects, which include repair and maintenance of existing facilities, replacement of existing structures and facilities, construction of small new structures and minor alterations in the condition of land, are within certain classes of projects that have been determined not to have a significant effect on the environment in that they meet the criteria set forth in the State CEQA Guidelines sections and the County's Environmental Document Reporting Procedures and Guidelines exemption sections cited in the attached list of projects.

The proposed projects will not involve the removal of healthy, mature, and scenic trees. Additionally, the proposed projects will comply with all applicable regulations, and there are no cumulative impacts, unusual circumstances, damage to scenic highways, listing on hazardous waste sites

pursuant to Government Code Section 65962.5, or indications that the proposed projects may cause substantial adverse changes in the significance of a historical resource that would make the exemptions inapplicable.

The proposed projects at the South Coast Botanic Garden listed in Attachment I are within the scope of the project in the previously adopted South Coast Botanic Garden Vision Plan Mitigated Negative Declaration. There are no changes to the project or to the circumstances under which the project is undertaken that require further review under CEQA.

#### **CONTRACTING PROCESS**

The Department received assistance from DPW during the bidding process for these contracts.

On March 11, 2019, DPW issued and advertised a Notice Inviting Bids for twenty JOCs (1900 through 1919) using the JOC Unit Price Book and Specifications dated February 2018, which incorporated the JOC Unit Price Book and Specifications adopted by the Board on May 1, 2018, along with the procedure to add unit pricing for Non Pre Priced tasks not previously priced in the JOC Unit Price Book and Specifications adopted by the Board on April 12, 2016. Fifteen of the twenty JOCs (1900 through 1914) will be utilized by DPW. The remaining five JOCs (1915 through 1919) will be utilized by the Department.

On March 11, 2019, the Invitation for Bids was placed on the County's "Doing Business with Us" website (Attachment IV); DPW's "Business Opportunities" website; Twitter; and advertised in the Los Angeles Daily Journal, Los Angeles Sentinel, La Opinión, and The Daily Breeze. Also, DPW informed 2,392 Local Small Business Enterprises (LSBE) and Community Business Enterprises (CBE).

On March 21, 2019, DPW held a Mandatory Pre-bid Conference to explain the JOC concept, discuss JOC from the contractors' perspective, and answer questions. Also present was a representative of the Department of Consumer and Business Affairs who provided a presentation on the County's LSBE Preference Program.

On April 15, 2019, 57 bids were received and publicly opened.

On April 16, 2019, DPW received a request from New Creation Builders, the lowest bidder on Job Order Contracts 1915, to be relieved from their bids due to clerical error. DPW reviewed the facts and consented to relieve New Creation Builders of their bids in accordance with Section 5101 of the Public Contract Code of the State of California. The second lowest responsive and responsible bidder for JOC 1915 is recommended for award.

The lowest responsive and responsible bidders listed in Attachment II were deemed the apparent lowest responsive and responsible bidders for the five JOCs (1915 through 1919) meeting the criteria adopted by the Board with regard to each respective JOC agreement.

To ensure the contracts are awarded to responsible contractors with a satisfactory performance history, bidders were required to report violations of the False Claims Act, their civil litigation history, and information regarding prior criminal convictions. The information reported by the lowest responsive and responsible bidders listed in Attachment II was considered before making this recommendation to award the JOCs.

DPW has evaluated and determined that the Living Wage Program (County Code, Chapter 2.201) does not apply to the recommended contracts as these contracts are for non Proposition A services.

Participation by CBE in the project is encouraged through DPW's CBE Outreach Program and by reporting the good faith efforts of bidders to utilize CBEs.

In addition, the contracts require contractors to report Small Business Enterprises/LSBE and CBE utilization for all subcontractors used.

The contractors will be in compliance with the CEO's and the Board's requirements.

A copy of the February 2018 JOC Unit Price Book and Specifications are on file in Business Relations and Contracts Division of DPW.

#### **IMPACT ON CURRENT SERVICES (OR PROJECTS)**

The use of these JOCs will expedite the completion of repair, remodeling, refurbishment, and maintenance work throughout the Department. Minor impacts may occur while repair and maintenance work is underway.
