TEMPLE CITY LIBRARY PROJECT

On October 18, 2016, the Board authorized the Los Angeles County Development Authority (LACDA) to accept a contribution of \$1,950,000 from Temple City (Temple City) and the transfer of \$1,950,000 from the Fifth Supervisorial District Extraordinary Maintenance Budget for development and construction activities associated with the Temple City Library Project (Project). In addition to this funding, Los Angeles County Library committed \$200,000 in Developer Fees funds to raise the total project budget from \$3,900,000 to \$4,100,000. The Project will expand the current 10,000 square foot Temple City Library (Library), located at 5939 Golden West Avenue, Temple City, to approximately 11,400 square feet, and with additional upgrades to maximize the use of space for expanded programming. Upgrades include a new community room, group study room, enhanced family place and children's reading areas, interior finishes, lighting, low voltage, HVAC (heating, ventilation, and air conditioning), energy saving measures, and furnishings. Exterior improvements will include upgrades to the existing parking lot. The LACDA is overseeing the development and construction of the Project.

The LACDA is now requesting the Board to approve the Project, amend the project budget, adopt the plans and specifications, and to instruct the Executive Officer of the Board to advertise the Project for bids. Following this activity, the LACDA will return to the Board to award the construction contract, and request authority to accept the Project upon construction completion.

I, THEREFORE, MOVE that the Board of Supervisors:

- 1. Find that the Project is exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines Section 15301 and Class 1 of the County's Environmental Document Reporting Procedures and Guidelines, Appendix G because the action will not have a significant effect on the environment.
- Approve an appropriation adjustment to transfer \$200,000 from the Los Angeles County Library Developer Fees Area #3 to the Project and Facility Development budget to provide additional funding to the Temple City Library's expansion Project.

Authorize the Chief Executive Officer (CEO), or her designee, to execute an amendment to the existing Funding Agreement between the County and the LACDA for the Project to increase the project budget by \$200,000, thereby increasing the County's contribution under the Funding Agreement to a total of \$2,150,000, and all related documents, for the Project.
- Authorize the LACDA to act as the agent of the County for development and construction of the Project.
- I, FURTHER MOVE, that the Board of Commissioners of the Los Angeles County

 Development Authority:
- 1. Find that the proposed Project is exempt from the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines section 15301 and Class 1 of the County's Environmental Document Reporting Procedures and Guidelines, Appendix G. Upon the Board's approval of the recommended actions, the LACDA will file a Notice of Exemption with the County Clerk in accordance with section 21152 of the California Public Resources Code.
- Authorize the LACDA to act as the agent of the County for development and construction of the Project.
