

**DEPARTMENTAL ASSIGNMENTS AND COMMISSION APPOINTMENTS MADE BY THE CHAIR OF THE BOARD**

Pursuant to Chapter VII, Section 28 of the Rules of the Board, the Chair of the Board assigns each of the Supervisors to provide oversight and support to specific County departments. The Auditor-Controller, Chief Executive Office, County Counsel, Executive Office, and the Health Agency are not assigned to specific Supervisors, as these entities report to the Board as a Committee of the Whole. In addition, as Chair of the Board, I am responsible for designating the assignments of all the sanitation districts and various commissions that require Board representation.

**I, THEREFORE MOVE**, that the Board of Supervisors make commission and sanitation district assignments as reflected on Attachment A and assign each County department to a specific Board office as reflected on Attachment B, for the purposes of enhancing communication, collaboration and accountability, understanding that departments are still required to respond to all Board offices.
