


ANALYSIS

This ordinance amends Chapter 15.64, Part 5, of Title 15 – Vehicles and Traffic – of the Los Angeles County Code, adding Sections 15.64.1340 through 15.64.1344, to establish the Sherbourne Drive Preferential Parking District.

The ordinance provides that each dwelling unit within the parking district may obtain two (2) parking permits, upon the payment of a one hundred ten dollar (\$110) fee every three (3) years. The ordinance also provides that each dwelling unit within the parking district may obtain one-day visitor parking permits without charge.

An ordinance amending Chapter 15.64, Part 5, Title 15 – Vehicles and Traffic – of the Los Angeles County Code, adding Sections 15.64.1340 through 15.64.1344, to establish the Sherbourne Drive Preferential Parking District.

The Board of Supervisors of the County of Los Angeles ordains as follows:

SECTION 1. Section 15.64.1340 is added to read as follows:

15.64.1340 Sherbourne Drive Preferential Parking District—Purpose.

The purpose of the Sherbourne Drive Preferential Parking District is to reduce noise, litter, and blockage of residential driveways, and to equitably allocate the limited parking for residents living within the boundaries of the Sherbourne Drive Preferential Parking District in the unincorporated community of Ladera Heights.

SECTION 2. Section 15.64.1341 is hereby added to read as follows:

15.64.1341 Sherbourne Drive Preferential Parking District—

Description.

The area bounded, as described below, shall be designated as the Sherbourne Drive Preferential Parking District.

South Sherbourne Drive between the north right of way line at Senford Avenue and the north right of way line at Centinela Avenue frontage road.

SECTION 3. Section 15.64.1342 is hereby added to read as follows:

15.64.1342 Sherbourne Drive Preferential Parking District—Parking

Restrictions.

Parking without a permit is prohibited within the Sherbourne Drive

Preferential Parking District as follows:

Days and hours – seven (7) days per week, twenty-four (24) hours per day, including holidays.

SECTION 4. Section 15.64.1343 is hereby added to read as follows:

15.64.1343 Sherbourne Drive Preferential Parking District—Permit

Types.

The following types of permits will be issued for the Sherbourne Drive Preferential Parking District: Each residential dwelling unit within the Sherbourne Drive Preferential Parking District may receive two (2) hanger parking permits, which are valid for a period of three (3) years and may be renewed once every three (3) years.

Each dwelling unit within the Sherbourne Drive Preferential Parking District may receive visitor permits by contacting the Ladera Sheriff Community Center. Visitor permits shall be valid for only one (1) day on the date specified on the permit.

SECTION 5. Section 15.64.1344 is hereby added to read as follows:

15.64.1344 Sherbourne Drive Preferential Parking District—Permit

Fees.

The fee for obtaining two (2) hanger parking permits, as specified in Section 15.64.1343, shall be one hundred ten dollars (\$110). The renewal fee shall also be one hundred ten dollars (\$110). There will be no charge for visitor permits.
