## SUBJECT: REPORT BACK ON FUNDING DISTRIBUTION METHODOLGY FOR CATALYTIC DEVELOPMENT FUND AND COMMUNITY BUSINESS REVITALIZATION PROGRAMS (ITEM NO. 1-D, AGENDA OF JULY 7, 2020. RELATES TO NO. 7)

On July 7, 2020, your Board authorized the Acting Executive Director of the Los Angeles County Development Authority (LACDA) to execute a Funding Agreement, or an amendment to an existing Funding Agreement, with the Los Angeles County (County) and take all actions necessary to facilitate the transfer of the \$4,600,000 (\$2,200,000 for the Catalytic Development Fund [CDF] and \$2,400,000 for the Community Business Revitalization Program [CBRP]) to implement the initiatives of the County Economic Development Trust Fund (Trust Fund), which shall be used for economic development purposes subject to the approval of the Board. This same Motion directed LACDA to incorporate the \$4,600,000 into its approved Fiscal Year (FY) 2020-21 budget, as needed. Furthermore, your Board directed the Acting Executive Director to Report back to the Board in writing in 60 days on a distribution plan for the Trust Fund CDF Programs in equal amounts to all Supervisorial Districts.

Since receiving this directive, the LACDA has consulted with the Economic Development and Affordable Housing Division of the Chief Executive Office to fulfill your Board's directive. On August 28, 2020, LACDA provided each Economic Development Deputy with the fund balances that reflects past and planned expenditures for both the CDF and CBRP programs for your respective Board Office based on your Board approved Motion. Additionally, during the September 3, 2020 meeting of the Economic Development Policy Committee (EDPC), the approval of Supplemental Budget, for LACDA was presented. The funding distribution is attached for your review.
