
Location: Unincorporated Santa Monica Mountains North Area within the Malibu Zoned District.

General Description of Proposal: A proposed update to the Santa Monica Mountains North Area Plan and Community Standards District to address community concerns, strengthen environmental resource policies, identify standards that support the region's rural and semi-rural character, and more closely align regulations with the Santa Monica Mountains Local Coastal Plan. The Board will also consider the Final Environmental Impact Report for the Plan Update pursuant to the California Environmental Quality Act.


