As of 2019, 8.8% of all workers in Los Angeles County worked in food service establishments & drinking places, employing 398,800 people. This industry employs a labor workforce that is dependent on jobs with low barriers to entry for their livelihood - with many from communities of color.

Until full indoor dining is once again permitted, the independent hospitality industry is unlikely to generate the revenue they produced before COVID-19, and it is necessary for the Board to support this industry by temporarily allowing them to add a "COVID-19 Recovery Charge" to a customer's total bill.
