**Extend the Reward Offer in the Murder of Timothy Jackson**

On Saturday, February 8, 2019, at approximately 10:30 p.m., fifty-three-year-old Timothy Jackson was shot and killed on the 3500 block of Floresta Avenue in the unincorporated area of Windsor Hills in Los Angeles County. After receiving several 9-1-1 calls reporting gunshots in the area, deputies from the Los Angeles County Marina del Rey Sheriff’s Station conducted a search of the area and found Mr. Jackson in the backyard of his residence with multiple gunshot wounds to his upper torso; he was pronounced deceased at the scene.

At the time of his murder, Mr. Jackson was employed in the real estate industry. He is survived by his daughters, Timisha Adams and Tyra Jackson, as well as his son, Timothy Jackson II. To date, investigators have limited information regarding this murder. Los Angeles County Sheriff’s Department’s Homicide Bureau detectives believe a reward would encourage witnesses in the neighborhood who may have seen the suspect(s) leave the area come forward with information that would assist investigators in solving the crime.

On April 30, 2019 the Los Angeles County Board of Supervisors (Board) approved a reward in the amount of \$10,000 in exchange for information leading to the apprehension and/or conviction of the person(s) responsible for the death of Timothy

Jackson. The Board then voted to extend this offer on July 16, 2019, January 21, 2020, and July 21, 2020. This reward is set to expire on January 18, 2021 if no action is taken. Detectives investigating the case recommend that this reward be extended to help solve the crime.

**I THEREFORE MOVE THAT THE BOARD OF SUPERVISORS:**

Extend the offer of a reward in the amount of \$10,000 in exchange for information leading to the apprehension and conviction of the person(s) responsible for the death of fifty-three-year-old Timothy Jackson, who was shot and killed on February 8, 2019 at approximately 10:30 p.m. on the 3500 block of Floresta Avenue in the unincorporated area of Windsor Hills in Los Angeles County.
