A RESOLUTION OF THE LOS ANGELES COUNTY FIFTH SUPERVISORIAL DISTRICT CONSOLIDATED OVERSIGHT BOARD APPROVING THE ADOPTION OF THE RECOGNIZED OBLIGATION PAYMENT SCHEDULE ("ROPS 21-22") FOR THE PERIOD OF JULY 1, 2021 THROUGH JUNE 30, 2022 FOR THE SUCCESSOR AGENCY TO THE COMMUNITY REDEVELOPMENT AGENCY OF THE CITY OF PALMDALE.

WHEREAS, pursuant to ABx 1 26, enacted on June 28, 2011, and as subsequently amended by AB 1484, SB 341, and SB 107 ("Dissolution Act"), the Redevelopment Agency to the City of Palmdale was dissolved as of February 1, 2012, and the City of Palmdale elected to serve as the Successor Agency to the former Redevelopment Agency to the City of Palmdale.

WHEREAS, pursuant to Health and Safety Code Section 34179 (q), commencing on and after July 1, 2018, the County of Los Angeles, where more than 40 oversight boards were created by the Dissolution Act, shall have five consolidated oversight boards each encompassing the five supervisorial districts; and

WHEREAS, the Fifth Supervisorial District Consolidated Oversight Board ("Fifth District Consolidated Oversight Board") has jurisdiction over the Successor Agency of the Former Redevelopment Agency to the City of Palmdale; and

WHEREAS, on January 12, 2021, the Successor Agency to the Community Redevelopment Agency of the City of Palmdale approved and adopted the Recognized Obligation Payment Schedule for the period of July 1, 2021 through June 30, 2022 ("ROPS 21-22"). Successor Agency to the Community Redevelopment Agency of the City of Palmdale Resolution No. SA 2021-001, approving the ROPS 21-22, is attached to this Resolution as Exhibit A; and

WHEREAS, the Fifth District Consolidated Oversight Board held a regular/special meeting on January 14, 2021; and

WHEREAS, all other legal prerequisites to the adoption of this Resolution have occurred.
