### Los Angeles County Sheriff's Department



Rosas Settlement Agreement Provision 1.4 requires the Department to publicly report to the Los Angeles County Board of Supervisors bi-annually:

- Implementation Plan
- Status of Compliance
- Training on Use of Force Policy
- Use of Force Statistics and Trends
- Department Use of Force Policy Violations
- Inmate Grievances

#### Rosas, et al. v. Sheriff Alex Villanueva



- Rosas is a federal class action lawsuit alleging a pattern of excessive use of force in the Downtown jail facilities (Men's Central Jail, Twin Towers Correctional Facility, and the Inmate Reception Center).
- ➤ The Settlement Agreement was initially approved by the Court on April 21, 2015. The Department began assessing compliance with the Settlement Agreement effective July 1, 2018, after the establishment of the revised Compliance Measures (May 2018).
- Provisions are grouped in 7 Categories:

Administrative, Use of Force, Training, Force Reporting and Force Investigations, Grievances, Restraint, and Early Warning System (104 Provisions with a total of 402 Compliance Measures).


#### Note:

As of March 17, 2020, all Standards and Training For Corrections (STC) were postponed due to the COVID-19 Pandemic; however, classes for Intensified Format Training (IFT) continued, excluding De-Escalation and Verbal Resolution (DeVRT) training. STC and DeVRT training resumed on July 1, 2020. Custody Training and Standard Bureau has implemented COVID-19 precautions for all STC and IFT classes to be in compliance with the CDC's recommendations.



#### Downtown Jail Complex Overall Use of Force Statistics






2019 Total UOF Incidents = 1334 2020 Total UOF Incidents = 958 (-28%)

#### Downtown Jail Complex Use of Force - Category 1






2019 Total Category 1 Incidents = 822 2020 Total Category 1 Incidents = 663 (-19%)


